

Rural Oregon must vote

When voting, please refer to OFB's 2016 Election Guide at oregonfb.org.

From candidates to ballot measures, this election will have a direct impact on your ability to farm or ranch. Voter turnout is crucial this November. No matter how you feel about the presidential race or other choices you have on the Nov. 8 ballot, we urge you to vote.

To determine who will best represent agriculture and rural communities in the legislature, Oregon Farm Bureau's grassroots leaders combed through the candidates to create the 2016 Election Guide, available at oregonfb.org.

"The candidates who earned OFB's endorsement will stand up for Oregon's farm and ranch families at the capitol," said OFB Director of Public Policy Jenny Dresler.

"These are people who will have an open door to Farm Bureau in policy discussions and can make a major difference for agriculture in coming legislative sessions," said Dresler.

The Oregon House is only one seat away from becoming a "super majority," which means that one party can raise taxes

Help us defeat Measure 97, the tax on gross receipts, not profits.

If passed, this would be the largest tax increase in

Oregon history.
Taxed businesses would pass along the costs to farming and ranching families, raising the price of feed, fertilizer, crop protection, fuel, electricity, transportation, equipment, and insurance. This would further burden Oregon farm-

ers and ranchers already trying to absorb the costs of increased regulations — and would put them at a competitive disadvantage in national and global markets.

From Measure 97, the tax on sales, to determining whether the legislature will be able to pass tax increases without any minority party votes, your farm or ranch has a lot at stake. PLEASE VOTE IN THIS ELECTION.

If you are mailing your ballot from inside Oregon, post it by Nov. 3. If you are delivering your ballot to a drop-off location in person, do so before 8 p.m. on Nov. 8.
