Repo attempt turns violent

An attempt to repossess a vehicle in the parking lot of Quality Suites turned into a confrontation leading a man to ram another vehicle with his.

On Monday, Jan. 16, Keizer police officers were dispatched to 5188 Wittenberg Lane N.E. where a complainant said an attempt to repossess at 2006 Mercedes-Benz erupted into a verbal confrontation.

She told the responding officer that after the verbal exchange the man got into the Mercedes and backed into her vehicle causing damage to it before taking off north on River Road North.

She followed the vehicle, but lost sight of it near the intersection of River Road and

Parkmeadow Drive North-east. She identified the owner as Adam Corey Williams.

Williams was located and arrested in Salem the following day on an unrelated matter and charges including possession of methamphetamine. He was charged with unauthorized use of a motor vehicle and failure to perform the duties of a driver when property is damaged. Williams was on the Salem Police Department's Most Wanted List.
