

* At the end of 2016 (most likely in November,) the pictures will be voted upon by readers for which photo they liked the best. The winner will receive a \$100 cash prize from the St. Johns Review.

PICTURES MUST BE:

* Sent in high resolution (200+).
* Unaltered photos are preferred but will not be turned away.
* Send pictures in a JPEG format.
* Do not send a photo more than once.
* Pictures appearing in the paper must belong to the taker of the picture, but the Review has the right to use them in current and future issues.
* Color pictures are preferred.
* Do not send more than three pic-

tures at a time.

* Pictures may be cropped (by the Review) to fit the paper’s perimeters. For photos appearing in the Masthead they need to be vertical more than horizontal. Masthead pictures are 10.25” across, and 3” to 5” tall. Pictures of the Week can be vertical or horizontal and any size.

The newspaper has the right to change or alter these rules during the year should it be needed.

Voting begins in November where all the year’s pictures will be re-shown. A winner will be announced in December.




