Cars Attacked in Many Districts of

the Bay City.

SAN FRANCISCO, May 25.-Considerable violence, but of a minor character, atthe operation of cars by the United Railroads today. Instead of be-ing confined to the district south of Markgt street, which has been the center of demonstrations against cars and dis-turbances by union sympathizers since the lines in that part of the city were opened, stoning of cars and assaults upon the strike-breaking employes were re-ported by the company to have occurred today in many other sections of the city. of the cars returning to the barns evidence of well-aimed fusillades of bricks and other missiles.


