BY THE PRESIDENT OF THE UNITED STATES OF AMERICA-A PLOCLAMA TION-Reminded by the changing seasons that it is time to pause in our daily avocations and offer thanks to Almighty God for the mercies and abundance of the year which is draw. ing to a close; the blessings of a free government continue to be vouchsafed to us, the earth has responded to the labor of the husbandman, the land has been free from pestilence, internal order is maintained and peace with other Powers has prevailed. It is fitting at stated periods to cease from our accustomed pursuits and from the turmoil of our daily lives, and unite in thankfulness for the blessings of the past and the cultivation of kindly feelings toward each other. Now, therefore, recognizing these considerations, I, U. S. Grant, President of the Unite States do reccomend to all citizens to assemble in their respective places of worship on Thursday. the 26th day of November next, and express thanks for the mercy and favor of the Almighty God, and, laying aside all political contests and all secular occupations, to observe such day as a day of thanksgiving and praise.




