CHARTER FOR EUGENE

Radical Changes Proposed For Oregon City's Municipal Government.

EUGENE, Ore., Jan. 9 -The commission recently appointed by Mayor Matlock to revise the city charter has completed its work and presented the amendments to the city council. The amedments will be voted upon by the people of the ctly at a special election some time next month

If the amendments are voted there will be some radical changes in the new charter. Principal among them will be what is known as the Des Moines plan of city government, This provides for creating five departments of government as follows: Department of public affairs, department of accounts and finance, department of public safety, department of streets and public improvement, department of parks and publis property. The may or is to be the superintendent of the department of public affairs and the council is to designate by vote a member of the council as superintendent of each of the other departments. The council is to be reduced from eight to four members, and the mayor has a vote upon all questions. The mayor and councilmen are to be placed upon a salary, whereas they are serving without pay under the old charter. The salary of the mayor is to be \$800 and the councilmen \$750 each. The new charter provides that when the city shall attain a population of 12,000 the salaries shall be increased 20 per cent, and there is to be a further increase of 20 per cent for each 5000 additional population thereafter. The office of city recorder is to be appointive instead of elective, as at

The new charter provides that at elections for a bond issue none shall vote who is not a bona fide taxpayer in the city.

The amended charter also authorizes the city to bond itself in the sum of \$75,000 for a new city hall and to issue bonds in the sum of \$75,000 for a gas plant and \$150,000 for an electric light plant.

In the clause relating to the regulation of the sale of liquor is a provision empowering the city to pass an ordinance declaring a place where liquor is kept for sale to be a com-In effect November 1, 1908,-Daily mon nuisance and providing for earch and seizure.
