### O. R. & N. PREPARING FOR PORTLAND-CHICAGO FLYER

Two new O. R. & N. dining cars were taken through the city today en route for Portland where equipment is now being assembled for the new transcontinental flyer that the Harriman system is to start running May 1. The train is to be known as the Portland-Chicago flyer and will be one of the finest passenger trains in the United States. It will be an exclusive train and will handle no local business. The time table has not yet been announced.

### EDITOR PUTNAM OF MEDFORD TRIBUNE EXONERATED

Salem, March 9.—George Putnam, the editor of the Medford Tribune was completely exonerated from conviction in criminal libel, secured against him before Circuit Court Judge Hanna, in the opinion handed down today by Superior Court Justice Beaumont. The prosecution of Putnam grew out of factional troubles over local option at Medford. Mayor Reddy was assaulted by a man with an ax, and the grand jury refused to indict his assailant. Putnam's Tribune censured the grand jury. The same grand jury indicted him for libel. Putnam was thrown into jail. At the trial, testimony which the supreme court in opinion of today says should not have been accepted was excluded.

### POLICEMAN MURDERER CAUGHT AFTER SEVEN YEARS CHASE

Chicago, March 9.—After a chase of seven years for the unknown murderer of Policeman Patrick Duffy, of the local force, the authorities today are in receipt of information that the murderer is Vincent Briscoe, who served a sentence for burglary at San Quentin, California, under the name of Frank Bennett. It is alleged that Bennett is the man who shot and killed Duffy when the latter searched a company of men on the street suspected of burglary.

### RUSSIAN DOUMA VOTES FIVE MILLIONS FOR RARMY

St. Petersburg, March 9.—After an all night session the douma today voted \$5,000,000 million dollars to be used placing the Balkan fleet in shape for action and \$20,000,000 to restore the army equipment and munitions which were depleted since the Japanese war.

### TAFT CONFERS ONLY WITH CANNON AND FRIENDS

Washington, Nov. 9.—President Taft is reported today to have invited only the supporters of Cannon to the White House tonight for the conference over the proposed changes in the rules of the house, indicating that Taft will not support the "insurgents" in their fight against Cannon.
