Agriculture, Market Access & Certification Program, Administrative Rules Chapter Sue Hooch, Coordinator (503) 986-4583 Amend: OAR 603-048-0700. SUMMARY: industrial hemp program financially (program) insolvent. Current registration fees to do not generate funds sufficient to cover the cost to pay for administration of the program. The only mechanism available for financing the program under the current statute (ORS 571.300 to 571.315, as modified Oregon Laws 2016, Chapter 71) is annual registration fees. The proposed fee change increases annual registration fees for industrial hemp as follows:

Industrial hemp grower registration increases from \$500 to \$1300; Industrial hemp handler

registration increases \$500 to \$1300; Agricultural hemp see producer registration increases from \$25 to \$120.

A delay in adopting these rules to increase fees would cause the program to go further in debt, impair the program's ability to register and regulate registrants, and ultimately seriously prejudice this new industry. It is therefore necessarv to immediately adopt temporary rules. January 31, 2017
