Daily Monutaincer. In the State of Georgia the "Industrial Bureau" have fixed the price of negro labor at \$10 per month for men, and \$8 for women, including board, and ten hours to constitute a day's work. This is much better wages

than the laboring classes of Eogland obtain. A yinm in San Francisco who had a ship and cargo ddstroyed by the Shenandoah, have forwarded a bill of \$260,000 to Washington to be filed with other claims for indemnity against England, for property destroyed by English pirates. Similar bills will be pre-sented by the owners of all the other vessels destroyed by the pirates.

THE Six New England States, with a popu-lation of 3,135,303, and a total Congressional representation of 39 members, furnished 367,946 men to the late war. Pennsylvania, with a population of 2 906 370, and a Congressional representation of only 26 furnish-ed 363,444 soldiers to the war. For each representative in Congress, New England furnished a little over 9,000 soldiers, while Pennsylvania furnished over 13,000 for each one.


