The National Park Service's traveling tent show will be arriving at the Museum at Warm Springs and holding lectures, videos, speeches April 22-25. Those two lost white guys, Lewis and Clark, were near Wappato Island area, now known as Sauvie's Island (why the name change?).

On April 3, 1806: "... an old man who appeared of some note among them and father to my guide brought forward a woman who was badly marked with the small pox, and made signs that they all died with the disorder which marked her face, and which she was very near dying with when a girl, from the age of this woman this destructive disorder I judge must have been about 28 or 30 years past, and about the time the Clatsops informed us that this disorder raged in their towns and

#### distroyed their nation."

April 6, 1806: "The party remained in camp on Sauvie Island, hunting and drying meat. They hoped to amass a sufficient quantity to last them till they reached the Nez Perces. Since the rain was almost continuous, they had to dry it over fires. Overcast skies prevented them from making celestial observations and gales lashed the river to turbulence. In the wide river below the mouth of the Willamette, they had not realized how much the spring flood was adding to the difficulty of their progress." (DeVoto's notes on Chapter XXV, From Sandy River to The Dalles of the Columbia.)

Note: All of the area below Celilo Falls was Chinookan, the Upper Chinookan known as The Dalles Wascos, Dog River Wascos and the Cascade Wascos (known in the Middle Oregon Treaty of 1855 as Ki-gal-twalals.)

The Kiksht, or Chinookan language went from below Celilo Falls to the mouth of the Columbia. It can be guessed that runners were passing the word about what these interlopers were doing, gathering food and preparing to move upstream. The mighty Wascos I am sure had the red carpet laid out for them. Louie Pitt.
