#### HARRIMAN'S PREPARATIONS.

It is evident that large railroad affairs are being adjusted in a manner to admit of relief for Central Oregon. Nothing has yet transpired having a direct bearing on our railroad prospects but the indirect indications are strong and the definite announcement any day of a railroad line for the Deschutes valley need not occasion surprise. This will be no "jerkwater" road, either, if events in the railway world are to be trusted. It will be a large transportation enterprise and it will mean the bisecting of the state, one way or the other.

Harriman recently obtained \$11. 000,000 from Senator Clark and his associates for turning over a stretch of the Oregon Short Line in Utah. The Union Pacific is just now in the act of marketing \$10,000,000 of bonds, the proceeds of which, it is announced, are to be used in providing new lines in the far West. Here Harriman will have more than \$20,000,000 in cash that is applicable to railroad construction. It is not at all likely that he would accumulate so great a sum without some definite idea of using it, for it doesn't pay to keep large amounts of money idle.

There is room to doubt that the line which will give relief to the Deschutes valley will pass north and south. As time passes, the indications become stronger and stronger that the railroad to Bend will be an east and west line and that it will give us an outlet to the Eastern market as well as to Portland. We can find no fault with And there is no reasonable that. ground for doubting that Harriman, with his treasury full of money, with the Keene suits against his Southern Pacific control withdrawn, with a freer hand in the Pacific Northwest by reason of the dissolution of the Northern Securities Company, will now look after important interests in this quarter of the world.
