It is pretty certain that the value of timber land will increase as time passes, and the man who gives an option for a year on his timber claim simply makes the othgr fellow a present of one year's increase in value, whatever that may The man who wants such an option ought to be willing to pay something for it. At the same time an option for a few months, in order to give time for getting a bunch of claims together, cruising ARKIVE them and arranging for their sale to the capitalists who cannot afford to fool with individual claims, is not unreasonable.


