WATER STUDY AIM OF BILL

MEASURE INTRODUCED BY REPRESENTATIVE H. J. OVERTURE PROVIDES FOR APPOINTMENT OF COMMISSION.

The last bill to be introduced by Representative H. J. Overture, of Bend, previous to his leaving Salem for a week-end visit at his home in this city, was a measure providing for the appointment of a commission to study the most efficient use to which the waters of the Deschutes may be put. The movement for the appointment of the commission proposed in the bill was started by the Bend Commercial club.

Mr. Overture arrived in Bend Saturday morning, spent the day looking after personal business, leaving Saturday night to resume his work in the legislature. He stated that he expected a report on the Deschutes county delegation's bill providing an appropriation of \$2000 annually for the Deschutes county fair, early in the week. The bill makes no mention of the location of the fair, this having been taken care of through the appointment of a fair board by the county court.
