

GERMANY MAKING TROUBLE Wants the Panama Canal Herself Disregards the Monroe Doctrine

Washington, Jan. 15.—Although the German government formally denies seeking to acquire Colombia's interest in the Panama canal, there is no denial of the fact that a syndicate, largely made up of German capitalists has been formed for the purpose of purchasing the property March 5th, as soon as the option of the United States expires.

Minister Hart has reported to the State department that the influence of European representatives, including those of Germany has been exerted to prevent Colombia from signing the canal treaty, and this is the chief cause for Colombia's insistence upon the annual rental being \$100,000.

Colombia expects to either bring the United States to terms, or make a better bargain with European capitalists. This was admitted by Minister Herron who also confirms the report that Germany has been negotiating with Colombia for a coal station, despite the knowledge that such action would be in violation and defiance of the Monroe doctrine.

The president is said to be considering the advisability of calling a conference of leading senators and representatives to decide upon a course of action.

On the Defensive Before Commission
Grand Jury Indicting Them.

House Committee Taking a Hand

Philadelphia, Jan 15.—When the Anthracite commission opened this morning, Attorney Burr presented the Hill Coal & Iron Co's and Scranton Co's evidence along the same general lines covered by the operators heretofore.

A special grand jury began the hearing of final witnesses in the coal conspiracy cases this morning. It is believed that true bills will be issued against at least ten big operators before the day is over.

Washington, Jan 15.—The House committee on Merchant Marine, which has been authorized to investigate the coal transportation, today decided to send a sub committee of five to Boston and begin taking testimony. Others of the committee will remain here, and probably will summon operators and coal presidents to give testimony.
