RESUMED WORK.

Reduction Plant Next Year at Crown Point.

Work was resumde at the Crown Point, in the Cable Cove district, this week. A contract was let for driving the lower tunnel 200 feet, which, according to survey, will reach the main vein of the property at a depth of 650 feet. L' F. Balbee, one of the owners of the Crown Point, states that work is to be prosecuted continuously during the fall and winter months and that it is the present plan to install a reduction plant early next season.

The Crown Point is one of the old Cable Cove properties on which a great deal of development work has been done, and from which some ore was shipped during its previous operation, but owing to high transportation charges, and legal en-tanglements, nothing has been done for several years. The workings represent a distance of over 1,200 feet. There are five tunnels in which there is a good grade of milling ore.
