June Mouser.

and sisters, but she has grandchildren, great-
grandchildren, and two great-great-grandchil-
dren. She loved them all equally. Her daugh-
ter-in-law Carol Mouser lives in Redmond.

Charlotte was preceded in death by her
husband Ray, daughter Delores, son Don, and
two grandsons.

When her son passed away, Charlotte
asked me to help her with her finances and
legal things. I spent many hours with her and
she was a treasure to me. We shared many life
stories, had good laughs, good food, and she
was there for me when I lost my husband. I
miss Charlotte very much, but she always
told me not to grieve for her when she passed,
just smile and always help people, even if I
didn't know them. I'm going to try to keep
that promise.
