

# Girls tennis starts week with win

The Lady Outlaws won all their matches against Corbett at home on Tuesday, April 12, and then played a friendly match with Henley at home on Friday, in preparation for the Madras Invitational on Saturday.

In Tuesday's match against Corbett, Lacey Gilmore (No. 1 singles) matched up against Carli Berghoff, Corbett's biggest threat. Gilmore defeated Berghoff 7-6 (7-5), 6-4. Gilmore struggled a bit in the first set, but came back strong in the second with a 5-1 lead. Berghoff wouldn't quit, and brought the score to 5-4 before Lacey sealed the deal at 6-4.

"This was a great win for Lacey," said Coach Susan Fullhart. "After taking a 2-0 lead in the first set, she started to struggle. She was missing shots she wouldn't normally miss, and just wasn't feeling it. She dug deep and just willed herself to make balls, and consequently took the first set in a tight tie-breaker."

In every other match, the Outlaws dominated. Hawley Harrer (No. 2 singles) defeated Frewoni Berhane 6-0, 6-1, and Mykaila Hartman defeated Sara Gradwohl 6-0, 6-1. In the No. 4 spot, Mary Florian beat Anna Bidonda 6-1, 6-1.

The doubles teams also tallied a sweep. Alana Lukens and Anni Stadel (No. 1 doubles) defeated Clare Dearixon and Camille Wilcox 6-1, 6-0, and Engracia Diez and Emily Skalda (No. 2 doubles) beat Anna Bidondo and Emmy Bunnell 6-1, 6-1. At No. 3 doubles, Hogan Hernandez and Taylor Eagan defeated Amanda Hendricks and Leila Gorman 6-1, 6-0. Devry Grace and Trinity Diaz (No. 4 doubles) wrapped it up with a 6-2, 6-2 victory over Jane Hawley and Natalie Arneson.

In the friendly match-up with Henley on Friday, teams didn't even exchange rosters. The Lady Hornets No. 1 doubles team won state last year, but those two players split up and played singles on

Friday. Lacey Gilmore lost 6-0, 6-0, to their best player. Hawley Harrer beat the other half of that state champion duo team 7-5. They only played one set because both players were dealing with some injury issues.

Anni Stadel and Alana Lukens lost at No. 1 doubles 6-3, 6-1, and Engracia Diez and Mykaila Hartman played great at No. 1 doubles and won the match 7-6, (7-3), 6-4.

# Phone scam still active in Central Oregon

Deschutes County Sheriff's deputies have received information that someone has either started or re-started a telephone scam within Central Oregon.

A caller will identify themselves as being from the Deschutes County Sheriff's Office by name and/or rank and name. They will say that you have missed a court date or should have gotten a subpoena to appear and failed to appear. This person will say that there is a warrant or some kind of fine related to the missed court date.

The caller will then ask that you meet them to make the payment or may want you to take care of the fine asking for a debit or credit card number. They may ask you to go to a Western Union or

similar financial wire service to satisfy a fine. They may also tell you that if you don't take care of this fine or warrant that a deputy will be sent to your home.

Updated Information: In this most recent incident, the caller told the victim they had been summoned or subpoenaed as a character or material witness for the state and they had failed to appear as required by law. The caller then instructed the victim purchase and use a "Fred Meyer Recharge Card" to complete the transaction and avoid being arrested. This was all done via telephone.

No law enforcement agency will call any citizen and ask for any credit card, debit card, or checking account information.
