DELINQUENT TAX LIST

Greeting: In the name of the State of Oregon, you are hereby commanded to collect the taxes by seizure and sale of the goods and chattels of such delinquent tax-payers whose names appear on the foregoing list, and if none be found, then upon the real property as set forth in the foregoing delinquent tax list, or so much thereof as may be necessary to satisfy the amount of taxes so charged, together with the costs and expenses of collecting, and that you pay over all moneys so collected to the treasurer of said county, as by law you are directed, and return this warrant together with the aforesaid tax list with entries thereon of all payments made to you, to the County Court of said county, within sixty days from the date hereof.
