DELINQUENT TAX LIST

FOR 1894.

STATE OF OREGON, ss. County of Wasco.

By virtue of a warrant issued out of the County Court of the state of Oregon for the county of Wasco and to me directed bearing date October 5, 1895, commanding me to seize and sell all the goods and chattels of such delinquent taxpayers whose names appear on the foregoing (following) list, or so much thereof as may be necessary to satisfy the amount of taxes so charged, together with the cost and expenses of collecting.

Now therefore, I, T. J. Driver, Sheriff and Ex-Officio Tax Collector, in and for Wasco County, State of Oregon, in obedience to said warrant, will, on Monday being the 4th day of November, 1895, at the hour of 10 o'clock in the forenoon of said day, at the front door of the Court House in said County and State, offer for sale the following described lands as set forth in said tax list, being and lying in said Wasco County Oregon.

To T. J. Driver, Sheriff and Ex-Officio Tax Collector, in and for Wasco County, State of Oregon: Greeting: In the name of the State of Oregon, you are hereby commanded to collect the taxes by seizure and sale of the goods and chattels of such delinquent tax-payers whose names appear on the foregoing list, and if none be found, then upon the real property as set forth in the foregoing delinquent tax list, or so much thereof as may be necessary to satisfy the amount of taxes so charged, together with the costs and expenses of collecting, and that you pay over all moneys so collected to the treasurer of said county, as by law you are directed, and return this warrant together with the aforesaid tax list with entries thereon of all payments made to you, to the County Court of said county, within sixty days from the date hereof.
