Durrant said at the time of Graham's visit he did not know whether he had the notes or not, although he afterward admitted that on April 10 he asked a student named Glazier to read his notes to him. Durrant said his notes of the lecture were meager, and as Glazier read his notes he expaneled hisown.

The weak part of Durrant's testimony was his statement that when he was arrested on April 12 he did not know whether he had notes of Dr. Cheney's lecture or not, although he had compared his notes with Student Glazier's four days before and knew that he was suspected of killing the girl who had dis-

GILBERT GIVES THE DECISION

The Government Expected no Personal Liability From the Stockholders--Other News.

SAN FRANCISCO, Oct. 12 .- Mrs Leland Stanford has won another victory from the United States government, this time in the court of appeals. The decision handed down today was signed by United States Circuit Judge Gilbert and by United States District Judges Morrow and Hawley. It is given on the appeal taken from the previous order of Judge Ross, sustaining the demurrer of Mrs. Staniord to the suit brought against her to recover \$15,337,000, alleged to be due the government from her husband's estate on account of Central Pacific bonds. As the decision is an affirmation of the correctness of the position already taken by Judge Ross, there is no relief to be obtained in the premises through a suit
