

The coroner's jury in the case of John Swenson, whose dead body was found near the door of his residence at Clifton a few days ago, yesterday returned a verdict of "accidental death." The verdict is considered a singular one, inasmuch as all the circumstances seemed to indicate that Swenson had been murdered. The facts that the gun with which the killing was done was found several feet away from where the body lay; the forcing open of the door of Swenson's house, and the testimony of Dr. Fulton that the dead man's coat could not have been powder burned to such an extent unless the weapon, when discharged, was at least two feet distant, are, in the opinion of many Astorians difficult to reconcile with the idea of 'accidental death."
