



WOMEN IN GERMANY.

Recent Laws Tend Towards the Curtailment of Her Privileges.

Germany is the only country in the world which is taking backward steps in regard to the rights and privileges of women. learned of this law to their sorrow. The empress takes no apparent interest in the movement for the advancement of women. She leaves that for her mother-in-law, the ex-Empress Frederick, probably because her imperial husband is so positive in his views upon such questions. The emperor adheres to the Japanese notion, that women should obey their fathers, husbands and sons in all things, and confine themselves to domestic affairs. Only a few months ago the leaders of a branch of the women's suffrage movement in Berlin were arrested, tried before a magistrate and punished with heavy fines for maintaining an unlawful association and holding political meetings without the permission of the police. There is a law prohibiting women and minors from belonging to political associations, which places the most venerable and intellectual women in Germany upon an equality with chil-


