John Irvine, a Pioneer of '32 Dies at His Home in This City. Yet another pioneer has made the last long journey, compared with which all others are nothing.

Coming from Indiana to Oregon in '32, his first home was what is now known as the Snipes ranch at Rowena, eight miles below this city.

In '54, when the massacre occurred on the Snake river, Mr. Irvine enlisted as a volunteer, but outside of this his life has been comparatively uneventful, for while he watched The Dalles grow from a place which contained only about three families.

His life contained much of sorrow and perplexities, but he was ever good natured and pleasant to those about him, while he was honest in the strictest sense of the terms.

Word was sent to his son, Frank at Antelope, who arrived this afternoon. The funeral will occur at 11 o'clock tomorrow from the Christian church.
