GRADUATING CLASS.

Ten Young Ladies Listen To Baccalaureate Sermon Yesterday.

For the first time in its history the Roseburg high school will this year graduate a class composed wholly of girls. Among their number are Misses Anna Ferguson, Klatha Conn, Lola Williams, Rhoda Watson, Grace Clayton, Beate Bond, Miriam Caro, Mabel Clements, Nina Voorhies and Anna Allen.

Commencement week formally opened yesterday, when Rev. J. N. McConnell, pastor of the Roseburg Christian church, delivered the baccalaureate sermon, at the Presbyterian church. The interior of the edifice was beautifully decorated for the occasion, roses and spring flowers being used in profusion.

Rev. McConnell chose as his subject, "It might have been." The reverend gentleman said that such an expression was generally used when failures resulted along any line. "There comes a period of ripeness in every life," said the pastor, "which, when made use of will bring success—but neglected, failure will come and then we hear these words, 'It might have been.'"

Columbus, George Washington and other great people have done their work nobly but there remains many things to be discovered and many good causes to be championed. No one starts out deliberately to make a failure, but by neglect to follow the Divine plan, many find in the end that their lives have been useless."

The speaker took a general text from Psalms 37-37: "Mark the perfect man, and behold the upright, for the end of that man is peace. God expects us to strive for perfection. Three other texts were quoted and enlarged upon by the pastor. The discussion clearly showed that God intends for man to be diligent in business, to improve his mind and save his soul, and no person who will do, will ever have to say, 'It might have been.'"

Special music enlivened the occasion and incited an inspiration which will ever be remembered by the members of the class and the crowd that taxed the capacity of the spacious edifice.

Orations by the graduating class will follow at the high school auditorium this evening, while on tomorrow evening the class play, "Moss Fearless & Company" will be presented at the Palace theatre. Large Audience Marked Closing Services Last Night.

Owing to the beautiful weather the large attendance and excellent spirit prevailing the closing days of the campmeeting were the best of the entire session.
