# GRIDER IS HELD

## To Appear Before Grand Jury in November.

### BOND IS FIXED AT \$1,000

#### Woman Admits That She Is Not Grider's Wife—State Says Illegitimate Child Is Grider's.

Following a preliminary hearing in the justice court this afternoon, Justice of the Peace Marsters held Charles Grider, accused of the crime of non-support preferred by his wife, to appear before the grand jury at the next regular session of that body in November. Bonds were fixed in the sum of \$1,000. Unable to furnish the same Grider was remanded to the county jail pending the November term of court.

The state introduced three witnesses, the woman responsible for filing the complaint, Mrs. Charles White, of Myrtle Creek, and Mrs. Gilkey, of Roseburg. Mrs. White and Mrs. Gilkey both testified that Grider and his supposed wife had stayed at their homes and that Grider had introduced the woman as his wife. They also admitted that the child carried on the arm of the woman was represented by Grider as his offspring. The woman, responsible for Grider's arrest, admitted on the witness stand that she was not the latter's wife, but nevertheless contended that Grider was the parent of the child.

Unable to substantiate a charge of non-support in the case of the woman, the district attorney quoted the late Oregon statutes, in which it is held that a father must support his child, be it legitimate or illegitimate. Upon this part of the code the district attorney dealt at some length. The woman testified that she and Grider lived together, and passed as man and wife. She claimed that he failed to support either her or her child, and that she was left here to be taken care of by charity.

The district attorney spoke eloquently in his argument, and impressed his listeners. Judge Fullerton, who represented Grider, contended that the statute under which the charge was brought referred only to persons who were lawfully married, and not to illegitimate children. As a result he contended the state had failed to make out its case.

Grider refused to take the witness stand. Judge Fullerton remarked just prior to closing his case that there wasn't a jury in the world that would convict Grider after they had heard the evidence and the law as given by the court.

## Impeached Governor Nominated For Assemblyman.

### MAKE IT WARM FOR ENEMIES

#### Ex-Governor's Friends Hope to Get Him Back in Executive Chair via Assembly Route.

NEW YORK, Oct. 20.—William Sulzer, impeached as governor of the state, was nominated for the assembly tonight by the progressives of the sixth assembly district. Mr. Sulzer in 1889 began his public career as a member of this branch of the legislature.

Mr. Sulzer has agreed to accept the nomination. Max Steindler, progressive leader in the sixth assembly district, who placed the ex-governor's name in nomination, said Mr. Sulzer reached him by telephone from Albany, inquiring if he had been designated. Mr. Steindler replied in the affirmative. He said he asked Mr. Sulzer if he would accept and Mr. Sulzer replied he would gladly do so.

#### Sulzer Issues Statement.

"And I will make it warm for my enemies in the assembly," he said, "and I'll make them take notice in other places, too."

His statement follows in part: "In view of the urgent pleadings from lifelong friends and the request in writing from more than half of the registered voters of the sixth assembly district, regardless of party affiliation, begging me to accept the nomination for member of assembly to further the cause of honest government, I have consented to come back to Albany as a member of the assembly for the good that I can do. I shall be a non-partisan candidate, having no axe to grind and no motive or purpose other than to do what I can for the cause of good government—the struggle for which brought about my removal from the governorship by an arrogant boss whose dictates to do wrong I defied."

# HAIR TURNS WHITE.

## Blake-McFall Salesman Has Terrifying Experience.

PORTLAND, Oct. 20.—As a result of the accident that happened to him near Brownsville last Wednesday William E. Greene, a salesman for the Blake-McFall Company, today has white hair. He was thrown from his buggy driving out of Brownsville, and for two days wandered aimlessly and was discovered by a friend in Grants Pass Friday. Greene is confined to bed with concussion of the brain. He has several bruises on his shoulders and legs.

# WHITE SLAVER GETS TEN YEAR SENTENCE.

## Federal Judge Names Maximum Period—Aggravated Case of Depravity.

Following a stinging denunciation of the crime and the criminal by Federal Judge Bean, John Aloga, Spanish white-slaver, was this morning given a sentence of 10 years at the government prison on McNeill's Island.

Aloga was convicted last week of violation of the immigration statutes in bringing Rosa Pustea, 18 years old, from Spain to this country for immoral purposes. "The 10 year sentence is the maximum for the offense. Only one other white slaver in the Portland federal court has ever received so heavy a sentence. That was I. Panasadi, an Italian, who was convicted of taking a girl from Portland to Sacramento for immoral purposes two years ago.

As during the trial last week, Aloga was extremely nervous, and twice during today's proceedings cried out something at Judge Bean in Spanish. Antagonizing trouble, John Montag, United States marshal, and two of his deputies were on hand to restrain the infuriated Spaniard.

#### Case Is Most Aggravated.

"In all my experience with these cases," declared Judge Bean in sentencing, "I have never heard a more aggravated case for this offense. He has followed the trade of the underworld all his life.

"His offense consisted of marrying an 18-year-old girl, innocent, modest, retiring, his niece, who had been a pure girl until that time.

"When they came to this country he needed money, but he was too good to go to work himself. He impudently tried to go out on the street, but she resisted. At last he succeeded in forcing her out to solicit the patronage that she could.

"He brought the girl with the evident design of prostitution. "There is not one extenuating circumstance in this case," thoroughly concluded Judge Bean. "This man had considerable property and he was a white man. It was not necessary for him to put this little innocent girl out in the way that he did."

#### Aloga Is Sentenced.

Aloga was then given the sentence, and Judge Bean declared that he suspected the immigration authorities

would keep their eyes on him and deport him as soon as he gets out. Assistant United States Attorney Johnson asked Judge Bean to confer the maximum sentence. It was the first time he had ever asked that for any prisoner, he said. Johnson explained to the court an abundance of other implicating testimony that would have been introduced had Aloga not pleaded guilty at the stage of the trial that he did.

Attorney Matthews asked that Aloga be deported immediately instead of sent to the penitentiary. He said that Aloga had pleaded guilty in order to shield his wife from a vigorous examination by himself.
