REQUIREMENTS RAISED.

New Ruling Regarding Entrance to Normal Schools.

SALEM, Or., June 24.—That the entrance requirements of all the normal schools of the state be raised so that students must have an education equal to the ninth grade in high schools before entering a normal, is one of the most important recommendations of the Board of Normal School Visitors has just made to the governor. The adoption of this recommendation would be equal to advancing the standard of the normals by one year.

Another important recommendation made by the board is that graduates of high schools be admitted to advanced standing in normals proportionate with the work they have done in the secondary school subjects. This would give high school students credit for all their high school work and leave them, chiefly, the professional studies and training department work to do in the normal.

Perhaps more important than the recommendations made by the board is a report as to the efficiency of the instructors. In this respect this board has done what has probably never been done before in Oregon—has made a personal, fearless and apparently impartial report as to each teacher. This report will enable the board of regents to weed out the instructors who are not doing good work and to re-elect those who are.

HUNTER MURDERS COMPANION

BAKER CITY, Or., June 24.—Jas. Elliott, who was shot yesterday by J. W. Williams at Richland, died last evening. They started on a hunt and quarreled over shooting at a mark. Elliott, who was the aggressor, told Williams he would shoot his eye out. He drew his gun and Williams shot him. He gave himself up on the way to Baker. Both had been drinking.

TO STRENGTHEN SOCIAL BOND.

Magnificent Estate Where North and South May Meet.

CHATTANOOGA, Tenn., June 25.—To provide a place where the leading men of the North and the South may meet on common ground and to establish a greater degree of social solidarity between the once warring sections of the union is the object of the promoters of the Interstate Club, which meets here today. Chattanooga, "home-coming" festival, which has attracted hundreds of visitors and former residents of the city.

President Roosevelt, ex-President Cleveland, William J. Bryan and Vice-President Fairbanks are among the honorary members of the club, and the officers include, as vice-presidents, Secretary Root, Speaker Cannon, Secretary Taft, Leslie M. Shaw, Senator Aldrich, Melville E. Stone, Senator "Bob" Taylor and Governor Blackburn of Tennessee. Senator Blackburn is president.

The club has acquired a tract of 21,000 acres on the highland surrounding Signal Point, directly across the Tennessee river from Lookout Mountain. Steps will be taken at this meeting to erect a magnificent club house on this tract, with a lofty dome from which nine states will be visible. At this club house the leaders of the nation will meet to fish and hunt and indulge in social recreations.

FUNERAL FRIDAY

Cleveland Will be Buried With Simple Ceremonies

BODY NOT TO LIE IN STATE

Sherman Still Improving, but Cannot Leave Hospital for a Week—Operation Later

Special to the Evening Review. PRINCETON, N. J., June 25.—Funeral services over the late ex-president Cleveland will be held at the family home in this city tomorrow afternoon at 5 o'clock. The arrangements for the funeral will be of the simplest kind. The name and date of birth will be the only inscription on the casket plate. Pursuant to the widow's request, the body will not lie in state.

Roosevelt Shows Respect. NEW LONDON, Conn., June 25.—President Roosevelt will not attend today's races between the Yale and Harvard crews on account of the death of ex-President Cleveland. The Harvard collegians are greatly disappointed at the president's decision.

Sherman Improving. CLEVELAND, Ohio, June 25.—Representative John S. Sherman continues to improve, but it will be fully a week before he is able to leave the hospital. Although an operation is not imperative at the present time, Sherman will have to submit to the knife later on when he regains his full strength.

Meadows Murder Case.

OKLAHOMA CITY, Okla., June 25.—Charged with the murder of her husband, because of her alleged infatuation for another man, Mrs. Lila Meadows will be placed on trial tomorrow.

The body of J. R. Meadows, a telephone lineman, was found in a grave near Capitol Hill about a year ago. Mrs. Meadows and her alleged paramour, Rudolph Tegeler, were arrested. The latter has been tried and convicted and sentenced to prison for life.

The prosecution will attempt to show that Tegeler and Mrs. Meadows were unduly intimate and that they were seen together on the night that Meadows was supposed to have been murdered. Evidence of a startling nature is anticipated.

Populist Convention.

JACKSON, Miss., June 25.—An attempt to revive the Populist party in Mississippi which has been quietly lumbering for six years will be made today by the handful of Watson followers gathered here today for a state convention. A Watson and Williams' electoral ticket will be nominated. Hearst's Independence Party has also announced that an electoral ticket will be put in the field in Mississippi. Neither party is taken seriously by the voters at large and it is unlikely that either will poll as large a vote as the Socialists.

MILITIAMEN ONLY 10 DAYS.

But Regulars Will Camp Longer at American Lake.

OLYMPIA, Wash., June 25.—Seven thousand regular and national guardsmen, consisting of troops from the Department of the Columbia and the national guards of Washington and Oregon, will go into camp at American lake, near Tacoma, for 10 days, beginning August 2. The guardsmen with number about 2500. Washington's present strength is 800 and Oregon's 1436, but recruiting for the campment will continue until July 15 and it is expected the strength will be increased 25 per cent.

The Washington and Oregon national guards will leave the encampment August 12, but the federal troops will remain and the national guards of Idaho, Montana and North Dakota will go into camp with them a few days later. The national guard strength of these three states at the present time is about 1500 but this also will be increased about 25 per cent before the date of the encampment.

ARTICLES ON FORESTRY.

What Hunters Save—Species of Land Piracy—Costly Fires.

An important feature of the work of the Forestry Bureau is the killing of wild animals that destroy stock. Will C. Barnes, in an article in the July McClure's says:

"In the year 1907, according to records kept of all predatory animals killed upon the various national forests, or on lands adjoining them, no fewer than 1600 wolves, 19,469 coyotes, 265 mountain lions, 368 bears and 2285 wild cats and lynxes were killed by the various hunters and settlers. Of these, it is probably fair to credit the rangers and the hunters employed by the Forest service with at least one-fourth.

"Now, any well posted stockman will tell you that, on an average, a full-grown wolf will destroy one thousand dollars' worth of stock every year of its life. Mountain lions prefer horses to any other food, but still they will put up with calves and sheep. They, too, are easily chargeable with a thousand dollars' worth of damage each year. The coyotes, bobcats, and lynxes do less harm, and that mostly to sheep. Yet I think it is a very conservative estimate to say that each coyote or lynx annually destroys stock to the value of fully one hundred dollars.

"Taking these figures as a basis for comparison, it is very easily seen that the value of the animals killed by the Forest Service men, is more than \$1,000,000. Hence, so far as return for their \$336,920 in grazing fees is concerned, the stockmen get it back in full and with some to spare."

Mr. Barnes also contributes a chapter on placer mining under the caption of

Land Conspiracy Checked.

"Of course, where mining companies, organized solely to obtain vast areas of timber land, under cover of the mining laws, especially the Timber and Stone Act, and the Placer Mining laws, found their work exposed by the activity and watchfulness raised a cry against the Service that awoke the echoes.

"The Placer laws allow a company to obtain title to twenty acres of land simply by showing five hundred dollars' worth of mining work done upon it. No signs of mineral need be shown, no further attempt to develop it is required. Prove that five hundred dollars' worth of work has been done, and the grant is issued. The takers are not limited to a single tract, but can have just as many tracts as they have sums of five hundred dollars to invest. Under this Placer law, whole townships, covered with the finest timber on the Pacific coast, were taken up solely to obtain title to the land for the timber upon it.

COSTLY FOREST FIRES.

"If the Forest Service had done no more than keep down the fire losses, their work would not have been in vain. In 1901 the total area burned over in the government forests equalled 2 3/4 acres in every thousand, while in 1907 the burned area was only 9-19 of an acre in every thousand. No record of the money value of the earlier fire losses was kept, but that the loss ran into the millions to one who has seen the miles of burned over tracts can doubt.

The following table shows the fire losses in the national forests for the past three years:

Year	Area of burned timber	Acres	Val. of timber lost
1905	627,000	279,592	\$101,282
1906	106,999	115,416	76,183
1907	164,154	212,850	31,549

That is, in 1905 the loss from fire was more than three times as great as in the 1907, with an area of forests 60 per cent greater.

ANNIVERSARY OF TRAGEDY.

Harry Thaw Killed Stanford White Two Years Ago Today.

NEW YORK, June 25.—Harry Kendall Thaw, millionaire madman, will today begin the third year of his confinement behind prison bars. It was just two years ago tonight that the Pittsburgh fired the shot which "echoed round the world," sent Stanford White's soul into eternity and started New York as it had seldom been startled before. From that night, when Thaw was led from a scene of revelry, suddenly transformed into bloody tragedy, to the West Thirtieth street police station, and later to Tombs prison, he has not known a moment of liberty. The millions of his family and friends, poured out like water in his behalf, have not served to save him. Surrounded by gibbering, muttering lunatics, by men whose darkened minds are filled with insane fancies, wildest fears and memories of bloody crimes, he is apparently destined to live out his life.

A big, indifferent first-night audience jammed the roof of Madison Square Garden on the evening of June 25, 1906. It was the first performance of a musical hodge-podge, "Mamzelle Champagne." More than a New Yorker conveying a country relative explained that the great building with its tall, Diana-crowned ampitheatre towering above the roof was of Stanford White's design, and that the famous architect had his studio in the tower itself.

A few of the more knowing whistlers of rumored orgies in that same studio, where Diana, and not Venus, was the presiding deity.

The performance droned along. People who were not especially interested in it noticed Harry Thaw and his wife at one of the tables. They had been dining at a restaurant, and later reports stated that Evelyn had shown annoyance at seeing Stanford White dining there also.

After a time Thaw left his wife and began to pace aimlessly about the roof. He seemed to be looking for some one. His tall figure in its long, gray raincoat attracted attention, as he passed the outer fringe of the audience. At last he took up a position behind a bank of palms at the southern end of the auditorium.

The center of the roof was occupied by rows of theater chairs facing the stage. On either side of this square of seats were tables. At the southern end was a cleared space. At the southeastern corner was a rather narrow exit leading to the elevator.

Through this passage at about 9:30 came a large, florid, middle-aged man, accompanied by some friends. He was Stanford White. He had dined with his son and had been going to his club. Now he was dropping in to see the final act of the new summer show. He sat down at one of the central tables on the southern side of the roof, chatting with one or two people who recognized and stopped to speak to him, and at last was left alone at the table, where he idly watched the performance drawing to a close.

The tall man in the gray raincoat left his retreat among the palms and walked quickly to where White sat. The architect looked up and met Thaw's glare. But he did not rise to make the slightest effort at self-defense.

White whipped out a revolver and probably before the architect could guess his intent—certainly before he could avert it—the young man fired.

Three times he shot, slowly, deliberately, regularly.

Every shot took effect.

White tumbled heavily from his chair to the floor—dead.

Kribs is Roasted.

PORTLAND, Or., June 25.—Attorney Dan J. Malarkey made the opening address for the defense in the Kribs trial today, roasting F. A. Kribs, the principal witness for the prosecution. Malarkey said that the \$800 paid by Kribs to Booth was not for advance information on timber lands, as alleged by the indictment, but to cover an option in a certain land deal.

Honey and Burns Summoned.

The Portland Telegram of June 24, says:

Francis J. Honey and W. J. Burns, formerly of the secret service, have been asked to come to Portland to testify in the case of James Henry Booth, now being tried on a charge of accepting a bribe while receiver of the Roseburg land office, for giving Frederick Kribs advance information. Without Honey and Burns, Tracy C. Becker, special assistant to the attorney-general feels that his case is not so strong as he would like, and in order to convict Booth, Becker has telegraphed Honey and Burns, urging his attendance. Burns and Honey are still in San Francisco connected with the graft case. Burns should be now on his way to Portland, but is not, and Honey is expected to arrive and give his testimony Saturday.

As soon as Booth has given his testimony, Honey will be wired to come for rebuttal. The Booth indictment was the last one brought by Honey and it based on information given by Frederick Kribs. The indictment was brought in April, 1905, and not until Monday, more than three years after the indictment was secured by Honey was Booth brought to trial. The prosecution is that Booth made statements to Honey and Burns which he will not deny. If these men are brought to the witness stand from "Albion," it is supposed that Honey will arrive in Portland next Saturday morning, give his testimony and return south on the night train.

LAUNCH IS EMPTY

Fishing Party of 12 Believed Killed By Explosion

FATAL PANIC IN CHICAGO

Persian Rebels to Give Battle to Shah's Troops—Slaughter of Prisoners Going On

LOUIS, Mo., June 25.—Twelve men are believed to have been killed by the explosion of an engine on a gasoline launch, which was found on the beach of a lake today, demolished. The launch was the property of John Krause, who took a party of 11 men fishing. Not one of the party has been found.

Chemical Works Blown Up.

CHICAGO, June 25.—An explosion in a chemical works here today precipitated a panic among tenants overlooking, and in the rush for windows a woman and her four children and an unknown man, were trampled to death. Scores of other persons were hurt, and some of these will die.

Teheran Still in Uproar.

ST. PETERSBURG, June 25.—A dispatch from Teheran says that a large body of well armed rebels are marching on that city and that a bloody battle will result. Prisoners taken by troops yesterday are being executed by order of the Shah, while wholesale arrests continue. Many prisoners are being shot without trial.
