GOES DRY TOMORROW NIGHT.

At 12 o'clock Tuesday night, June 30, 1908, Douglas county, along with several others, enters the list of "dry" counties in this state. Every saloon for the sale or use of intoxicating liquors will pass out of legal existence in this county. That date will thus mark the opening of a new epoch in the county's history. The legal prohibition of the liquor traffic has never yet been tried here. What will be the results in a business way have been viewed with strong misgivings by many citizens who apprehend a possible depression of commercial activity as well as the certain wiping out of a large source of city revenues. What will really occur can only be judged by the experience of other counties. To the north of us, Lane, Linn, Benton and Yamhill counties entered the "dry" class two years ago, and at the recent election on June 1st, each of these counties voted to continue in the "dry" column by heavily increased majorities. Their principal towns—Eugene, Albany, Corvallis and Medford—are also enjoying at the present time the largest and most substantial growth in their history. By the "dry" element these are pointed out as unmistakable evidences of the success of the new regime, while the "wets" maintain that this advancement is being made "in spite of" the "drawbacks" occasioned by prohibition. From these experiences the conclusion we reach is that Roseburg and Douglas county are bound to grow and prosper under the new conditions as have our neighbors to the north.

For a time at least our city tax levy will doubtless have to be increased somewhat to cover the loss of the \$6000 heretofore annually received from saloon licenses. Upon our city's assessed valuation of something over \$1,600,000, an additional levy of five mills will fully cover the shortage, and that small amount is not likely to prove very burdensome to the property owners. Almost immediately nearly every one of the buildings now occupied by saloons will be used for other purposes. In fact most of them are already used for various other lines of business. This shows there will be no business depression here and that the property owners will receive their regular rentals as usual.

Along with other communities under prohibition laws, we shall doubtless have a more or less varied experience with operators of "blind pigs," "boot leggers," etc., for a while. There are always individuals who will not profit by the experience of others but think they are "smooth" enough to dispense the forbidden "booze" without being caught. This may be done for a little while, but the final result is inevitable. Of course, they may argue a fine now and then would not be an expensive form of license. But such are likely to confront an altogether different condition before long. In all probability a "blind pigger" will not be arrested until several well defined cases or separate charges against him are secured. Upon the first trial he will likely be dismissed with a fine, only to be immediately re-arrested and sent to jail for a good long period to "think it over." There is no apparent intention or probability of any "persuasion" along this line, but on the other hand there is a very general and positive sentiment in favor of law enforcement—and this is just as true among a large proportion of the "wet" element as it is among the "drys." That the new law will be enforced to beyond question, and transgressors may as well understand that they will sooner or later be apprehended and punished. It will be a duty of every law-abiding citizen to aid in seeing that the law is observed, whether a believer in the new regime or not.

Another conclusion should also become settled in the minds of our citizens at once—that is, that the action bringing about prohibition has already been settled and cannot be changed for at least two years and any discussion of it, either pro or con, is useless. The matter is decided and all enemies aroused over its discussion should be allowed to die as soon as possible. This can be accomplished by ceasing to talk about it and everybody uniting in the work needed for the advancement and growth of our city, county and state.

ASHLAND, Or., June 27.—The annual assembly of the Southern Oregon Chautauqua will begin at Ashland July 8 and continue for 10 days. The program includes a lot of star attractions for the platform, besides the usual schools and classes. Among the notables of the platform for this year's assembly are: Congressman John Sharp Williams of Mississippi; Bishop Robert McIntyre, Alfred Montgomery, the farmer-painter; Alfred Montgomery, "chaik talker"; Dr. Ira Landrith, Dr. Edwin (Cyclone) Southers, President W. J. Kerr, of the State Agricultural college; Dr. J. Whitcomb Broucher, Mrs. Lenora M. Lake, Y. M. C. A., Secretary H. W. Stone, Dr. E. L. House and others. The music will be in charge of Martin E. Robinson, of Chicago, who had good success last year, and who is already in Ashland preparing for the musical features. The Pasmores will be a musical attraction again this season, having been in Europe studying since their last appearance here. A new feature this year will be a boys' club, under the direction of Professor Irving W. Larimore, physical director of the Portland Y. M. C. A.

The grounds have been greatly improved in many ways the past year, one of the latest improvements which will be completed before the opening of the coming assembly, being a sewerage system to cover the camping grounds.

ROOSEVELT AND TAFT.

The whole realm of public life contains no two men of the same convictions and temperament as are Roosevelt and Taft. Roosevelt is impulsive and combative; Taft is judicial and persuasive. Roosevelt assaults obstacles with all the vehemence of his nature; Taft would order the engineer corps to remove the obstacles. Roosevelt exerts and obliterates his enemies; Taft would make them see the reasonableness of doing the right thing, and ask them to do it. Yet both men work to the same end. It must not be supposed that behind Roosevelt's passion there is no sufficient foundation; neither must it be supposed that behind Taft's amiable there is no iron determination. One is a piece of dynamite under the stump, the other is the stump-raising machine that works evenly and makes no noise—but either will raise the stump. In carrying out the Roosevelt policies by the Taft method there will be fewer explosions in the White House, fewer epithets used, and a death of high-flavored sensations, but the work will be done just as effectively. Roosevelt has the machinery mostly in good working order, and Taft is too good a workman to allow it to get rusty.

GENERAL TAX FAVORED.  
Every Oregon Child Should Have at Least 6 Months Schooling.

UNIVERSITY OF OREGON, Eugene, June 27.—The Western Federation of Teachers' association will endeavor to change the manner of taxation in the state of Oregon from the local tax which now is provided in some districts to some form of a general state tax. Recommendations along three lines of the finance committee were adopted yesterday, as follows: That independent districts should not be utilized any more for the unit of taxation; that a state plan is much better; that every child in the state should have at least six months' schooling; that a committee should be appointed to put the findings before the people through the press. The argument against the district tax in the report is the unequal taxation. For example, in Lane county one district has assessable property amounting to \$3000, while another has assessable property amounting to \$290,000. The speaker showed that scarcely half of the rural schools of the state of Oregon use local taxes to run their districts, and that as a result 20 per cent of the total districts in the state have only four months' school, affecting between 8,000 and 10,000 Oregon children.

On the Taxation of Toilers to Keep Up Military Swagger.

THE poor timid souls who think Japan or Great Britain likely to attack the United States ought really to be sent to a weakminded asylum until they get rid of these cowardly delusions. If it is our duty, strong, rich and unassailable as we are, to have a big and constantly growing navy, much more so it is the duty of all other nations less fortunately situated to do so, and more than one European authority has declared that OUR SWAGGERING TALK OF "A BIG STICK" AND OUR EVER GROWING NAVY have violently checked the tendency to a limitation of armaments, for, as they know us to be in no danger from others, they presume we can only desire a great navy for purposes of aggression upon weaker states, and they point to Mexico, Spain and Colombia as having suffered from us in the past.

We have just had a conference of president and governors to prevent waste of our national resources, and a most commendable purpose it is. I regret, however, that I cannot discover any tangible, practical proposal emanating from such a spectacular assembling together of the wisdom of the head of the nation, re-enforced by the wisdom of the heads of all the states and territories and illumined by the advice of such skillful appropriators to themselves of the national resources as Mr. Hill and Mr. Carnegie. Let us all hope, however, that some sensible and practical proposals will result, but meanwhile let us limit as far as possible THE SHAMEFUL WASTE BY CONGRESS OF THE MONEYS WRUNG FROM THE POOR on objects which can only add to their already heavy and unjust burdens.
