Myrtle Creek Mail

The shareholders of the Myrtle Creek Rochdale Company held a business meeting Saturday. They were well pleased with the showing the Rochdale store has made under the management of G. M. Thorp. During the three months the store has been running, the business down amounts to more than \$25,000, with an ever increasing list of customers. Myrtle Creek lemons are ripe. The crop is not large and the output will not effect the California market at all, but nevertheless there are two different parties here who have real Oregon grown lemons, ripe, and as perfect in shape, color and flavor as the lemon of commerce. One exhibited at the Mail office this week picked from the tree at the M. B. Smith farm in Missouri Bottom, is a fine specimen of its kind, and to all appearances is as good as the best. The tree has green fruit and blossoms also, and the fruit matures in July of each year. The fruit crop in the vicinity of Myrtle Creek is looking well for this time of year, and gives promise of being the largest ever produced in this section. The output of prunes next fall promises to be a record breaker. So far the season has been ideal for the growing prunes and apparently the fruit is larger at this time than is usually the case. The apple yield will be unusually heavy, the largest for many years and the fruit is in good condition. Peaches are a fair crop. Peaches are below the average, with occasionally a full orbored Lugos berries and raspberries are a fair crop. Strawberries are all marketed and the yield was about two-thirds of what it was last season. Cherries are up to average. Some plums and apricots.

FULK'S BODY RECOVERED. The body of Arthur Fulk, the young logger who was drowned in the North Umpqua river, three miles above the fish hatchery, on the 20th of last June, was recovered last Saturday. It arose to the surface of the water and rested against a log in the boom a mile above the hatchery. The body was discovered by Louis Adler, a resident of Glide. It was brought to this city Sunday, and this morning it was given burial in the Odd Fellows' cemetery, with benediction pronounced by Rev. E. H. Hicks and preceded by services at the chapel at W. B. Hamilton's undertaking parlors. Fulk was 26 years of age. His home was at Cretin, Md. A brother, George Fulk, with whom he came to Roseburg from Idaho only a few days before his tragic death, was the only surviving relative present at the funeral.

The body was considerably decomposed. Large bruises on the forehead, face and breast led to the theory that when Fulk fell from the log during his fatal attempt to break a jam in the rapids he must have struck or have been subsequently swept against rocks with such force as to render him incapable of saving himself. Geo. Fulk scents such an idea, however. He believes that his brother was seized with a cramp, which is quite probable in view of the fact that he was overheated from work when he struck the exceedingly cold water of the river.
