WADES INTO HOLE

Oscar Hall, Aged 18, Drowns While Bathing in Umpqua

OCCURRED AT BRICK YARD

Companion Goes to His Assistance, but Abandons Him When Own Life Becomes Imperilled

While bathing in what is commonly known as the "brickyard swimming hole," in the Umpqua river, in South Roseburg, Wednesday evening, Oscar Hall, aged 18 years, was drowned. By means of a grappling hook operated from a row boat, the body was recovered and then taken to the young man's home on Mill street, where he resided with his brother, Tom Hall, and sister. The young man was employed as a driver on the city delivery system, which his brother owns. His parents, Mr. and Mrs. J. W. Hall, reside at Cleveland. In the water with young Hall was Windsor Talcott, a few years older, and who is also employed as a driver on the delivery system. Talcott can swim, but Hall could not. According to Talcott's story of the tragedy, Hall waded into a deep hole, not over 20 feet from the bank, and that as soon as he observed his predicament he swam to his rescue, although almost tired out from a swim across the river and back. Talcott says when he reached his companion, Hall grabbed him and dragged him under water three times, imperiling his own life as well. Finally exhausted and half strangled, Talcott was obliged to abandon Hall in order to save his own life.

Parker Opens Bryan Campaign in Los Angeles.

Taft ADDRESSES LAWYERS

Harriman Says it Makes no Difference Who is Elected as Resources Are so Great.

LOS ANGELES, Calif., Aug. 6.—Judge Alton B. Parker, of New York, opened the Bryan campaign in this city last night with an address to an audience of 2000 people. He eulogized Bryan and Kern, and in referring to the tariff, said:

"How it is that against the interest of the people the party in power for more than 50 years has been able to shut its eyes to the fact that the people have been systematically robbed by means of a statute of this party, which has not consented to change it?"

Taft Addresses Lawyers.

HOT SPRINGS, Va., Aug. 6.—Wm. H. Taft today addressed the Virginia Bar Association on the subject of "Courts." Among other things, he said:

"The present court system, while not perfect, is so far from producing proper results that it calls for anxiety. The inequality existing in the administration of justice will soon rise and call for popular condemnation and reform."

Harriman Don't Care Which.

OGDEN, Utah, Aug. 6.—While the coming election is greatly important it will not matter which is elected, Bryan or Taft," said E. H. Harriman today, while on his way to southern Oregon for an outing. "The policies of both parties are the same. The natural resources of the country are too great to allow an election to affect business." The prosperity will be the same under either administration.

Harriman declared the country needs federal ownership of newspapers because their articles on corporations are unfair to the money interests. He denies the report that he is seeking to form a combination with the Gould interests.

NEGRO DEMOCRATS.

CHICAGO, Aug. 6.—Prominent negroes from all sections assembled today at the Keystone Hotel for a conference of the Negro Democratic League. Plans will be made for furthering the interests of Bryan in the campaign. A place and date will be selected for the next quadrennial national convention. J. A. Ross, of Buffalo, is chairman of the league. It is declared that the negroes of the country are almost a unit in their opposition to Taft and that Bryan will receive a larger colored vote next November than any democratic candidate has ever received.

BRYAN USES "WANT AD."

Unique Method of Calling for Campaign Contributions.

FAIRVIEW, Lincoln, Neb., Aug. 5.—Another startling innovation in campaign methods was adopted today by W. J. Bryan. Following up the invitation to all democrats to contribute, he has made an appeal in the form of a "want ad," in which he announces the leading planks of his platform as the inducement to contribute. This is how he tells what he wants and what he offers:

Wanted—Campaign contributions.

From citizens of the republic who favor these democratic propositions:

Tariff revision by representatives of the consumers and not by the agents of those who make exorbitant profits by manufacture and sale of highly protected products.

Election of United States senators by popular vote, thus breaking up the senatorial oligarchy headed by the Standard Oil, which is strong enough to successfully resist all measures offered in behalf of the people's welfare.

Guarantee of all national bank deposits, thereby preventing all money panics by giving all people absolute confidence in all banks.

Destruction of private property and the enforcement of law against the trusts by the people who are oppressed by the trusts and not by the agents of the trusts.

Strong on Publicity.

Publicity of campaign contributions before election day, so that the people may know who is paying the expenses of candidates and why paying.

Adoption of an income tax, because it is just and so wealth may bear its proportionate share of the burdens of the federal government.

The punishment of men who manipulate railroad stocks and ownership, the encouragement of railroad construction on a businesslike basis and railroad operation with fair returns in wages and profits to workers and owners on honest valuation and honest labor, but not on watered stocks and false bond issues created purely by exploitation.

The appeal closes with a copy of the resolution adopted by the democratic national committee on the occasion of its visit to Fairview, July 14, declaring for publicity of contributions before election, limiting individual contributions to \$10,000, and providing for the publication of all contributions above \$100.

BOARD ON DEFENSE

Interstate Rulings Assailed by Railroads

OREGON TARIFF INVOLVED

Canadian Pacific Strike May Extend to Trainmen—Typewriter War Inaugurated

SAN FRANCISCO, Aug. 6.—It was officially announced here today that the Interstate Commerce Commission will meet in this city August 18 to take up matters relating to the controversy between that body and the railroads affected by its recent order reducing the tariff on lumber shipments from western Oregon to San Francisco bay points. It is likely that the commission will also hear complaints of transcontinental roads against its ruling on Oriental tariffs. The commission has also been subpoenaed to answer in the Federal court before Judge Morrow why an injunction should not be issued restraining enforcement of the new lumber rates, which are being very strongly opposed by the railroads, principally the Southern Pacific.

Strike May Extend.

WINNIPEG, Aug. 6.—It was announced at the headquarters of the striking machinists of the Canadian Pacific today, that the engineers, firemen and conductors' unions are negotiating for a sympathetic strike. If this occurs it will completely tie up the system and prevent the moving of crops. The railroad officials are apparently unmoved by these reports.

War on Typewriter Trust.

NEW YORK, Aug. 6.—A typewriter war promising a slash in prices has been started by Allan A. Ryan, son of Thomas R. Ryan, the multi-millionaire. Young Ryan announces that he will put the highest grade of machine on the market for \$65, and that his concern and other independent manufacturers will fight the trust to a finish.

Young Turks Rejoice.

CONSTANTINOPLE, Aug. 6.—A new Turkish cabinet was named today by the Sultan. There isn't a single reactionary in it, and the members promise to uphold the new constitution. This is regarded as a great victory by the young Turks, and they are rejoicing generally.

PRIMARY RESULTS.

Elections Held in Kansas, Missouri and Oklahoma.

TOPEKA, Kan., Aug. 5.—After one of the bitterest campaigns ever waged in Kansas, the nomination of Joseph L. Bristow, as republican candidate for United States senator is conceded by Chester I. Long, the present incumbent.

Walter R. Stubbs, of Lawrence county, was nominated for governor by the republicans over Cyrus Leeland, Jr. Early returns indicate the renomination of all republican congressmen.

Mr. Bristow was fourth assistant postmaster-general in President Roosevelt's first administration and brought to light the frauds in his department which caused the sending of several officials to the penitentiary. He made a report accusing a number of congressmen of unduly influencing postal appointments, which caused a storm in the House with a chorus of vociferous denials. He resigned in the interest of peace in the party and was appointed by the president to investigate the commercial possibilities of the Panama Canal, where he fell foul of the Harriman competition of railroads and steamships. He then retired to Salina, Kan., where he is editor of the Journal.

Matilda Vanderpool, a 13-year-old girl, ward of the Boys' and Girls' Aid Society of Portland, who ran away from the home of Mr. Craig, at Myrtle Creek last Sunday, was apprehended at Ruckles the following day as she was walking along the railroad track. Yesterday she was brought to Roseburg, where she now awaits the arrival of Supt. W. T. Gardner, of the Aid Society, to take her back to Portland.

Through the initiative of R. L. Stephens, a movement for the erection of a suspension foot-bridge across the Umpqua river at the foot of Oak street has been made. Over \$700 have been pledged for that purpose by residents of West Roseburg, which suburb would be brought into much quicker communication with the city by the erection of such a structure. It is estimated that the cost of such a bridge would be about \$3000. "Booster" Zurcher is in communication with a Portland engineer in relation to the same and the matter may take definite shape in the near future.

RAID MINING CAMP

Yaquis Indians Slay 13 and Now Threaten Survivors

CHICAGO MURDER MYSTERY

Two Tragedies in San Francisco, and Both Victims Boys—One Shot Other Suicides

EL PASO, Aug. 6.—According to a private letter received here, thirteen persons were killed at the Lampazas mine by Yaquis Indians, who are now threatening to attack the Promontorio mine, where survivors have taken refuge. The massacre occurred on the morning of July 24. Without warning the Indians swept down on the mining community, killing thirteen members of three families.

Work Scarce; Stole; Killed.

SAN FRANCISCO, Aug. 6.—Scott Rounds, aged 19 years, was shot and instantly killed this morning by Policeman M. T. Arey, who caught him in the act of robbing a Mission Street saloon. The policeman chased Rounds and a companion, Ray C. Paired, who was later captured. The two came here from Seattle looking for work and could not find it.

Afraid of Spirits; Suicides.

SAN FRANCISCO, Aug. 6.—De-luded with the idea that he was being pursued by the devil, William Lattin, aged 18 years, ended his life today by drinking carbolic acid. He left a rambling note to his mother, relating his experiences with evil spirits, saying he did not dare go home for fear they would kill him.

Evidence of Foul Crime.

CHICAGO, Aug. 6.—Searchers today discovered the head of the dis-membered body of a boy which was found yesterday sticking in a hole in the drainage canal. The corpse is now complete except the arms. The police are secretly holding a Greek suspect, thought to be the leader of the atrocious "Padrone System" of murder. Four ribs broken at the ends indicate that they were torn from the body.

Bryan in Charge Aug. 22.

LINCOLN, Neb., Aug. 6.—It was announced today that Bryan would assume official charge of his campaign at Chicago August 22.

DRUMMERS TO ORGANIZE.

MILWAUKEE, Wis., Aug. 6.—An attempt to organize a National Association of Traveling Men will be made by the representatives of the profession who gathered here today for a session of three days.

The correction of grievances of the traveling public is the purpose of the organization. Already the attention of the state railroad commission has been called to evils existing within the state, which should be corrected. Letters have been received from hundreds of travelers commending the organization and offering their aid. The fact that there are 650,000 in the United States, who pay \$500,000,000 annually to hotels and \$750,000,000 annually to railroads, is given as a reason for the organization which shall protect their interests. The committee has been assured of the co-operation of many leading hotels and railroads throughout the country.
