LONG LIFE ENDED

Nicholas T. Day, Pioneer of 1850, Called by Death

WAS NEARLY 88 YEARS OLD

Performed Humane Deed in 1855 by Preventing Attack on Peaceful Umpqua Indians

Death Tuesday evening, August 11, 1908, summoned another of Douglas county's prominent and honored pioneers, in the person of Nicholas T. Day, who passed away at the home of Jesse T. Thompson, at Coles Valley. Mr. Day was nearly 88 years of age. About six months ago his health began to fail rapidly and during the past week his condition was such that death was expected at any hour.

The funeral will be held from the Methodist Episcopal church in this city tomorrow morning at 10 o'clock with services conducted by Rev. J. K. Hawkins. Interment will occur in Masonic cemetery beside the grave of Mr. Day's wife, who died in 1897.

Mr. Day was born in Taxewell county, Virginia, October 26, 1820. At the age of 21 he emigrated to Wisconsin and engaged in lead mining. While in that state he also visited for its admission into the Union. In 1850 Mr. Day journeyed across the plains into Oregon, stopping first at The Dalles, where he was employed by the government for two months building the historic old log fort, which served as a means of defense against Indian attacks. Mr. Day spent the winter of 1850 in Yamhill county, and in the following March, in company with General Palmer and 21 other men, he went to the mines at Yreka, Calif. In 1852, Mr. Day returned to Oregon settling at the mouth of the Calapooya river, 10 miles west of Oakland, where he remained continuously up to the time his health began to fail.

Mr. Day leaves five daughters and one son: Mrs. Isadore Abraham and Miss Jessie Day, of this city; Mrs. H. D. Yett, of Long Beach, Calif.; Mrs. J. F. Fowler, of Stellacoom, Wash.; Mrs. Roy Whistler, of Win-

lock, Wash., and Fred Day, of Portland. Mrs. Fowler arrived here on Monday.

Saved Indians From Attack.

During the Rogue River Indian war of 1855-56, Mr. Day's sense of right and courage prevented an unwarranted slaughter of the Umpqua tribe of Indians, about 400 in number, who dwelt near his place on the Calapooya. These Indians were on peaceful terms with the white settlers, but this fact was unknown to a company of seventy volunteers, organized in the Willamette valley and heading southward to participate in the campaign against the Rogue River tribe. Learning of the presence of the Umpqua Indians on the Calapooya and presuming that they were also hostile, this company decided to attack them. Through some source, the Indians were apprised of this plan, but the chief of the tribe, in preference to giving battle, appealed to Mr. Day to intercede. Mr. Day at once intercepted the volunteers and demanded that they let the Umpqua tribe alone. The captain of the company at first became angry at this and threatened to shoot Mr. Day. Upon being defied, however, by Mr. Day, who stood his ground unflinchingly, the officer cooled off and moved his company on south, where they rendered valiant service in the Rogue river campaign.

In January, 1856, at the order of the government, the Umpqua Indians were assembled at the mouth of the Calapooya and placed in charge of Mr. Day. This was done to prevent their being approached by Indians of other tribes, who might be inclined toward war. Later they were moved to the reservation on the St. Helens.

DAY OF OVATIONS TO BRYAN IN LINCOLN

Notification Occasion for Joyous Celebration

"SHALL THE PEOPLE RULE"

This is the Slogan of Nominee, Who Grills Republican Rule in Grand Style

LINCOLN, Neb., Aug. 12.—"I have the honor of notifying you of your nomination as the democratic candidate for president," quoth Congressman Henry D. Clayton, permanent chairman of the Denver convention in a few well chosen words.

And in accepting it William J. Bryan launched forth in an address in which he outlined the democratic policies in the present campaign, elaborated the platform declarations and denounced the republican policies, past, present and prospective. One of the largest crowds ever gathered in Lincoln heard the address of the famous commoner, and took part in the demonstrations of joy and approval which marked every important incident of the day's program. The whole city was given over to celebration. Intermittent showers prevailed, but the democrats said it was democratic weather, presaging victory for Bryan in the national election. As Bryan walked to breakfast, he was loudly cheered, and fireworks were exploded.

The day was ushered in at sunrise with the firing of a salute of forty-six guns, one for every state in the Union. By 10 o'clock, when the formal program was commenced with a band concert, the streets were crowded with people. Political leaders from all over the country and crowds of well-dressed city folk from Omaha, St. Joe and other towns rubbed shoulders with husky Nebraska farmers, who had drove into town with farm wagons filled to overflowing with the women folks and the youngsters.

Following luncheon, the members of the notification committee, accompanied by Bryan and Kern, paraded in carriages to the capital grounds. The candidates for the presidency and vice-presidency were given an ovation all along the line.

The day's program will come to a close this evening with a dinner to the committee on the lawn at Fairview, Mr. Bryan's suburban home.

At the capital grounds, where the notification ceremonies took place, Mr. Bryan was given another ovation when Mr. Clayton finished his remarks. Great as this was, however, it was totally eclipsed by the demonstration that followed the closing of Mr. Bryan's reply, which fairly lifted the great crowd from its feet. Mr. Bryan spoke as follows:

Mr. Clayton and Gentlemen of the Notification Committee:

I cannot accept the nomination which you officially tender without first acknowledging my deep indebtedness to the democratic party for the extraordinary honor which it has conferred upon me. Having twice before been a candidate for the presidency in campaigns which ended in defeat, a third nomination, the result of the free and voluntary act of the voters of the party, can only be explained by a substantial and undisputed growth in the principles for which I, with a multitude of others, have contended. As these principles and policies have given me whatever political strength I possess, the action of the convention not only renews my faith in them, but strengthens my attachment to them.

A Platform is Binding.

I shall, in the near future, prepare a more formal reply to your notification, and in that letter of acceptance, will deal with the platform in detail. It is sufficient, at this time to assure you that I am in hearty accord with both the letter and the spirit of the platform. I endorse it in whole and in part, and shall, if elected, regard its declarations as binding upon me. And, I may add, a platform is binding as to what it omits as well as to what it contains, according to the democratic idea, the people think for themselves and select officials to carry out their wishes. The voters are the sovereign; the officials are the servants employed for a fixed time and at a stated salary to do what the people

want done, and to do it in the way the people want it done.

Republican Challenge Accepted.

The distinguished statesman who received the republican nomination for president said, in his notification speech:

"The strength of the republican cause in the campaign at hand is the fact that we represent the policies essential to the reform of known abuses, to the continuance of liberty and true prosperity and that we are determined, as our platform unequivocally declares to maintain them and carry them on."

In the name of the democratic party I accept the challenge and charge that the republican party is responsible for all the abuses which now exist in the federal government, and that it is impotent to accomplish the reforms which are imperatively needed. Furthermore I cannot concur in statement of the republican platform unequivocally declares for the reforms now necessary; on the contrary, I affirm that it openly and notoriously disappoints the hopes and expectations of reformers, whether those reformers be republicans or democrats. So far did the republican convention fall short of its duty that the republican candidate felt it necessary to add to his platform in several important particulars, thus rebuking the leaders of the party, upon whose cooperation he must rely for the enactment of remedial legislation.

As I shall, in separate speeches, discuss the leading questions at issue, I shall at this time confine myself to the paramount question, and to the far reaching purpose of our party, as that purpose is set forth in the platform.

Shall the People Rule?

Our platform declares that the overshadowing issue which manifests itself in all the questions now under discussion is: "Shall the people rule? No matter which way we turn; no matter to what subject we address ourselves, the same question confronts us: Shall the people control their own government, and use that government for the protection of their rights and for the promotion of their welfare? Or shall the representatives of predatory wealth prey upon a defenseless people, while the offenders secure immunity from subsequent official whom they raise to power by unscrupulous methods? This is the issue raised by the "known abuses" to which Mr. Taft refers.

The President's Indictment.

In a message sent congress last January, President Roosevelt said: "The attacks by these great corporations on the administration's actions have been given a wide circulation throughout the country. In newspapers and otherwise, by those writers and speakers who, consciously or unconsciously act as the representatives of predatory wealth—of the wealth accumulated on a giant scale by all forms of iniquity, ranging from the oppression of wage earners to unfair and unwholesome methods of crushing out competition, and to defrauding the public by stock jobbing and the manipulation of securities. Certain wealthy men of this stamp, whose conduct should be abhorrent to every man of ordinarily decent conscience, and who commit the hideous wrong of teaching our young men that phenomenal business success must ordinarily be based on dishonesty, have, during the last few months, made it apparent that they have banded together to work for re-election. Their endeavor is to overthrow and discredit all who honestly administer the law to prevent any additional legislation which would check and restrain them, and to secure, if possible, a freedom from all restraint which will permit every unscrupulous wrong doer to do what he wishes unchecked, provided he has enough money—what an arraignment of predatory interests. Is the president's indictment true? And, if true, against whom was the indictment directed? Not against the democratic party.

Taft Endorses Indictment. Mr. Taft says that these evils have crept in during the last ten years. He declares that, during this time some "prominent and influential members of the community, spurred by financial success and in their hurry for greater wealth, became unmindful of the common rules of business honesty and fidelity, and of the limitations imposed by law upon their actions," and "the revelations of the breaches of trusts, the disclosures as to rebates and discriminations by railroads, the accumulating evidence of the violations of the anti-trust laws by a number of corporations, and the over-issue of stocks and bonds of interstate railroads for the unlawful enriching of directors and for the purpose of concentrating the control of the railroads under one management," all these, he charges, "quickened the conscience of the people and brought on a moral awakening." During all this time, I beg to remind you, re-

STRIKERS LOSING

Canadian Pacific Pays them off and Discharges Them

ROAD WILL FIGHT TO WIN

Union Pacific Wins \$27,000,000 Suit—Thaw Declared Bankrupt, to Evelyn's Loss

WINNIPEG, Aug. 12.—Employees of the Canadian Pacific railway were today paid in full and the striking machinists were notified that they were discharged. This is taken to mean that the railroad will fight the strikers to a finish, and present indications are that the road will win. Strike-breakers are being imported in increasing numbers from the United States, but no clashes are reported.

Vice-President Whyte, of the Canadian Pacific, who arrived today from the Pacific coast, declared that the road had started in to win this fight, and would spare neither money or effort to do so.

Durkee Estate Loses.

ST. LOUIS, Mo., Aug. 12.—Morgan, Harriman, Gould and other Wall street magnates are indirect victors in a decision handed down in the United States court of appeals today, denying the claim of the Durkee estate against the Union Pacific railroad in a suit involving millions of dollars and which has been pending five years. John A. Kaykendall, as administrator of the estate of Charles Durkee, who died in 1870, sued the railroad, claiming Durkee owned \$27,000,000 worth of first mortgage bonds, obtained by loaning money for the construction of the road. Kaykendall alleged that Durkee was defrauded out of his rights by the manipulation of other stockholders.

Thaw Declared Bankrupt.

PITTSBURGH, Pa., Aug. 12.—Harry K. Thaw was declared a bankrupt by Referee Blair today. This action greatly reduces Evelyn Thaw's income, which has been over \$1000 a month.
