ASKS POINTED QUESTIONS.

John W. Kern, Candidate for Vice-President, Scores Roosevelt.

In a speech at Baltimore a few days ago, Hon. John W. Kern, democratic candidate for vice-president, referring to the Haskell incident, said:

"Under our system of jurisprudence every man is presumed innocent until his guilt is satisfactorily shown. A square deal even as interpreted by half civilized people demands this. The evidence at hand tends to confirm this presumption as to Governor Haskell. He is at all events entitled to a hearing before he is condemned by any fair-minded man. If after a hearing there should be any doubt of Governor Haskell's innocence, his official connection with the Democratic national committee will cease and that be the evidence of the good faith of our party."

SOME REPUBLICAN REASONS.

"But when did Mr. Roosevelt become so sensitive as to the previous or even the present business connections of the officers of the several political organizations? Was his conscience shocked when the trust magnates and tariff beneficiaries forced the election Geo. R. Sheldon as treasurer of the Republican national committee, knowing, as he did, Mr. Sheldon's connection with 20 or more corporations? Did he object to the appointment of Frederick W. Upham, a member of the Illinois board of regents, which passes upon the amount of taxes the corporations and large estates in that state shall pay? Was his conscience aroused when he learned a few weeks ago that on Mr. Upham's motion, as a member of that board, the assessment of the Chicago Street Railway had been reduced about \$10,000,000 from the amount fixed by the assessors? The officials of that corporation will be ungrateful indeed if they fail to respond with liberal individual campaign contributions on the demand of Mr. Upham. Was Mr. Roosevelt in any wise offended at the 'makeup' of the executive committee of his party?"

HOW ABOUT DUPONT?

"Did he object to the appointment of Charles F. Booker, vice-president of the New York, New Haven & Hartford railroad company, a corporation now a defendant in a suit by the government? Has he manifested displeasure at the appointment on that committee of Mr. Dupont, a member of the Dupont Powder company, a controlling factor in the powder trust, against which the government is now proceeding cautiously on account of its violation of the law? As a civil service reformer, did the president experience any shock at the appointment of Boies Penrose of Pennsylvania on that committee. And what did he think of the choice of Frank O. Lowden of Illinois, considered as he is with that widely-known and felt monopoly, the Pullman Palace Car Company? If the appointment of Governor Haskell, a man recently endorsed by the president, what diatribes may be expected from him when he familiarizes himself with the personnel of the executive committee of his own party?"

BONAPARTE AND STEEL TRUST.

Mr. Kern then turned his attention to Mr. Bonaparte and the steel corporation. "Although the most conspicuous of all the gigantic monopolies which have grown up behind the Dingley tariff wall," he said, "there is no man in the country who is in doubt as to its existence. That man is a distinguished citizen of Maryland, Hon. Charles J. Bonaparte, chief law officer of the United States. Referring to the charges made by Mr. Bryan that this combine has been allowed to grow and thrive and fatten upon the earnings of the people in defiance of law, Mr. Bonaparte falls into a humorous vein and brushes aside the charge with a bit of pleasantries, published in the newspapers today in the form of an interview."

HASKELL RESIGNS.

Forced Out by Charges, but Insists That They are Untrue.

CHICAGO, Sept. 25.—Governor C. N. Haskell, at midnight resigned as treasurer of the Democratic national committee. His resignation was announced by himself three hours after his arrival in Chicago from Guthrie, Okla., and after he had conferred with officials of the democratic national committee.

Haskell admitted that his resignation is the direct result of Hearst's and Roosevelt's charges, but still insists that they are untrue.

HEARST TICKET.

NEW YORK, Sept. 26.—A full state ticket will be nominated by the Independence party at its convention in Cooper Union today. It is understood that Reuben Robie Lyon or Henry A. Powell will be selected for governor and that an entirely independent ticket will be placed in the field against Hearst and Chandler. National and state headquarters of the Hearst party have been established in the American building and an extensive campaign will be directed from that point.

OHIO DEMOCRATS.

MANSFIELD, O., Sept. 26.—Buckeye state democrats are here in force today at the big rally formally opening the state campaign of the party. John W. Kern, democratic candidate for vice-president, and Judson Harmon, candidate for governor, will be the chief orators.

TAFT IN ST. PAUL.

ST. PAUL, Minn., Sept. 26.—William H. Taft began his invasion of the Twin Cities today and will make speeches in both St. Paul and Minneapolis. Tomorrow he will spend in Minneapolis, resting from the fatigues of his campaigning of the last three days. Next week he will tour the Dakotas, Nebraska, Iowa, Kansas and Colorado.

BANKERS IN DENVER.

DENVER, Colo., Sept. 26.—With the arrival today of the advance guard of the nation's bankers, Denver is already a fair way to become the temporary financial center of the country, and by tomorrow evening or Monday morning there will be hundreds of bankers and financiers in the mile-high town, with an aggregate capital that will make Wall street, New York, look like a child's betting ring. At least, so say the enterprising Denver bankers and capitalists who for months have been laying plans to make next week's convention of the American Bankers' Association the most successful and interesting financial conference in the country's history.

Coming as it does on the eve of a presidential campaign, with the bank guaranty project and other financial issues in the foreground, the coming convention cannot fail to be of general interest to the country at large, and will doubtless produce many interesting discussions of financial matters. The present panic, its causes and effects, will also provide a topic for consideration that will attract general attention.

HOLDS LAW INEFFECTIVE.

Judge Hanna Prevents Removal of Medford Councilman.

MEDFORD, Or., Sept. 25.—Holding that the recall amendment passed last June is ineffective and without legislative action providing for the manner of putting it into effect, Councilman John D. Owell, through his attorneys, Reames & Reames, on Friday secured a temporary injunction from Circuit Judge Hanna, restraining City Recorder Collins from calling a special election under the recall petition for his removal filed last Saturday.

The injunction is asked upon the grounds that Mr. Owell was duly elected, qualified and has since served as councilman from March of last year, the term extending from January 15, 1907, to January 15, 1909. The recall constitutional amendment passed last June is quoted as providing "such additional legislation as may aid the operation of this section shall be provided by the legislative assembly" and the amendment is alleged to be "ineffective for any purpose until added by appropriate legislation."

No action has ever been taken; it is alleged, by the people of Medford or its city council providing for the manner of carrying into effect the recall amendment, nor has there been any legislative action or popular vote providing therefor.

It is also alleged that there is no provision of law or ordinance providing the number of names to be signed to a recall petition, and the same was left to legislative action, which has not been taken, and the number required has not been fixed by law.

The election, it is declared, will be a needless expense to taxpayers; a waste of money by the recorder; that a multiplicity of lawsuits will follow as well as block important pending legislation, to the detriment of the city.

PAVING PLANT IGNITES.

Warren Construction Company Loses \$1000 at Vancouver.

VANCOUVER, Wash., Sept. 25.—The plant of the Warren Construction Company, which is laying blocks of bituminous pavement in this city, suffered \$1000 damage by fire early this morning.

The building in which the machinery was located was totally destroyed as were also the carriers, but the bituminous mixture were only slightly injured and the boiler and engine not injured at all.

The tar-like bituminous mixture that was being heated in the big cauldron boiled over and the fire ran all over the ground. On this account the firemen were unable to use water on the burning building.

HEAD OF POWDER TRUST.

Dupont Resigns From National G. O. P. Committee.

NEW YORK, Sept. 25.—After many rumors which were about here and in Washington, Chairman Hitchcock of the Republican national committee, announced that General T. Coleman Dupont, of Delaware, head of the bureau of campaign speakers, of the national committee, had resigned as head of that bureau and also as a member of the executive committee of the national committee and that his resignation has been accepted.

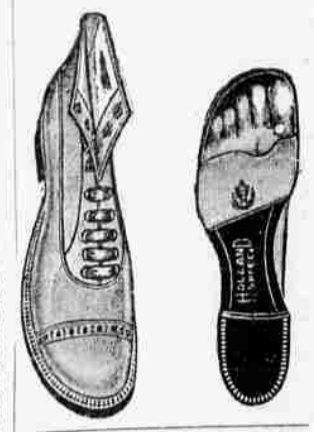
Chairman Hitchcock explains that Dupont's connection with the powder companies, now being used by the government, would be employed by the democrats to injure the republican campaign.
