

The Portland Oregonian contains a special dispatch under date of October 1 from its Washington correspondent virtually conceding Ohio to Bryan. The dispatch states: "Ohio, the home of the republican presidential nominee, has become the most doubtful of all the normal republican states. The Foraker following will be antagonistic to the republican national ticket in November. The situation is most serious. There is lack of good party organization; there is lack of party harmony, and there is an alarming lack of enthusiasm. Foraker has not lost all his strength. He is still an idol with not a small republican following. There are at least 40,000 negroes, holding the balance of power in Ohio, who will follow Foraker's advice, and if Foraker persists in his fight, the republican ticket will fall."

The situation in Ohio finds a parallel in Indiana, Illinois, Wisconsin, Iowa and other central west republican strongholds. The use of federal patronage and the big stick to force Tatt upon the party is everywhere resented by the party, with the result that leaders are resentful and the rank and file apathetic.

CIRCUIT COURT DOCKET.

October Term Opens Next Monday With 100 Cases Listed.

A preliminary session of the Circuit Court will be opened by Judge Hamilton in this city next Friday, for hearing motions, arguments, etc., on cases, preparatory to the opening of the regular October term of court next Monday. The docket of cases to be heard at this term includes a total of 100 actions, and suits, besides whatever cases may be returned on judgments by the grand jury.

This is the longest docket of cases for hearing at a single term of court ever called in Douglas county. It was nearly equalled last January, when the number of docketed cases was 102. Of the cases to be heard at the present term, 18 are actions for divorce.
