OREGON'S VOTE MAY DECIDE

How New York World Sizes up Chances of Bryan and Taft.

Portland Journal, Oct. 20: It is within the possibilities that Oregon's four electoral votes may decide the result of the national campaign. In that event the voters of Oregon will determine by their votes whether Bryan or Taft is to be the next president of the United States.

According to the forecast of the New York World, which on the whole is the fairest estimate of the situation that has been published, there are but six really doubtful states, New York, Indiana, Ohio, Maryland, Nebraska and West Virginia.

The World considers that Taft is sure of 295 electoral votes, Bryan is sure of 178, and these six doubtful states have 109. The successful candidate must have 242 votes.

The six doubtful states are as follows: Indiana 15, Maryland 8, Nebraska 8, New York 33, Ohio 29, West Virginia 7.

Present indications are that Bryan will carry both Nebraska and Indiana. New York, which is now the chief battleground, is expected to go for Bryan. Adding the vote of these three states to that of the states which are considered safely for the Nebraska, his total would then be 240, or two less than the required majority of the electoral college.

If Oregon's four votes should be cast for Bryan he will be elected, even though Taft carry Maryland, Ohio and West Virginia.

Oregon's vote would be equally decisive in case Bryan carries New York and Ohio, the other four doubtful states going to Taft.

Even without New York Bryan will be elected provided he carries the other five states classed by the World as doubtful and receives in addition Oregon's four votes.

NEW INDICTMENTS

Two for Liquor Selling—One For Tobacco to Minor

FOURTH HELD IN SECRECY

Jones and Cameron, indicted at Term Previous, Fail to Appear, and Forfeit \$1,000

Pleading guilty to the charge of selling tobacco to a minor, John W. Kruse, a storekeeper of Yoncalla, paid a fine of \$20 in the circuit court here this morning.

The grand jury is still in session, but it is expected to complete its work tomorrow. This morning the jury asked Judge Hamilton in effect if an evasion of the law was equivalent to a violation of the law and indictable.

Judge Hamilton informed the jury that the question raised was for the jurors exclusively to decide. The word "evasion" is believed to indicate that the jury was investigating either "near-beer" traffic or indiscriminate sale of liquor through physicians' prescriptions.

That the former, at least, is probable is evidenced by the condition of the grand jury room, which, when exposed to outside gaze for a brief moment, this afternoon, revealed innumerable bottles of liquor under inspection.

The jury this morning returned "not a true bill" in the case of Thos. Gallagher, a transient, charged with stealing a pair of trousers from the McMullen home, in the Hamilton addition, several weeks ago.

The Wels-Kohlman damage suit, which resulted in a verdict for the defendant, will be appealed to the supreme court.

\$1,000 Forfeited. Forfeiture of bail was declared in the cases of Chas. Jones and John Cameron, partners, indicted by the grand jury on the charge of selling intoxicating liquor.

Neither defendant appeared at this term of court for trial. Each had posted bail of \$500.

RECORDS VS. PROMISES.

Record of Last Congress and Record of Taft Convention.

Promises are cheap, but records are costly. Three times within 25 years Mr. Taft's party has promised revision of the tariff, and each revision, instead of reducing, raised the tariff in 1884 it raised the duties, in the face of the fact that a high tariff commission had urged congress to reduce all duties 20 per cent.

The last congress rejected all appropriations for rivers and harbors, but voted hundreds of millions to increase the army and navy. Why? It refused to pay expenses for the commission on conservation of our water powers, our forests, our coal lands and our natural resources.

It rejected a campaign publicity bill, rejected the injunction bill, rejected a child-labor bill—rejected everything the people asked for.

The Taft Convention. By a vote of 866 to 114, the convention that nominated Taft rejected the La Follette platform plank for election of senators by the direct vote of the people.

Also, the same convention, by a vote of 917 to 63, rejected a plank for ascertaining the real value of railroads as a basis for regulating rates.

La Follette was the father of it and has put it into effect in Wisconsin. Why was it rejected?

Again, the same convention, by a vote of 884 to 94, rejected a plank for publicity of campaign funds.

Trust magnates dare not let it be known before election what they are contributing to Mr. Taft's campaign, because thereby they would warn the public of their designs.

When trust magnates contribute, they expect favor in return. It was for their sake that the publicity plank was rejected.

Once more, in a speech in Oklahoma, Mr. Taft opposed the initiative and referendum. The constitutionality of this law is now being tested.

It is now on its way to the United States supreme court for final decision. Four members of that court retire during the next administration.

If Mr. Taft is elected, will he not appoint men to that bench who are in sympathy with him in his opposition to the initiative and referendum? Men, think before you vote!—Saturday's Portland Journal.

VETERANS FAVOR BRYAN.

Portland Journal: Members of the Grand Army of Portland do not seem to look with favor upon the candidacy of William H. Taft, according to the investigations of Alanson M. Hines of this city, himself a member of the Grand Army.

Mr. Hines decided yesterday to take a sort of straw vote among the old soldiers and see how they were going to vote at the presidential election.

Accordingly he started out among the veterans and the first 12 men he met, all of them republicans, signified their intention of voting for Bryan.

Mr. Hines decided if that was the way the sentiment ran it would not be necessary for him to search further to find how the soldiers were intending to cast their ballots.

ANOTHER BRICK BLOCK.

The apartments in the Abraham building, recently vacated by the Hunsaker-Guest Co., is being prepared for occupancy by another grocery firm—Mrs. A. C. Kidd & Son, whose present location is to be utilized by the owner, A. Schioemann, for a new two-story building early next year.

Mr. J. G. Mack, of Portland, one of the owners of the Abraham building, who is in the city, states that the demolished one-story brick adjoining and formerly occupied by I. Abraham, will be replaced as early next year as the weather permits by a modern two-story structure, plans for which are now being drawn by a Portland architect.

The new building will be 90 feet deep and 40 feet wide, save for a small portion of the front, which will be reduced 5 feet to maintain the present stairway leading to the upper floor of the other building.

The extension of this stairway, descending to the rear of the building will be abolished. A steam heating plant will supply both buildings. The lower floor of the new structure will be planned for store purposes, while the upper part will be divided into office rooms.

SCHIEK'S SHORTAGE GROWS.

WASHINGTON, Oct. 21.—The Controller of the Currency today received a report of Bank Examiner Claude Gatch, showing that the affairs of the Farmers' & Traders' National Bank of La Grande, which recently failed, are much worse than first anticipated.

At the time of making his report, Gatch had discovered a shortage of \$47,000 and as other liabilities are discovered this shortage may grow.

The face value of the bank's assets was \$166,231, and its liabilities, as far as ascertained, \$213,515.

SERVIANS REVOLT

Have Been Warring Against Austria For 10 Days

FACT WITHHELD FROM WORLD

Portland Postoffice Cashier Held to Federal Court on Charge of Embezzlement

Special to the Evening Review. LONDON, Oct. 22.—Open warfare has been in progress for the past ten days in the provinces of Bosnia and Herzegovina, annexed by Austria a few weeks ago.

This is the information brought here by a Montenegro agent, who says 120,000 Austrian soldiers sent into the provinces were attacked by Servian insurgents. Knowing that they could not engage in an open battle with any prospect of victory, the rebels are carrying on guerrilla tactics with such good effect that Austria is rushing reinforcements over the frontier.

True conditions in the annexed territory have been kept from the outside world owing to the strict news censorship established by the Austrian government.

Portland P. O. Clerk Held. PORTLAND, Or., Oct. 22.—Chas. A. Strauss, cashier in the Portland postoffice, surrendered to the federal authorities today, after a preliminary hearing on the charge of embezzling government funds. He furnished half of \$5000. It is charged that Strauss failed to turn over remittances for stamps and other sums received from the postmasters throughout the state, amounting to \$4,000.

Arrest in Murder Case. VANCOUVER, Wash., Oct. 22.—In the arrest last night of a man giving his name as B. D. McLean, the police believe they have a person who knows something about the murder of H. P. Butterworth, the jeweler, in his dooryard at St. Johns Tuesday night. McLean is being put through the sweat box this afternoon.

Mutiny on Ship. SAN PEDRO, Calif., Oct. 22.—At the request of Capt. Whittier, a number of policemen reinforced by a special squad of deputy sheriffs, went to the ship Aram today to arrest the ringleaders of the mutineers in possession of the vessel. The mutiny was the result of Capt. Whittier's refusal to allow the crew to go ashore last night, and the captain saved his life only after a desperate fight.

Cracksmen Make a Haul. SIOUX FALLS, S. D., Oct. 22.—The vaults in the State Bank of Verigil were cracked by dynamite early this morning, and \$4,700 were stolen.

Michigan for Taft. CHICAGO, Oct. 22.—A straw vote in Michigan, conducted by the Chicago Record-Herald, indicates that Taft will carry the state by a plurality ranging from 50,000 to 100,000.

Missing in Mountains. HOT SPRINGS, Wash., Oct. 22.—Although two searching parties have scoured the mountains for a trace of Fred W. Kloeber and Julius Klumme, who have been missing since Monday, nothing has been found or seen that indicates their whereabouts. The men were lightly clad and carried no food. They had intended to be absent from Hot Springs only a few hours. Bloodhounds have so far been unable to pick up the scent, and it is feared the men are dead.
