SALEM, Or., Dec. 2.—The gross income of the Southern Pacific from its Oregon & California division between Ashland and Portland during the year ending June 30, 1908, according to the report filed with the Oregon Railroad commission, was \$2,714,909.95. Salaries and maintenance amount to \$598,811; accrued taxes, \$188,770.34; net income, \$2,116,128.61. From this amount current expenses are deducted, making what is called the net corporate income in Oregon the past year, \$949,813.76.

The report also shows that receipts from the sale of lands held by the Southern Pacific in Oregon amounted to but \$12,963.87.
