MILLIONS AT STAKE

Newfoundland Fishing Rights in Hague Conference

ROOSEVELT SITS WITH KINGS

Dominating Figure at Royal Luncheon—Tariff Main Feature of Congressional Campaign

Special to the Evening Review.

NEW YORK, May 21.—There called from here today the American delegation to the Hague conference between the American and British representatives for the settlement of the Newfoundland fishing cases. This delegation is headed by Senator Root, of New York, and among the members is Senator Turner, of Spokane. They will present claims in one of the most important disputes in which this country has ever been involved. Upon the adjudication depends millions of dollars worth of fishing rights. Twice in our nation's history has war been threatened between America and England over this question of fishing off the Newfoundland coasts and over the famous "Newfoundland Banks."

Roosevelt is Dominating Figure at Royal Luncheon.

LONDON, May 21.—The London newspapers today devote much space to describing the spectacle of the royalty of Europe, Asia and Africa gathered about former President Roosevelt at Windsor Castle, following the funeral of the late King Edward. The incident is termed a "wonderful personal triumph for Col. Roosevelt." At a luncheon to the many rulers present Col. Roosevelt was the particular guest of King George and was assigned to a place of honor with Kaiser Wilhelm of Germany. The distinguished American is termed in the press reports as being the dominating figure at the luncheon. The affair was marked by keen passages of conversation in which Roosevelt won the honors. The kings piled him with questions upon the world events of the hour and asked his views upon American and European politics. These he parried by asking questions regarding the duties of kingship as understood by host and guest.

The Roosevelts will remain in London until Monday.

Naval Conflict Imminent.

COLON, May 21.—It was learned today that President Madriz has sent wireless orders to General Arias, aboard the Nicaraguan gunboat Venus, to return to Bluefields and bombard the city, despite the American orders to the contrary. Madriz's action is believed to foreshadow a fight between the American gunboat Pinckney and the Venus. The possibility of such is regarded certain if Arias carries out these orders. Recently the Pinckney ordered the Venus not to bombard Bluefields and the Venus left that vicinity.

Sounds Campaign Keynote.

WASHINGTON, May 21.—Declaring the proposed tariff commission as merely a plan to postpone the people's verdict on the Payne-Aldrich tariff bill, and denouncing the encroachment of the executive upon the legislative branch of Government, Congressman Champ Clark today in the House, sounded the Democratic key note of the coming Congressional campaign. Clark said the proposed appropriation of a quarter of a million annually for the support of this commission was another desperate attempt to hoodwink the people. He

said the creation of such a commission would be another startling illustration of how far the legislative branch has surrendered to the executive branch. The power of Congress has steadily dwindled for a quarter of a century, while the legislative mounts to imperial and autocratic proportions. To the Republicans he shouted: "You will receive the bloodiest licking you have had since 1892, in the coming elections."

PRES. HILL AND PARTY ARRIVE THIS EVENING.

Met by a Large Party in Automobiles and Escorted to City—No Public Meeting.

President Louis W. Hill, of the Great Northern Railway system, who is touring Oregon with his party in the interest of the Hill lines in this state, will arrive here this evening from the south in automobiles. They left Medford this morning and passed through Grants Pass just before 11 a. m. A party of Roseburg citizens left here this afternoon in automobiles to meet them at Roberts hill, where a light lunch taken from here will be served. The party will spend tonight at the Hotel McClellan, where their rooms have been finely decorated with roses by the Ladies' Auxiliary. Mr. Hill has declined to be banqueted here—or anywhere else—on the remainder of his trip as the party is now hurrying through to meet important appointments in Portland. The public reception for the Hill party here has therefore been abandoned.

Saw Rogue River Valley. MEDFORD, Or., May 20.—A journey of 91 miles was taken by Louis W. Hill and party through the orchards of the Rogue River Valley today, and tonight the president of the Great Northern road was the guest of honor at a banquet given by the Medford citizens.

Special efforts at decorating the dining room at the hotel were made by the women of Medford and there was a great profusion of roses that had been grown in the valley. When informed here yesterday and today that President Allen of the Pacific & Eastern, now known as a Hill road, had been securing rights-of-way at Ashland and other points in the valley, Mr. Hill expressed surprise and said that it was the first he had heard of it.

He promised Ashland citizens to let them know later whether the Great Northern was interested or if it was a private enterprise of Mr. Allen. For the balance of the journey by automobile to Portland, Mr. Hill has declined invitations to banquets and side trips and other entertainments. Business matters are demanding his attention in St. Paul and he will proceed rapidly to Portland, seeking as much of the country as possible while following the main routes. It is expected that Portland will be reached Monday evening.

Too Much Conversation.

KLAMATH FALLS, May 20.—That an investigation be instituted by the next Oregon legislature of the procedure and work undertaken and accomplished by the Reclamation Bureau and Forestry Service in Oregon is a suggestion that is being made by President Louis W. Hill, of the Great Northern Railway, in the course of his addresses in Central and Western Oregon.

Mr. Hill declares that such an investigation would be more thorough and fairer than any hearing that has been or would be held in Washington, and that the results of the investigation could be made the basis of an effective remonstrance or memorial if the conditions were found to warrant it.

In his talks Mr. Hill has been pronounced in his criticism of the bureau of the Federal Government. In speaking to about 20 business men of Klamath Falls yesterday at a luncheon given at the farm of N. C. Merrill, south of this city, Mr. Hill said:

"I was disappointed this morning in not seeing the American flag floating over the Reclamation headquarters as we passed. The raising and

NORTH HAS TRIAL

First of 5 Local Option Cases Up This Afternoon

STATE'S DEFEAT PREDICTED

Reputation of Prosecuting Witnesses in Local Employ, Big Help to the Defense

It looked like civic wash day of the city of Eugene in the Circuit Court in Roseburg this afternoon, when Al North, proprietor of a soft drink house in this city, was placed on trial on a charge of selling two bottles of real beer to Franklin T. Plank, constable of Eugene. Next to Plank, the state's chief witnesses were Tom and O. B. Linn, also of Eugene. The questionable reputation of these three men was subjected to merciless grilling by the defense, and even the state's witnesses in this regard qualified their testimony in such a way that the prosecution lost ground.

At 3:15 o'clock this afternoon, District Attorney Brown began making the opening argument to the jury which is comprised of W. J. Kellner, A. L. Ady, L. T. Thompson, W. M. McGee, L. W. Chapin, W. R. Murray, Philip Dewey, J. A. Worthington, J. H. Grubbe, Frank Hopkins, H. E. Baker and B. R. Jones. As the big crowd of spectators filed out of the court room it was freely predicted that North would be acquitted. If such proves to be the case it will probably mean the dismissal of four other pending indictments charging violations of the local option law. North's attorneys are Elbert B. Hermann, of this city, and J. M. Pipes, city attorney of Eugene.

Plank's story on the witness stand was that Al North's brother, Ben North, sold him a bottle of real beer in the former's place of business on the 8th of last April. In the presence of the Linn brothers, who, it was alleged, also bought a bottle of beer, which they drank in the house. Plank said the bottle of beer he obtained was analyzed by Professor Shinn, of the chair of chemistry at the State University. Testifying on the witness stand, Professor Shinn said that the contents of the bottle contained 4.78 per cent alcohol, or 1.78 per cent above the maximum volume of temperance beer.

Ben North denied that he had ever sold Plank beer at any time, but that Plank and the Linn boys asked him repeatedly to get it for them. He said one of the trio explained to him that their presence in Roseburg was due to the convening of the Lane county grand jury in Eugene. This was substantially the story told on the witness stand by Al North. City Marshal Joe Huffman, I. Abraham, Geo. Kohlhaugen, City Recorder A. N. Orcutt and J. R. Lee all testified that North brothers, personally, and their place of business, bore the very best of reputations.

\$50 for Each Conviction.

On cross-examination, Plank stated that for the past two months he had been in the employ of the Roseburg branch of the Anti-Saloon League of Oregon. His contract with that organization, he said, was that he was to be paid \$50 for each conviction that he secured and his expenses in addition. In the event of failure to secure a conviction he was to receive his expenses only. To date, he said, he had been paid \$50 on his expense account. Regarding the Linn brothers' pay, he said he had an agreement to pay their expenses and give them two-thirds of every \$50 that he made on convictions.

Plank admitted that he had been indicted in Eugene on a charge of gambling, which charge, however, was dismissed at the alleged request of District Attorney Brown a week ago. Attorney Pipes endeavored to establish connection with this incident and the pending trial with reference to an immunity agreement, but Judge Hamilton intervened.

Attorney Pipes forced from Tom Linn the admission that the witnesses had been convicted of "boot-legging" in Eugene 2½ years ago. He asked him point-blank questions as to his honesty, associations and morality, and the hesitating manner in which Linn answered some of these queries could not have left a good impression on the jury. Linn's brother fared no better at the hands of Attorney Pipes, whose questions touched particularly upon the connection of the witness with a Lane county resort known as "Coney Island," which was pictured in uncomplimentary language. Pipes seemed to have the career of the Linn brothers, as well as that of Plank, at his finger ends and he never lost an opportunity to drive home a telling shot.

Charles Witnesses. Harry Graham, former night policeman of the city of Eugene, testified for the defense that the repu-

tation of the Linn boys and Plank was bad, so did J. M. Hartley, a cigar store keeper of that city, also O. Roberts, a dry goods merchant. In rebuttal, the state called three Eugeneites, E. J. Farrington, chief of Police; A. G. Pearce, a grocer, and J. J. Hartwell, an auctioneer. These witnesses, however, furnished material only for the defense.

Farrington said that Plank's reputation as to truth and veracity was good, but, in reply to a question put by Pipes as to his morality he said he "wouldn't call it first class," explaining that he meant that Plank was known in Eugene as an inveterate gambler. The Linn brothers, witness said, had a bad reputation. Pipes tried to draw from Farrington some information regarding an alleged attempt by Plank to levy blackmail, also a statement regarding his enforced relief from justice court work because of suspicion as to his integrity. Objections to both of these lines of cross-examination were sustained by the court.

Hartwell, like Farrington, upheld Plank's reputation as to truthfulness, but he admitted that his reputation as an officer was "not good." The Linn brothers, he said, had a bad reputation.

Pearce merely stated that he "never heard Plank's reputation discussed."

Frank Snodgrass, city marshal of Cottage Grove, said he never heard Plank's reputation as an officer questioned, but he had "heard that he gambled."

Other Cases. Judge Hamilton this morning overruled Attorney A. Abraham's motion for a new trial in the case of Edward (Strong Man) Morton, convicted of lewd cohabitation with Mrs. V. H. De Hart-Parker, whose arraignment on the joint indictment has not yet taken place. Morton has not yet received sentence.

After five minutes deliberation, a jury returned a verdict for the Southern Pacific Company in the case wherein J. Woodruff sued for \$530 damages for the loss of three horses, killed by a train last October on a railroad crossing, one-half mile north of Myrtle Creek.

DEATH BY STORM

Several States Report Heavy Loss of Property

COLORADO HAS SNOW STORM

Floods in Texas and a Tornado in Oklahoma Add to the Many Other Disasters

Special to the Evening Review.

DENVER, May 21.—Heavy snow is falling here today, following the severe wind storm which swept Southern Colorado, killing two persons and injuring several more, besides doing heavy damage to crops and property. At Ramah a flying beam killed the baby of Mrs. Edward Miller, who held the child in her arms when it was struck. John Ferguson, aged 46, when crawling through a barbed wire fence, was killed by lightning. Several houses were completely destroyed and many people took refuge in storm cellars.

Texas Storm Swept.

DALLAS, Texas, May 21.—Nearly every stream in Texas is flooded as a result of a two days' downpour of rain. The damage to crops is estimated at half a million dollars. At Middleton the 11-year-old son of J. L. Mouse was killed by lightning and three other persons were injured. Fifteen dwellings were destroyed at Sour Lake and the oil well derricks were blown down. At San Antonio crops were damaged and other losses are reported.

Fatalities in Oklahoma.

SHAWNEE, Okla., May 21.—A tornado which originated near Merty early last night swept that portion of the state with great severity. That village containing 100 inhabitants was destroyed, but only one person, Agnes Dewberry, aged 20, is known to have been killed. Many are reported injured at Marysville, Madril, Paul and elsewhere in Paul's Valley. Buildings were wrecked by the wind and livestock killed by the terrific hail. Wires are down but couriers report several people killed by the tornado. Relief expeditions left here today.

Houses Demolished.

HOUSTON, Texas, May 20.—Heavy windstorms on the coast last night and today blew down scores of houses and several substantial structures in a number of little towns. At Beaumont, oil derricks were overturned. One death by lightning is reported.

OREGON NEWS.

No married women will hereafter be employed as teachers in the public schools at Forest Grove. This is not because they have not done satisfactory work, but rather that the school board has decided to employ only unmarried women and widows. Women who make their own livelihood. The school board of directors has chosen the teaching staff for the coming school year and three married women were dropped.

For the first time a western college will make a practical study of the subject of forestry. The Oregon Agricultural College is taking the initiative in this matter and following in the footsteps of some of the great eastern colleges.

R. A. Booth, of Eugene, ex-State Senator, and for many years active in state Republican politics, has announced that he will not allow his name to be used in connection with the nomination for Governor. Many of Mr. Booth's friends have been urging him to make the race. E. L. Smith, of Hood River, who was a candidate for United States Senator in 1906, is now being mentioned as a possible candidate.

Mark Jones, aged 16, shot himself at Escadada, Friday, with a revolver he was cleaning. He lingered in agony five hours and then died before surgical aid could reach him.
