LAW VS. APPETITE

Can Vote State Dry, But Not People, Says Darrow

PROHIBITION NO SOLUTION

Wealthy Class Cannot be Deprived of Liquor—Declares Poverty Is Due to Monopolies

An audience that filled every seat and much of the standing room in the Roseburg armory on Thursday night listened to Clarence Darrow, the noted Chicago lawyer and political economist, who spoke on "The Liberties of man and the wrong of prohibition," under the auspices of the Greater Oregon Home Rule Association. Though his language was less polished, and having less pretension to eloquence, Mr. Darrow's discourse was as well received as the speech delivered here two weeks ago by his fellow campaigner, David S. Rose. His manner of talking was that which befitted him as a lawyer—a lawyer stating his case to a jury in a clear, dispassionate, logical way. Mr. Darrow was introduced by President McFadden of the local federated trades unions.

At times there were outcroppings of Socialistic principles in Mr. Darrow's remarks. This was particularly noticeable when he denounced the claim of the prohibitionists that drink was chiefly responsible for most of the poverty, crime and insanity. He declared that predatory corporations and commercial monopolies were responsible for nearly all human misery, either directly or indirectly, and when he asserted that these agencies would have to be first destroyed before social conditions could be improved he was greeted with the greatest outburst of applause of the evening.

Only once did the speaker soar up into the realm of oratory, and then when he asserted that the prohibitionists' lobbies in legislatures and in congress had done nothing to assist labor legislation. He simply gave Darrow a chance to get into his element. Dramatically he told the fight labor lobbyists had made in legislative bodies for legislation for safety appliances on the railroads and other remedial laws and reached a climax by saying:

"While these little lobbies were working in Washington and in the capital of every state, pleading for father and mother and wife and the little children, supported by the meager contributions sent from home, never once did a committee of prohibitionists raise a voice in behalf of the working man. But over in the other corner, in a dark corner, could be heard a hoarse voice whispering, 'Compromise on anything, no matter what it is, but give us prohibition.'"

Blue Laws Criticized.
"The prohibitionist does not believe in allowing man any of the pleasures of life," continued Darrow. "He does not believe in allowing a game of baseball on Sunday, he does not believe in playing cards, he does not believe in theaters being open on Sunday, he does not believe in going to a picnic on Sunday, he does not believe in giving us the pleasures that make life worth living. What would he leave us? Not one in a thousand of them believe in giving us anything that affords pleasure. Do they really believe in anything?"

State May Go Dry, But Not People.
"You are going to be called upon to vote the state 'dry.' You can probably vote the state 'dry,' but can you vote the people 'dry?' Somehow the Lord when he fashioned the universe and created man didn't understand the job as well as the prohibitionists understand it and he left mankind to stumble along and do the best he can. If the Lord had been given the ad-

vice of the prohibitionists it would have been much easier and saved us a lot of trouble. There wouldn't have been any wickedness in the world excepting prohibition. If anything went wrong all that would be needed would be to make another law and then you would make people right. If men drank too much make a law and then men won't drink too much. If they ate too much, make a law and then they won't eat too much. If they don't go to church make a law and then they will fill the churches. If they don't go to the right church make a law and head them in the direction of the right church. If a boy wants to have any fun on Sunday, or a man who works hard all the week wants to go to a picnic on Sunday make a law; then he won't go to the picnic, but will go to church.

"I don't believe in prohibition, but I am not a fanatic. If I had a chance to make the law I wouldn't compel a prohibitionist to drink a pint of beer every morning before breakfast. I think that would be carrying it too far, and I wouldn't pass a law to make him pour down his throat a glass of whiskey against his will.

Beer and High Prices.
"A man who talks to the poor man about getting rich by not drinking beer is insulting the poor man's intelligence, and he never read or studied anything himself in his life or he would have seen it. Now, the poor people, we will say, spend money for beer. Very few of them would spend one-tenth part of their wages for beer, but suppose they spend one-sixth or one-fifth. The food bill is a big bill, and I will undertake to say, as poor as the poor man is, there isn't one of them that doesn't waste three-fourths of the money he spends for food. So far as health and strength and ability to work are concerned, you waste three-fourths of the money you spend for food.

"Load your stomach up with pie and cake and liver and tea and coffee and see what is going to happen to you. You are shortening your life, and you only eat because it tastes good going down. You don't need butter on your bread; your ancestors didn't have it and your children won't have it either if you follow the prohibitionists in their theories. You waste money on your clothes; you don't need collars and neckties; they are purely ornamental. Women don't need furs and feathers and silks. They are ornamental. You can live in a cheaper house, you can save three-fourths of your money. Suppose you cut out meat and save half of your food bill.

Laborer Leads to Progress.
"There is one rule of life. If you give men opportunity, give them food and clothing and drink and sunlight and homes, they can look after their own morals, and they can't do it any other way. The whole theory of prohibition is wrong. If they get one thing they will want another. Today it is rum. Tomorrow it will be tobacco; next day it will be coffee. The theory is wrong; man can only progress by liberty. It has been a long and painful battle that the human race has fought. Every step has been inspired with the spirit of liberty. Take the ideal and dream of freedom from the human race and slowly and painfully it will go back to the brute creation from whence it came."

DARROW DECLINES DEBATE.
PORTLAND, Ore., Oct. 21.—Clarence Darrow of Chicago, is the last speaker of the Greater Oregon Home Rule Association to receive a challenge to debate the prohibition question. The challenge was made by J. P. Newell of the prohibitionists, on behalf of Mrs. Mary Harris ARMOR of Georgia. Mr. Newell's letter reads:

"Mrs. Mary Harris ARMOR of Georgia will deliver an address at the White Temple Sunday, October 23, at 3 p. m. in favor of prohibition. We would be very glad to have her divide the time with you at that meeting. If you do not feel disposed to discuss this question with her, we would be pleased to have you present in the audience and hear what this wonderful woman from Georgia has to say upon this question."

Mr. Darrow replied:
"Your kind letter inviting me to hear Mrs. ARMOR is received. I am leaving Oregon Saturday evening, and

for that reason will not be able to accept the invitation.

"If I were to be here I would prefer not to debate with Mrs. ARMOR, but I would certainly be glad to go and hear her. I have heard much of her ability and hope she will have a good audience, as no doubt she will. The important thing to my mind, in all these questions, is full and free discussion."

JUDGE JOHN S. COKE.

The following letter from District Attorney George M. Brown is self-explanatory:

Roseburg, Ore., Oct. 20, 1910.
Hon. A. P. Stearns, Oakland, Ore.:
My Dear Judge:—Referring to your inquiry concerning the laws creating three judgeships in the Second Judicial District and touching the ability and integrity of Hon. John S. Coke, I have this to say:

The Second Judicial District is the largest Judicial District in the State and comprises the counties of Benton, Lincoln, Lane, Douglas, Coos and Curry. The law provides for three Circuit Judges for this District.

The law further provides that the labors of these three judges may be divided as they may agree between themselves.

The law also provides that "One of said judges shall reside south of the Umpqua River and west of the Coast range of mountains during his term of office"; this provision is equivalent to saying that during his term of office one of the judges shall reside in Coos or Curry County, because these are the only two counties south of the Umpqua river and west of the Coast range of mountains.

While the law does not expressly state that one of the candidates shall be elected from Coos or Curry County, yet it is fair to assume that the spirit of the law contemplates that one of the judges elected shall, at the time of his election, be a resident of Coos or Curry County.

It is fair to the people of Coos and Curry County to elect one of their residents as Judge.

When the Legislature enacted the law creating the third judgeship of the Second Judicial District, the Governor of Oregon selected a resident of Coos county for the appointment. He appointed Hon. John S. Coke, who had been a resident of Coos county for more than thirty years; a law-

yer who had practiced his profession within the bounds of Coos county for nearly twenty years. After Judge Coke had been tried out as Circuit Judge, following his appointment in February, 1909, the people of Coos and Curry counties, by an overwhelming vote in the primary election, expressed a wish that Judge John S. Coke be elected as the Judge to reside in Coos or Curry county. The wishes of the people of the Coast counties should be respected. Personally, I have known Judge Coke for seventeen years, and know him to be a man of integrity, ability, learning, and he will make one of the best judges that ever presided in a Court of Justice within the State of Oregon.

The people who know him best admire him the most. You have a right to vote for two judges at the coming November election and one of your votes should be cast for Coke.

Senator Aldrich Found on Doorsteps, Cut and Bruised

REFUSES TO SAY ANYTHING

Rain Postpones Cub's Final Defeat—Inland Empire Farmers Ask New Wheat Rate

NEW YORK, Oct. 21.—Senator Nelson W. Aldrich of Rhode Island was reported at noon today to be rapidly recovering from injuries sustained in a manner that he will not divulge. At the corner of Madison avenue and Sixty-ninth street last night the senator was either knocked down by a vehicle or assaulted by an enemy.

Dr. Holbrook Curtis, the family physician, says that Senator Aldrich has a cut over the right eye and that both of his hands and his head and face are bruised. He expects him to be out in a few days. Aldrich refuses to state how he sustained his injuries. His family believes he was struck by a taxicab, but it is persistently rumored that he was murderously assaulted.

Senator Aldrich strolled from his home after dinner last evening. He had been gone only two minutes when he staggered back bleeding and disheveled and collapsed on the doorsteps.

Newspaper men scoured the district, but found no one who had witnessed the affair. Such clues as they secured led only to the Aldrich home, from which reporters were barred. His condition caused the gravest anxiety until it was learned that he was not internally injured.

Rain Postpones Game.

CHICAGO, Oct. 21.—The fourth game between the Cubs and Athletics was postponed today on account of rain, which has continued since last night. Chicago fans are discouraged on account of yesterday's third defeat, and it is admitted that the Athletics will probably win the series with four straight. It likewise means that there will be some changes in the Chicago team next year with an infusion of new blood.

Farmers Protest Rates.

WALLA WALLA, Wash., Oct. 21.—Hundreds of farmers, members of the Farmers' Union, met here today for the purpose of formulating demands for rate reductions on Inland Empire wheat consigned to the Coast or to the East over the Northern Pacific and Oregon Railroad & Navigation company's line. They will demand of railroad officials this afternoon the following reductions: From 8 to 10 cents from middle west and westward; slight reduction to the Coast; reduction of the O. R. & N. rate to Tacoma, making it equal to the Northern Pacific. President Crow of the union insists that the present rates are almost prohibitive.

Crippen Tells His Story.

LONDON, Oct. 21.—Dr. Hawley Crippen, the American dentist on trial for alleged wife murder, concluded his testimony today. Throughout the ordeal he remained calm and took Prosecutor Muir's fiery cross-examination almost philosophically. Muir's efforts to force Crippen to admit that none but himself could have buried the body in the cellar was a failure. "My wife and I were often away from the continent," said Crippen. "It would have been perfectly possible for some one to have placed the flesh where it was found. I have no idea whatever how the flesh came into the cellar; it's a great mystery."

Balloon Breaks Record.
GRAND RAPIDS, Mich., Oct. 21.—The world's record for sustained long distance flight has been broken by the balloon Helvetia, of Switzerland, which landed at St. Isador, Quebec. It traveled 1500 miles from St. Louis. The other two balloons are still unheard from.

GENERAL NEWS.

The Washington Supreme Court has upheld the constitutionality of the law passed by the legislature in 1907 which levies a \$35 annual tax upon all retailers who handle intoxicants, including druggists.

At Jackson, Ky., Thursday, Charles Little confessed the assassination of Matthew Crawford. He requested an immediate trial because of his fear of mob violence. Accordingly he was taken into court, sentenced to death by a jury, which was out six minutes, and then hurried to Lexington for safe keeping. Crawford's friends were at his funeral when this happened.

AFRAID OF MOONLIGHT.

The Reason Porto Ricans Carry Umbrellas at Night.

"The majority of Porto Ricans have instilled in them from earliest infancy a superstitious dread of the full moon rays," said a business man who has just returned from that country.

"It is a curious sight to the American visitor to note men and women going along the streets and highways of the island with umbrellas raised over their heads in the lone watches of the night, and the more brilliantly the moon is shining the greater will be the number of people who are thus protecting themselves from her beams. Out in the sequestered rural districts a gay mounted cavalier will be met at midnight, his bridle rein in one hand and an upraised umbrella in the other. It looks weird and also ridiculous, but the natives do it for a peculiar reason. They are possessed of the conviction that Luna's full light striking upon mortals is almost sure to make them mentally unbalanced—that is to say, lunatics—and that is why they interpose a shield between them and her dazzling brightness.

INVESTIGATING OREGON

SOIL AND CLIMATE

Prof. Thos. Shaw, formerly head of the Department of Agriculture of the state of Minnesota, and his son, Prof. Wm. T. Shaw of Pullman, Wash., were in Roseburg this morning on their tour of Oregon by automobile. The senior Mr. Shaw is the direct representative of James J. Hill and the Great Northern railroad, and he is investigating the soil and climatic conditions of this state on behalf of the publicity department of that great railway system. He is making special inquiry as to the possibilities of dairying, intensified farming and stock raising. The development of the country in numerous small tracts he deems an imperative necessity. That system will build up thousands of prosperous homes where very few now exist and will likewise multiply the country's products and material wealth. While he does not underestimate the great value of fruit-growing, he thinks the small dairy farms and producers of hogs, cattle and their products will be a still greater source of permanent wealth.

Under the direction of Mr. Hill 45 experimental or demonstration farms are now being conducted in the state of Montana and are proving of vast benefit to the farmers of that state. Prof. Shaw finds that such farms are greatly needed in Oregon and hinted that if proper effort was made Mr. Hill might be induced to inaugurate something of the kind here.

As to the building of Hill railroads in Oregon other than the Oregon Trunk, which is now under construction, Prof. Shaw stated that Mr. Hill did not confide to him his plans, but admitted that there were favorable indications. Prof. Shaw is evidently well pleased with the vast possibilities of Oregon. He departed for Eugene, Corvallis, Portland and the east, but will return to Oregon a few weeks later.
