**OREGON HOME RULE
ASSOCIATION PAVES
WAY FOR ELECTION.**

PORTLAND, Or., Oct. 21.—Let-
ters are being sent out today by the
Greater Oregon Home Rule Associa-
tion to the Mayors of practically all
the remaining dry towns and cities in
the state instructing them as to the
necessary lines of procedure in case
they desire to vote on prohibition at
the next general election. The cities
and towns are: Moro, Wallawa, Har-
risburg, Cottage Grove, Silverton,
Glendale, Roseburg, Sheridan and
Eugene.

In each case there must be a re-
adjustment of precinct lines to con-
form to the city boundary limits be-
fore another prohibition election can
be held. The voting precincts lie
partly in the country outside of the
city, and in the Joseph case, Judge
Moore, of the Supreme Court, de-
cided that in order to make future
Home Rule elections legal, they
would have to be conducted by the

city as a voting unit, and that the
precinct lines must coincide with the
city boundaries.

Under the original statutes, the
County Courts could only change
precinct lines at their July meeting
next preceding a general election, but
when the people's amendment was
passed changing the time of holding
elections, it is now possible for the
County Court to change these divid-
ing lines at their November meeting
next preceding a general election.
Therefore, if the cities named desire
to raise the wet or dry issue at the
next election, they must arrange with
the County Court in each county con-
cerned to have the lines readjusted
at the meetings which will be held
next month.

"The letters we are sending out,"
said Harry McAllister, general man-
ager of the Greater Oregon Home
Rule Association, today, "merely pave
the way for these cities to hold an
election if they care to. The associa-
tion is not in any sense forcing the
issue, but only acting in an advisory
capacity to these communities. At
the same time it stands ready at all
times to lend support and aid to any
city when so requested."

**MAYOR SANDERSON
AND EDITOR FIGHT
\$10 WORTH APPEAL.**

KLAMATH FALLS, Or., Oct. 20.

Mayor Fred T. Sanderson and Ed-
ward J. Murray, the latter the new
owner of the Morning Chronicle, met
in a hot fight in Main street this
morning, and as a result both were
escorted by Samuel L. Walker, the
Mayor's new appointee, who was con-
firmed by the council Monday night,
to the police court, where Police
Judge F. T. Nichols fined each man
\$10 on his pleading guilty.

The rift arose over the memory of
Walker's predecessor, the late Police
Chief Edward Townsend, whose body
was shipped away last week for
burial in Missouri. This morning's
Chronicle contained an article that
mentioned the late chief in a way
that aroused the Mayor's ire and
when Sanderson met Murray he took
him to task for the article. Murray

declared that the statement was just-
ified.
No serious damage was done to
either combatant aside from a few
facial scratches.
