MEXICANS RUN ABOUT AND THREATEN AMERICANS

Gen. Funston Asked to Recruit Infantry and Cavalry

MEXICAN SOLDIERS NOT SIGHTED

It Is Reported That the Mexicans at Ojinaga Are Assuming a Threatening Attitude—Scouts Patrolling Lines

SAN ANTONIO, June 21.—The War Department has wired General Funston to recruit four regiments of infantry and two of cavalry immediately for the regular service. Detailed instructions were mailed. Recruiting has already started. General Funston denied making a second appeal for the militia.

It is reported that the Mexicans at Ojinaga are assuming a threatening attitude. General Funston said they were "running around in circles bragging about what they intend to do." General Pershing still has a scout on both sides of the line. He found no Mexican detachments within reach of his lines anywhere.

Sheriff Salinas, of Laredo, issued a proclamation to Mexicans requesting them to report any persons attempting to foment revolts. He guaranteed protection for keeping the peace. Despite the proclamation the Mexicans continued to cross the border today.

INCREASE APPROPRIATION.
WASHINGTON, June 21.—The House this afternoon voted to increase the aeroplane appropriation from \$1,250,000 to \$2,000,000.

SUFFRAGE IS FAVORED.

WASHINGTON, June 21.—The President today interpreted the suffrage Democratic platform as an approval of the suffrage movement, but recommending that it have its inception by the states. He told the Virginia women that the plank did not necessarily disapprove of the Federal amendment idea.

FIREMAN WAS DROWNED.

PORTLAND, June 21.—When a steamer blew on the steamer Lurline burst William Moody, a fireman, planned into the river to escape the burning steam, and was drowned. One deckhand was injured.

ROBERT SMITH TALKED BEFORE TAXPAYERS AT EUGENE LAST NIGHT

EUGENE, June 21.—At a meeting of a number of taxpayers of Eugene at the Chamber of Commerce last night an initiative petition for a constitutional amendment was placed in circulation. This proposed amendment is similar to the Hingham law which prohibits the levying of a tax more than six per cent greater than the tax of the previous year in any county. City, school or bond district may propose to cover the entire state with this provision. In other words, after a county has spent as much in one year as it did the previous year, plus six per cent it will then have to raise its expenditures. Robert E. Smith, of Eugene, editor of the Tax Liberator, spoke at the meeting last night in favor of this amendment. He will return to Eugene about July 10 for the purpose of organizing a tax league.

INCREASE IN BOOZIE.

Although the affidavits have not been checked over by the district attorney's office, it was admitted this afternoon that they show an increase in booze shipments for the month of May when compared with the month of April. This is probably due, so the officers say, to the fact that many liquor shipments were received here during the Strawberry Carnival.

ENORMOUS PRUNE CROP.

Reports received from many sections at Douglas County indicate that this year's prune crop will be larger than for many seasons in the past. The weather has been good for prune growing, according to the growers, and prospects for a bumper yield were never better than at the present time.

FEDERAL BUILDING WILL BE STARTED JULY 1, SAYS CONTRACTOR IN LETTER

That work on the Roseburg Federal building will be started July 1, and that a large force of men will be employed until the structure is completed 18 months from that date, is the information contained in a letter received from Carl M. Stebinger, of the contracting firm of Stebinger Bros., of Portland, by local people this morning.

Mr. Stebinger also states that he hopes to have all the excavation completed by July 20, when he will commence to place the foundation. All the materials have been ordered and will be placed on the ground during the excavation work. Mr. Stebinger will be here in person when the work begins and he expects to remain for the greater part of the time during the construction.

Schedules for the various shipments of materials were set out in the letters received here this morning and, according to local parties, once the work is begun it will be rushed to completion with all vigor. The sand and gravel has been ordered from the Roseburg Sand & Gravel Company, and the hauling has already been contracted to the H. J. Deun Transfer Co.

TRANSFER GRANTED

Local Man Gets Permission To Join Company I.

ROSEBURG MEN WILLING TO GO

Officers Receive Formal Orders, Which Confirm Phone Message Last Sunday—Will Hold Usual Encampment.

With a formal transfer issued late yesterday by the state officials and signed today by Captain Buchanan, of the Fourth Company, Ralph Baldwin, private in the local artillery corps, left this afternoon for the Clackamas mobilization station to join Company I, of Woodburn, and probably leave some time this week with the Third Infantry of Oregon for the Mexican border.

Baldwin's application is the only one so far honored with transfers, although it is said there have been several ap. Baldwin expects to be with LeVoor Baldridge, also from Roseburg, who joined Company I yesterday. This company is one of the regular organizations of the Third Infantry and went into camp at Clackamas some time today. Both young men consider themselves fortunate in getting into the active ranks, as strenuous efforts are being made to hold all the local men here. They are especially glad for an opportunity to see Mexico.

The first drill of the local army since the mobilization of state troops was ordered will be held tomorrow night, and a large attendance is expected. It is also thought there may be several applications for membership. Nearly all of the boys have expressed themselves to their commanding officers as willing to go out of the state should the Roseburg organization be called.

The Roseburg company yesterday received the usual orders in regard to the annual summer encampment, and barring a possible call to the scene of real hostilities, two weeks will be sent to Fort Stevens in July in the regular artillery practice with the big guns of the coast. The exact dates are July 15 to 25.

Last night at the armory the non-commissioned officers held a meeting when it was decided to hold another picnic at Winchester on July 24, similar to the one two weeks ago. The men will march to the picnic grounds Monday evening, July 2, and after drill, supper and posting of guards, will spend the night in true military style sleeping on the ground. On Tuesday they will listen to a Fourth of July patriotic address and participate in a program of sports, featured by a ball game in the afternoon. Visitors are invited and refreshments will be served to all guests.

Hammond, of Eugene, commander of the artillery forces, which were practically the same as received over the phone from Adjutant-General White last Sunday. NAVAL BLOCKADE OF MEXICAN PORTS PROBABLE

Population of Mexico Said to Be Near Starvation

MILITIA HELD IN READINESS

It Is Probable That the Militia Will Be Enroute to the Mexican Border Before the End of the Week

WASHINGTON, June 21.—Secretary of War Baker will not order the militia to the border today because the mobilization is incomplete. They will doubtless be enroute before the end of the week. What states militia will be called first depends upon their readiness. Undoubtedly more than 20,000 soldiers are going.

The method of calling for volunteers has not been arranged. It will only be done when developments require it.

Reports that the administration intends to ask for a half million volunteers appear to be exaggerated.

An order for a naval blockade of Mexican ports is expected soon. Officials said it would be comparatively easy to bring about the blockade. As the population there is already near starvation, putting into effect a real blockade would mean further suffering; therefore the officials are determined to go slowly. Real action will not come for several weeks. The militiamen must become acclimated. It is expected that after they reach the border a period of waiting will follow, while Carranza is given a final chance.

CABINET IN SESSION.

MEXICO CITY, June 21.—Carranza and his cabinet met in special session this afternoon to consider the American note. They refused to see correspondents.

Miss Mabel Organ rendered a solo and the address of the evening was then delivered by Rev. J. K. Hume, of Glenbeith.

CANYONVILLE MAN IS DELIGHTED WITH TRIP THROUGH NORTHWEST

The Review last evening received the following letter from G. O. McGilvray, of Canyonville, who is enjoying an auto tour of Washington:

"As I promised an account of my trip I will drop you a few lines to let you know that we are enjoying our journey. We have already traveled about 175 miles. There have been a number of automobile accidents in Walla Walla, though we saw none on our trip. In two instances we saw cars which had been wrecked and subsequently destroyed by fire. Many people in Douglas County have the impression that the Columbia Highway is paved for 60 miles, or within three miles of Hood River. This is a mistake. The road is paved for a distance of 40 miles, and it is fine. The scenery along the road is beautiful. Before reaching The Dalles we traveled over a number of hills, one of which was seven miles in length. These hills are much like those in Douglas County. Enroute to The Dalles we burned out our brakes, which were rendered useless. Our emergency brake was in good condition, however, and this probably saved us as we sped down a steep hill at a lively pace. We have taken our time thus far, and at the time of writing this letter had been on the road six days. It was very hot when we arrived at Walla Walla, and we were treated to a genuine sand storm. Farmers here have just finished their first cutting of alfalfa. The second cutting will start in about two weeks."

PLANS FOR ROCK CREEK LINE MAY NOT BE COMPLETED FOR SEVERAL DAYS

The plans and specifications for the proposed railroad to Rock Creek, which is to be built by the city of Roseburg, will not be ready for bids for 10 days, according to City Engineer L. G. Hicks this morning.

Completion of the typewritten specifications, on which Miss Ethel Patrick, stenographer, has been engaged in the engineer's office for the past week, was expected this afternoon. This much of the work, however, according to the engineer, is only a small portion of that which must be finished before it can be submitted to the contractors. Throughout the work the possibility that other contractors than Mr. Kendall will also offer bids has been kept in mind, and every detail of the construction has been specified to that end.

In addition to the rewriting of the specifications, in which many changes were made during the conference here with Mr. Kendall last week, the engineer's force has also had to change many of the drawings, and the plans of some of the largest structures have not yet been started. Three bridges, one over the North Umpqua, 265 feet long, and two 50 foot bridges over Rock Creek, have not yet been definitely decided on as to the plan of construction, and there are also plans to be made for the water tank at Rock Creek, a roundhouse and other structures, numbering in all about seven, on which considerable figuring has to be done in order to determine the proper strength before they can be put on paper.

A depot at Rock Creek was included by Mr. Kendall, and Mr. Hicks today, and it is probable that the line will be operated from this point. The Southern Pacific depot at Roseburg will be used on the western end of the line, but a station will probably be built at the city limits and the dispatching from this end, to be done by telephone, will in all probability be handled at the sawmill plant. The roundhouse, the location of which may be provided near the mill also, was another suggestion recently made by Mr. Kendall.

The school board also canvassed the vote of the recent school election and found that R. L. Stephens was re-elected with 100 votes to his credit. One vote was cast for Attorney Charles F. Hopkins, probably by some person who wished to play a joke on the well known lawyer.

The school board also decided last night to make a slight change in the sewer connections at the school, in accordance with plans furnished by P. Manson White, the architect. The cost of this change will be nominal, according to members of the board.

WAS BIG CONVENTION

Attorney Albert Abraham Returned This Morning

IRVINE COBB AT CONVENTION

Attorney Abraham Says He Had the Opportunity of Meeting Many Prominent Men During Stay in Chicago

Attorney Albert Abraham, who went to Chicago a few weeks ago to attend the Republican National convention as a delegate from this district, returned here this morning. Enroute home he passed a few days at Portland, where he conferred with members of the state central committee regarding the Presidential campaign.

Mr. Abraham brought with him to Roseburg a photograph of the hall in which the convention is held. The photograph shows the delegates from the various states as well as the press boxes, galleries, speakers stand and chairs occupied by the alternates. The hall was occupied by about 14,000 people at the time the photograph was taken, although its seating capacity is 20,000. It was artistically decorated with American flags. Mr. Abraham also brought with him the official badges worn by the delegates to the Republican National convention, as well as those worn by the delegates attending the Progressive convention.

During his stay in Chicago Mr. Abraham had the pleasure of meeting Irvine S. Cobb, famous New York newspaper writer, as well as many other men of National prominence. Although it rained considerably during the days of the convention, Mr. Abraham says he enjoyed his sojourn in Chicago and it is said he was given the honor of being one of the representatives there from this district. The suffrage parade which was held in a downpour of rain, was one of the feature events in Chicago during the convention, according to Mr. Abraham. The women were dressed in white and carried American flags and other emblems appropriate to such an occasion. Mr. Abraham left Chicago a week ago last Sunday and arrived in Portland Saturday. There he remained until last evening, when he continued his journey to Roseburg. Mr. Abraham says many of the foremost men of the United States were present at the convention, and he had the pleasure of meeting a number of persons who are closely linked with the movement. Although the convention was held in Chicago's biggest hall, Mr. Abraham says the speakers could be heard without difficulty when not interrupted by applause or other confusion.

Mr. Abraham expects to place the photograph of the convention hall, together with samples of the badges worn by the delegates, in the show windows of the Red Cross Pharmacy where they will remain for several days.

AUSTRIANS RETREAT BEFORE THE RUSSIANS

Germans Make Forceful Attack South of Berryanbac

GERMAN PRISONERS ARE TAKEN

Six German Divisions With 120,000 Men Are Being Hurried Eastward to Check the Russian Offensive—Heavy Attacks

BERLIN, June 21.—Vienna dispatches today admitted that the Austrian right wing continues in rapid retreat before the Russians. A terrific force of Russian artillery is causing General Pflanzer to retire instead of sacrificing his men, as Vienna reported. He is expected shortly to make a stand. Four German divisions were rushed to the 30-mile front near Brody. The Russians opened a heavy attack there, evidently preparing to make a smash toward Lemberg.

Russian Advance Checked.
LONDON, June 21.—Six German divisions, comprising 120,000 men, are being hurried eastward to check the Russian advance, so Geneva dispatches declared. Two divisions are enroute to the Lutsk-Kovel front. The Austrians are counter-attacking vigorously on the northern flank of General Brusiloff's armies. The Russian advance is apparently checked temporarily.

Russians Pushed Back.
BERLIN, June 21.—The Russian left wing continues to push forward into Bukovina, but the right wing was halted, and even pushed back in some places, according to official statements. It was announced that the Russians who crossed the Styry River west of Kolk were driven back, the Germans taking 1000 prisoners.

Artillery Is Active.
PARIS, June 21.—Following the explosion of two mines, the Germans attacked south of Berryanbac, near Rheims. A screen of fire checked the assault. The artillery is active around Verdun, but the infantry made no gains.

Cabinet Has Resigned.
LONDON, June 21.—The Athens correspondent to the Central News called that the Greek cabinet has resigned under pressure by the allies. The official announcement is being withheld.

BIG CELEBRATION IS PLANNED AT RIDDLE; PROGRAM IS ARRANGED

RIDDLE, Or., June 21.—Plans are being made for a good old-fashioned Fourth of July celebration at Riddle. Instead of a morning parade and program, a baseball game between two valley teams will be played on the school grounds. At noon in the barbecue grounds a basket dinner will be eaten and in the afternoon there will be prizes offered for all kinds of sports. Rev. J. E. Anderson, pastor of the local Baptist Church, will direct the sports.

The Riddle Concert Band has been engaged to furnish music for the day.

The idea is to do away with the usual speechmaking and give people a real social good time.

ROSEBURG COLDEST.

According to William Bell, local weather observer, Roseburg was the coldest station on the Pacific Coast at 5 o'clock this morning. At that hour the thermometer registered 50 degrees above zero.
