MOHAIR POOL BRINGS 64 CENTS PER POUND.

The following clipping taken from the Oregonian would indicate that there is another class of farmers in Douglas county who need organization as well as the pruned men: Lebanon, Or., May 17.—The Lebanon mohair pool of 9000 pounds sold at auction this afternoon to M. Sanders & Co., of Albany, at 64 cents. This is the highest price ever paid for any pool of mohair sold this season and is 3 1/2 cents above the price paid for the pool here last year.

Sixty cents per pound is the highest price that any of the local mohair men have received for their clip this year, and according to County Agent Hurd the clip in this county is one of the largest in the state and the quality produced here is not excelled by any other section.

Automobile Is Stolen.

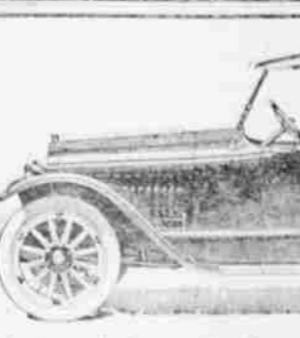

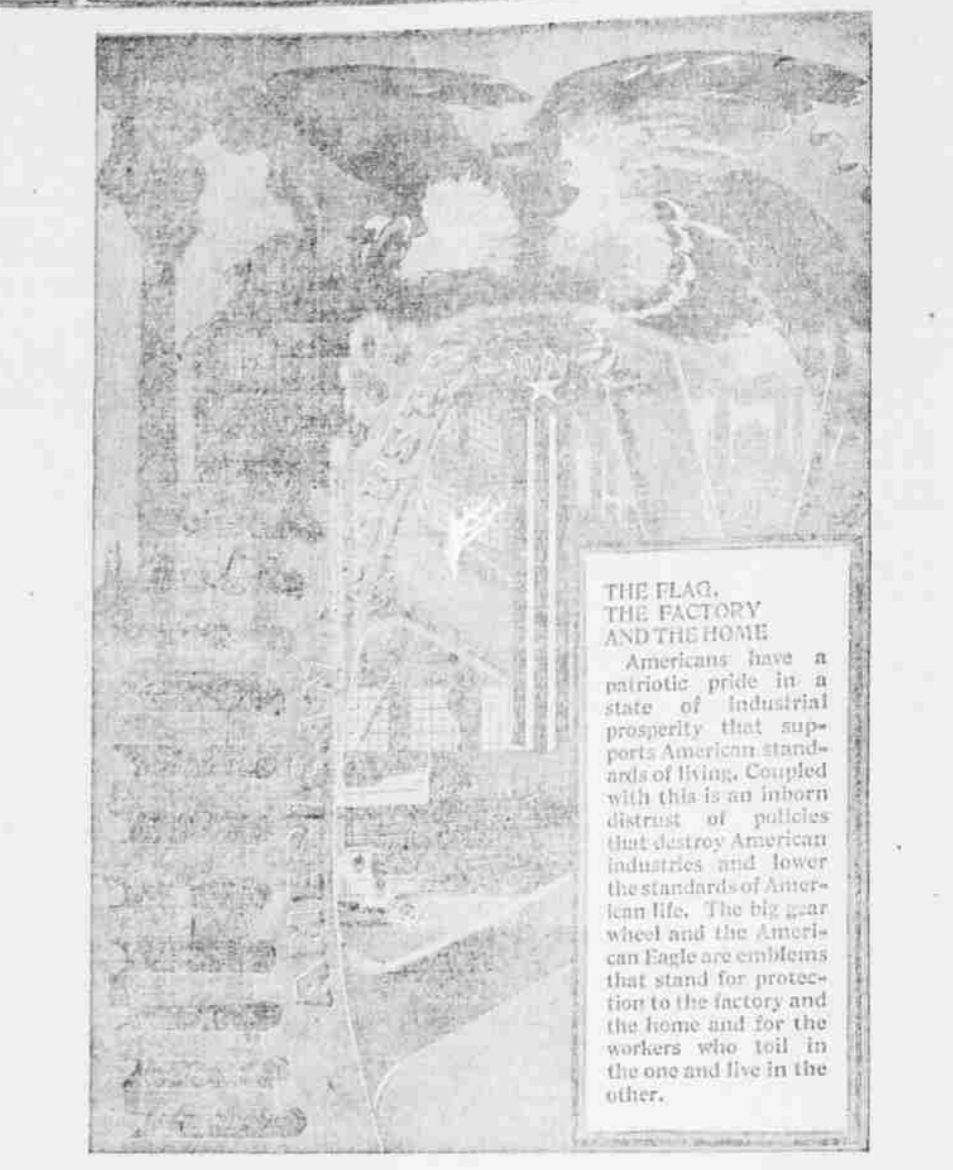
