EDITOR KILLED IN DUEL

MONTEVIDEO, April 3.—Political excitement prevails here today as the result of the death of Warrington Beltrán, editor of the El País, in a duel with the former president, Jose Batlle Y. Ordóñez, yesterday morning. After the last elections in Uruguay, the Nationalists accused the "Batlist" party headed by the former president, of fraud. Beltrán's newspaper in an editorial called Batlle the "champion of fraud." The utterance led to a duel. Batlle, who was twice president of Uruguay who is now a member of the national administration council, voluntarily gave himself up to the police and is being held incommunicado.

Claimed Boss Wiper Robbed Caboosees

P. S. Spinas, boss wiper at the S. P. roundhouse was arrested last evening by Detective Frank Rogers, charged with robbery from caboosees. According to the story told by Mr. Rogers, the train crews have been complaining for some time of missing various articles from the cabooses. Razors, articles of clothing, flashlamps, and other such articles were frequently taken and in order to stop the thievery the detective last night procured the assistance of the night storekeeper, Tom McCarthy and laid a trap for the man. He left his fine revolver lying in one of the cabooses and then took a position nearby. Spinas to whom is entrusted the task of supplying the cabooses with coal soon entered with a helper and upon leaving was accosted by the detective who stated that he found the revolver in the wiper's pocket. The man was lodged in the city jail and will be arraigned late this afternoon. It is claimed that he has induced others to assist him in his nefarious business and other arrests are expected to follow.

Are Bound Over To Grand Jury

Jack Denny and Frank Haddon, who were brought to this city yesterday afternoon charged with burglary of a Glendale store were arraigned in the justice court yesterday evening and after waiving examination were bound over to the grand jury under \$1,000 bonds. Being unable to furnish the money they were lodged in the county jail.

SHEEP AND GOAT MEN ORGANIZE

Officers of New Association Elected at Meeting Yesterday Afternoon.

COOPERATION IS AIM

Executive Committee Enters Upon Duties at Once and Will Improve the Quality of Herds in Douglas County.

The sheep and goat raisers of Douglas county formed an organization Friday afternoon with Loyal V. Emery as president, B. F. Nichols, vice-president, C. J. Hurd, secretary and C. E. Flanning, treasurer, and Remick Fite, Will L. Dixon, A. F. Bemis, L. L. Wells and J. G. Barnes as members of the executive committee.

The meeting was enthusiastic from the beginning. The following are the objects of the organization as declared by the constitution and by-laws: to promote the breeding and improvement of the sheep and goat herds; to improve the quality of the wool, mutton and mohair; to render mutual assistance in the protection of the flocks from the depredations of coyotes and other predatory animals; to disseminate information that is of vital interest to the sheep and goat industry of Douglas county.

The executive committee met immediately after the adjournment of the general meeting and instructed the secretary to send a circular letter to all raisers of sheep and goats in the county and ask them to send him a list of the purebred rams and billies needed for the coming year, also to send in a list of any sheep and goats that they have for sale.

The executive committee is planning a series of meetings to be held throughout the county and it is hoped within the next few weeks to secure every sheep and goat raiser in the county as a member of the organization.

Mr. O. M. Nelson of the Animal Husbandry department of the Agricultural College and Mr. Paul Mehl of the Bureau of Markets were present and rendered valuable assistance in the forming of the organization.

It is hoped to extend this organization in all other counties of the state.

Hon. O. P. Coshaw Appointed Director

O. P. Coshaw, of Roseburg, has been appointed campaign director for Douglas county for the united simultaneous campaign under the direction of the Interchurch World Movement, which will run from April 25 to May 2. Denominational county directors for the denominations participating in the campaign have been appointed, as follows: Baptist New World Movement, B. W. Strong, Roseburg; Presbyterian New World Movement, B. S. Nichols, Roseburg.

The drive plans call for a large organization in this county, including committees from each denomination under the direction of the denominational campaign directors, and a citizens' committee, headed by the united campaign director.

The denominational and interchurch quotas for the county have not yet been announced. They are to be apportioned from the total of \$346,777.572, which comprises all denominational and interchurch askings for 1920. The interchurch receipts, above campaign expenses, are to be prorated among the denominations. The askings are all based on budgets which were arrived at upon information secured by the national and foreign surveys of the Interchurch World Movement.

MICHIGAN TO HOLD ELECTION MONDAY

Preference of Voters Will be Expressed at Primary For Which State Is Prepared.

IS ON TWO TICKETS

Herbert Hoover Will Appear on Both Republican and Democratic Ballot Because of Double Filing.

DETROIT, Mich., April 3.—The preference of Michigan Republicans and Democrats for presidential nominees will be registered next Monday in the state's second presidential preference primary.

Republicans have a field of seven to choose from, while the Democrats have entered five in the lists. Two of the latter, William J. Bryan and William G. McAdoo, made unsuccessful efforts to have their names removed from the ballots. Withdrawal after certification, however, is not permitted under the state election laws, and the two names remained on the ballots.

An unusual situation results from the fact that the name of Herbert Hoover appears on both republican and democratic tickets. The double filing for the former food administrator was made possible when the state's attorney general ruled inoperative, as applied to the presidential primary, the amendment passed by the last legislature requiring from candidates an affidavit of party affiliation.

The republican ticket comprises Senators Poindexter, of Washington, and Johnson of California; General Pershing, Major General Leonard Wood, Governor Lowden, of Illinois; Mr. Hoover and William G. Simpson, of Detroit.

On the democratic ticket headed by Mr. Hoover, Mr. McAdoo and Mr. Bryan, are Governor Edward I. Edwards of New Jersey, and Attorney General Palmer.

Eugene V. Debs, of Indiana, is the sole candidate on the socialist ticket.

How far the preference of the voters expressed in the primary will be regarded as binding upon the delegates Michigan will send to each national convention is a matter of speculation. No provision is made in the primary law binding the delegation to the primary expression and the state's representatives at the convention may, if they so choose, swing their weight to another candidate after the first ballot is cast.

Vicious campaigns conducted by several of the leading candidates and the fact that in many cities and towns important local issues are to come up at the same time is expected to bring out a large vote this year. Bidding houses are to be balloted upon in many communities.

The heavy vote will be brought out in Detroit is regarded as a foregone conclusion. Here a street railway bond issue is expected to overshadow the interest in the presidential primary. The proposal is to bond the city for \$15,000,000 which is to establish a municipal owned traction system to compete with the present Detroit United Railway. A hot campaign has been made on this proposition, Mayor James C. Connelley, its sponsor, personally speaking at a score of meetings, and the editorial columns of the newspapers making strong arguments on the issue.

Griffith production at the Antlers Theater last night. "The Girl Who Stayed at Home" is one of the latest and best of the Griffith war pictures and portrays graphically the trials which beset a girl at home who is trying to remain true to her soldier boy "over there." Cate Blanchett, one of the girls who stayed at home, although partly sincere, and part sentiment, was the "Gilly Peril" with her killing slash gave one of the best character portrayals of his career. The picture as a whole was most unusual and entertaining.

ROOSEVELT SHOWN IN DIPLOMATIC ROLE

Letters Show Great American Held German Emperor Under His Power.

ACCOUNT IN SCRIBNERS

Letter Published by Roosevelt's Biographer Shows Former President, Now Deceased, in Entirely New Light.

NEW YORK, April 2.—Colonel Roosevelt's is shown in the role of a diplomatic letter writer to European royalties, bending even former Emperor William of Germany to his will, in freshly disclosed correspondence edited by Joseph Buckin Bishop, the late president's biographer, which will appear in the April issue of Scribner's magazine.

The correspondence includes letters to and replies from King Edward, Emperor Nicholas of Russia, the Emperor of Japan, Albert, King of the Belgians, and Queen Elizabeth of Rumania, in addition to the lengthy epistles that passed between the colonel and the head of the Hohenzollerns. Writing on August 14, 1906 to Henry White, who was then American ambassador at Rome, Colonel Roosevelt said:

"My course with him (Emperor William) during the last five years has been uniform. I admire him, respect him and like him. I think him a big man, and on the whole a good man; but I think his international and indeed his personal attitude one of intense egotism. I have always been most polite with him, have done my best to avoid our taking any attitude which could possibly give him legitimate offense, and have endeavored to show him that I was sincerely friendly to him and to Germany. Moreover, where I have forced him to give way I have been sedulously anxious to build a bridge of gold for him, and to give him the satisfaction of feeling that his dignity and reputation in the face of the world were safe.

"In other words, where I have had to take part of the kernel from him, I have been anxious that he should have all the shell possible, and have the shell painted any way he wished. At the same time I have had to speak with express emphasis to him on more than one occasion, and on one occasion (that of Venezuela) have had to make a display of force and to convince him definitely that I would use the force if necessary."

Mr. Bishop declares that in spite of the Venezuela incident of December, 1902, which must have been "a humiliating check," the former emperor cherished no resentment and subsequently wrote Roosevelt the most friendly letters. He also sent the colonel a number of photographs showing himself and Roosevelt astride magnificent horses at a manege of the German army. On the autographed photographs he had written: "The Colonel of the Rough Riders lecturing the Chief of the German Army." "Total agreement about the general maxims of life and policy between America and Germany." "On the Muhlentberg: A grave discussion: Carnegie looks out!" and "The Chief of the German Army thanking the Colonel of the Rough Riders for the honor of inspecting his troops." Mr. Carnegie, by the way, once had credited a rumor that Germany was building a strong fleet to attack the United States.

A letter the colonel wrote to Edward VII of England on April 25, 1906, contains a reference to the Algeiras conference of that year, an international party which at that time was said to have covered a general secret history of the conference, which stands revealed in Roosevelt's correspondence and which is far too long for publication in the magazine, shows conclusively that it was arranged by Roosevelt at the insistence of request of the Kaiser that Roosevelt draw up the terms of settlement which were adopted, and that he fairly compelled the Kaiser to give his unwilling consent to them.

Roosevelt's impatience with the ceremonies and etiquette of courts found vicious expression, Mr. Bishop says, when he exclaimed, after describing his experiences with potentates of various kindoms at the funeral of King Edward, at which he represented the United States: "I felt if I met another king I should bite him!" Amused and irritated by the funny anxiety displayed by the ruler of a petty kingdom about his prerogatives and the precedents to which he was entitled, Roosevelt, at another time said, drawing upon his bird lore for a simile: "He is nothing but a twittering wagtail."

Writing again to King Edward of England, for whom he professed a high regard, he said in 1903: "I feel very strongly that the real interests of the English-speaking peoples are

one, alike in the Atlantic and the Pacific; and that, while scrupulously careful neither to insult nor to injure others we should yet make it evident that we are ready and able to hold our own."

MEETING OF FIRE DEPARTMENT.

An enthusiastic meeting of the local fire department was held at the city hall last night. After considerable discussion it was voted to consider the taking over of the Strawberry Carnival and a committee composed of C. W. Parrott, James Fletcher and Jess Hicks was appointed to meet with the Chamber of Commerce and discuss the plans. Charles W. Parrott, who has been a member of the department for about 40 years, tendered his resignation because of his inability to give further active service. The boys refused to accept his resignation and gave him an honorary membership by a unanimous vote. Mr. Parrott is the oldest member of the department and his loyalty is appreciated not only by the firemen but by all the citizens of the city. It was also voted to allow the secretary of the organization the sum of \$5 per month to pay him for his time in attending to the duties incident with his position.

RED CROSS NURSE HERE FROM SEATTLE

Miss Margaret E. Durkin Confers With Local Red Cross Chapter Members.

ESTABLISH INSTRUCTOR

Miss Durkin Is Interested in the Establishing Here of a Hygiene Instructor to Have Classes of Girls and Mothers.

With the object in view of aiding in the establishing in Douglas county of a public health nurse or a part time instructor in hygiene, Miss Margaret Durkin, director of the bureau of instruction, nursing department of the northwest division of the American Red Cross, is in the city from her headquarters in Seattle today. Miss Durkin is attired in the regulation Red Cross service uniform and wears an American Legion button, having served in the navy during the world war.

The department of public health nursing which Miss Durkin is especially interested in is the installing of an experienced nurse as an instructor, who will give her whole time to the children and their mothers, with regular high school classes and outside ones as well. This could either supplement or precede the work of a public health nurse, and is especially excellent in preparing the way for one. The course which is offered under this instruction comprises fifteen lessons and is a particular stress on the prevention of disease and the preparing of the mothers and daughters in the home to properly care for their family in case of illness.

Miss Durkin was herself a public health nurse for 19 years and has a wide knowledge of the actual work which they accomplish in the community. This campaign by the bureau of instruction is an important part of the peace time work of the American Red Cross. They already have 35 instructors in the field, three of which are in Alaska. The Red Cross feel that they have learned a lesson from the recent epidemics and with this instruction will endeavor to do away with the same attendant upon most people when the sickness comes and they are unable to secure a nurse. By teaching them the simple rules of care of the sick, and how to recognize symptoms, they will then be able to cope with the situation themselves until a doctor or nurse can be secured.

Many counties, under their local chapter of the Red Cross, are employing a hygiene instructor. Some of the chapters charge the individuals for the services of the nurses, and some only for the text books used. The bureau also is willing to appoint some one already living in the community as an instructor, if possible, on capable, and with time to devote to it can be found. Miss Durkin is taking the matter up with C. S. Reineke today, and with other members of the Red Cross and it is possible that a meeting will be called to determine if anything will be done at the present time.

Some Congestion At Post Office

Owing to the illness of several of the clerks at the local post office, matters there at the present time are somewhat congested and according to Postmaster Reizenstein will remain so for several days longer. Mr. Keister has been ill for the past three months, and will not be able to return to work for some time as yet. Donald H. Gilts is also seriously ill at his home. It has been necessary to carry an extra substitute carrier for parcel post delivery. John L. Saunders, while the regular substitute has been transferred to the position of regular carrier in the place of Earl Parker, who is at present taking a vacation.

EQUIPMENT IS MOVED.

The moving of the equipment of the Review establishment to the new quarters in the office of the News-Review was started this morning and the first instalment of the former establishment was placed in position this afternoon and will be ready for operation this evening. All of the equipment will be moved during the coming week and the consolidated plant will soon be under one roof in the building occupied by the News. Additional floor space has been secured in the adjoining building and as soon as the installation of machinery is completed, the News-Review will send any newspaper in the state outside of Portland. The enormous circulation of the combined publication will cover Douglas county "like a blanket."
