Stating the purpose of miracles by Christ and His apostles under the first commission, I then took up MK. 16:17-20, Heb. 2:2-4, Ac. 8:14-17, Ac. 19:6, with several others, showing that the New Testament, by miracles, Heb. 2:2, 4, MK. 16:20, and when thus confirmed, ceased. Prof. Gal. 3:15 I Cor. 13:21, 13:8-12, Eph. 4:11-15, II Tim. 3:16, 17. Miracles were in part, I Cor. 13:8-11. Editor News-Review: In a recent edition of your paper a respondent from Looking Glass, signing himself or herself, "XX," seems to be quite peeved over the fact that the South Deer Creek Grange has asked the various candidates for the legislature concerning legislation that vitally affects the farmers of Oregon, and also seems to think that the proper place for the state capital is in South Deer Creek valley.

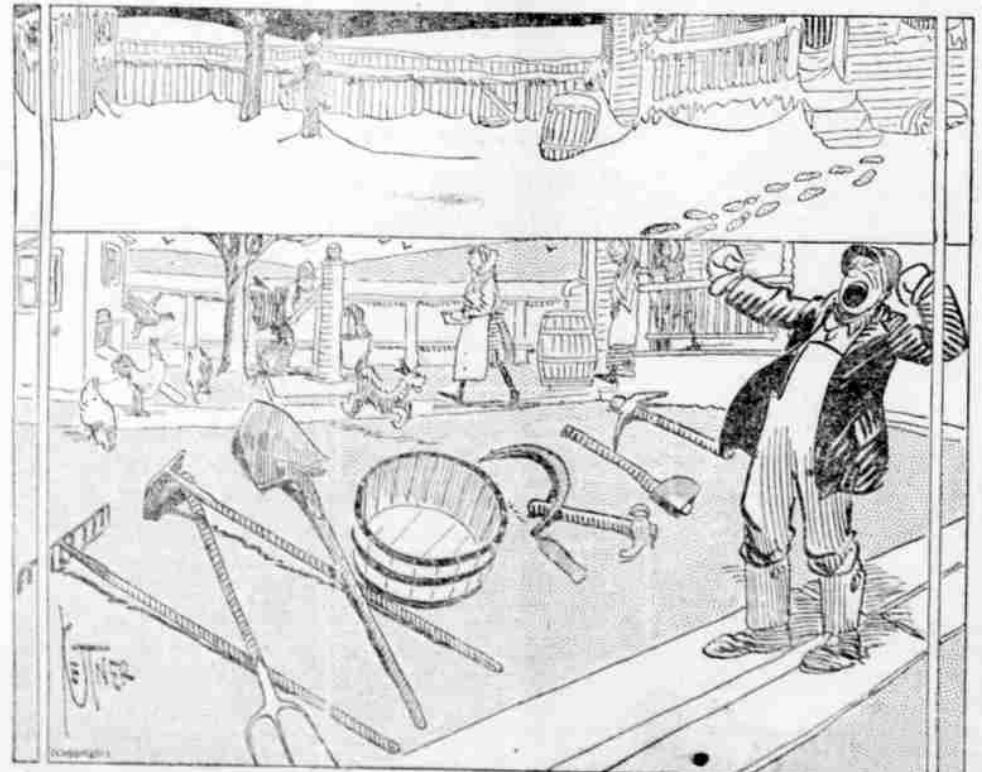
