FORMER MINISTER NOW MOONSHINER

Lane County Sheriff Finds A
Still Above Cottage Grove
Wednesday Afternoon.

CAUGHT WITH GOODS

Officers Make Arrest as Moonshiner -
Daughter Admits Warning -
Situation Was Quite Dramatic, Says the Story.

EUGENE, Or., May 13.—Another moonshiner still was captured by Sheriff Fred G. Stickles and Deputy Sheriff George Croner yesterday afternoon and the owner of the outfit, M. F. Green, a former minister of the gospel, aged about 65 years, is in the county jail.

An odd feature of the arrest of Green and the capture of the still is that the officers slipped up to the residence and standing on the outside beneath a window heard Green and his daughter talking of the still, the daughter pleading with Green to get rid of it as she feared that the officers would soon make a raid on the house as they had done so on a neighbor's place a few miles up the road the day before.

Woman Feared Raid.

Sheriff Stickles and Deputy Croner left Eugene yesterday afternoon about 2:30 o'clock. They arrived at the Green residence about supper time. Green arrived home from a nearby sawmill where he is employed. As the officers approached the house they could hear Green and the young woman talking, and stepping up close to a window, they heard the latter exclaim: "My God, Dad, if you don't get rid of that still, and they catch me I will go crazy." Green was heard to admonish her not to worry, and it was at that point that Stickles and Croner walked into the room where the couple were talking. Sheriff Stickles said it was one of the funniest experiences of his life to see the expression on their faces. "We are after your still," demanded the sheriff. "If you don't show me where it is I'll find it and if you do it will probably go easier with you."

Green Hesitated and Finally Said

Green hesitated and finally said he would take the sheriff at his word and showed the officers where the outfit was kept. The still consisted of a large copper boiler, a coil and the paraphernalia that usually goes with a complete outfit. The old man also had half a gallon of moonshine. Later on Sheriff Stickles discovered a secret lock to a room adjoining the woodshed and found another complete still in there, but Green said it belongs to someone else, but refused to divulge the name of the owner.

Woman Hysterical.

The young woman and Green were bundled into the officers' car and Green was brought to Eugene while the woman, in hysterics and crying all the way, was left at Cottage Grove.

The Green place is six miles above Cottage Grove and 200 yards off the road to Landon Springs. Sheriff Stickles said last night, and it is ideally situated for the operation of a still, with a clear stream of water running from the hillside into the yard and the water piped to the house.

Ardee Geer, aged 18, is the confessed owner of the still captured further up the Landon Springs road by the officers Tuesday. He was arrested yesterday by Deputy Sheriff Green Pitcher and brought to Eugene. He was fined \$100 in Justice of the Peace Wells' court and is now in the county jail, being unable to pay the fine.

Of Oregon's women voters, Mrs. Kemp holds high rank. She always has taken an active interest in women's affairs of the state and fought hard for suffrage in Oregon, working directly under the direction of the late Mrs. Dunaway, sister of the late Harvey Seel, long editor of the Oregonian.

Mrs. Kemp came in close touch with the former food administrator and believes the former Oregon boy could make the ideal constructive president and to this end she is touring north in his behalf.
