Grocers Must Obey Fixed Priced Sugar

PORTLAND, May 22.—No longer will the plea of ignorance of the law be accepted from grocers who exact more than the fixed fair price for sugar, according to announcement yesterday by Hall S. Lusk, chief assistant United States attorney, who is temporarily fair price commissioner for Oregon.

"I want to repeat that grocers or dealers in sugar who exact a profit greater than 2 cents a pound are considered by the department of justice to be profiteering and are liable to indictment under the Lever food control act," he said.

Mr. Lusk said investigation recently has shown that one dealer purchased sugar for \$18.45 a sack and sold it for \$25 because the price in the meantime had advanced from \$18.45 to \$22. After being haled before the prosecuting attorney this man agreed to refund to the purchaser all profit taken in excess of the legal 2 cents a pound.

"The margin of 2 cents a pound fixed by the attorney-general as the only profit on sugar which the department recognizes as lawful, is the largest margin that grocers have ever, in the history of their business, charged, and it is utterly unjustifiable in any merchant to take advantage of the recent advances in the price of this necessity by exacting a profit based not upon the amount which he paid for the sugar, but on a market price which he has not paid," is the ruling of Mr. Lusk.

NIGHT TRAIN TO MARSHFIELD.

General Passenger Agent John M. Scott, who spent Friday in this city, has just returned from Coos Bay, where he went for the purpose of establishing a new night train into that section. The residents of Coos Bay have been trying to secure the train for several years and it was thought at the present time that the travel warranted its institution. The train will run three times each week, and according to Mr. Scott will carry two sleepers, the one which was put on the first night found not to be enough to carry the traffic.

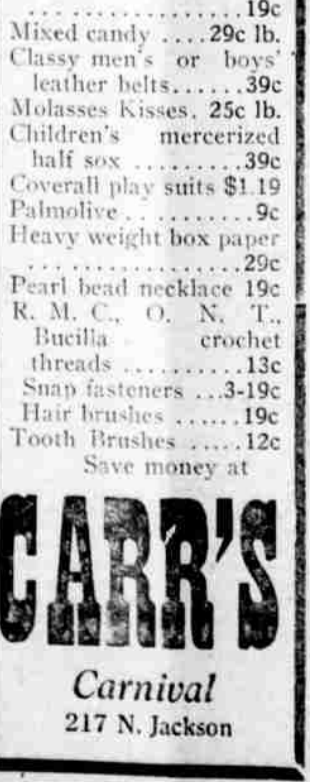

PHILADELPHIA, May 22.—Grover Cleveland Bergdoll, the wealthy draft dodger, who escaped from non-commissioned army officers at his mother's home here yesterday in a high-powered motor car, was still at liberty today. Both federal and city authorities said that an all night search had failed to reveal even the direction in which he went. Department of justice agents declared they were convinced that Bergdoll was aided in his escape.
