

# EMINENT LECTURER VISITING HERE

Will Give Double Series of Talks In This City.

## HAVE BOOK PUBLISHED

Four Talks Will Be Given From First Four Sermons in Book—One Series at Presb. Church the Other at Court House.

Dr. Louis Albert Banks, the eminent and well known lecturer and writer, is spending his vacation in this city at the J. C. Aiken residence and has been secured by the preachers of this city to give various sermons at different dates during his stay. Dr. Banks is from Boston and has visited here on numerous occasions, securing many friends who admire him for his brilliance and intellect as well as for his genial personality. Dr. Banks is a lecturer in Boston with the Anti-Saloon League.

Dr. Banks has written recently a book of sermons, which is to be published in the autumn by the Funk and Wagnall Company, and will give several of the sermons from his book in this city.

Dr. Banks will give a series of four talks in the Presbyterian church beginning Sunday morning July 18th. These talks will be the first four sermons of his book, and are called the "Four Winds of God." On Sunday morning July 18th, he will speak on "The East Wind," the wind that drives the soul to God. On July 25th, will be "The North Wind," the wind that purifies character. On August 1st, "The West Wind," the wind that inspires growth and fertility. And the closing sermon will be given on August 8th, on "The South Wind," the wind that brings peace and charm.

These four talks will all be given at the Presbyterian church in the morning, and will in no way conflict with his evening talks which will begin on July 25th, and be given for four consecutive nights. These evening talks will commence the week following the close of Chautauqua, and will be given in the open air on the court house lawn. They will be public, and all of the churches of the city have agreed to give up their services for those evenings.

The first sermon in the series of four for the evenings, will be the "Pioneer" sermon. Dr. Banks is well qualified for just such a sermon, having descended from a hardy race of pioneers, of which his own parents were excellent exponents.

In Dr. Banks is embodied much of the spirit of the pioneers, and he has condensed much of this into his pioneer sermon. Each of his series of sermons will be given, as series, and will be much more enjoyed if they began with the first, and none are missed.

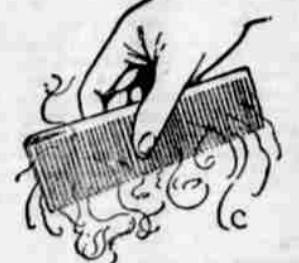
## Unthinking Tourists To Be Punished

parture and his method of travel noted. In his own automobile, the state number of the machine is recorded. With such information available conversations like the following sometimes are heard over the park telephone system:

"Hello, hello. In this the north entrance? All right, Chief Ranger's office speaking. John Q. Blank, traveling in automobile with State license No. 12345, wrote his name yesterday in Old Faithful basin."

Hold him when the car checks out."

And when the automobile arrives at the north gate, or any other of the parks four entrances, Mr. Blank—or Mrs. Blank or Miss Blank if they should offend—for women are not exempt—is fetched back to headquarters and told politely but firmly that such vandalism will not be tolerated. If he—or she—is willing to remedy the damage by affixing the writing, the incident may be allowed to end there. Otherwise the law takes its course before a United States Commissioner resident in the park. Heavy penalties are provided by statute for injuring the formation in any way.

In all justice to American tourists, however, Yellowstone officials say they have a minimum of difficulty in enforcing the regulations.

## Farm Implements To Be Demonstrated

A public demonstration of tractors, plows and other farm machinery will be held at the Fred Verrell ranch in Edenhower on Monday, and Tuesday July 19 and 20. This demonstration is being put on under the auspices of the C. A. Lockwood Motor Company of this city and representatives of various large implement manufacturing companies will be present. Among the companies to be represented are the Oliver Chilled Plow Co. of South Bend, Indiana, The Roderick Loan Manufacturing Co. of Springfield, Ohio, the Ford Motor Co. of Detroit, Mich., and the Anaco Drills Co. of Springfield, O.

Authorities on tractors, farm implements, soils and crops will be present for the purpose of answering any questions the farmers and growers may desire to ask. This will be one of the biggest demonstrations of the kind ever held in the county and a great number of farmers are expected to be present. All of the demonstrators are free and growers are urged to ask questions of the specialists who will be present. The following implements are to be demonstrated: Four tractors, No. 3 Sulky plow, No. D-42 Disc plow, R. L. Disk harrow, Spike tooth harrow, Cultipacker with a trailer attachment, Anaco Drill, and stationary power machinery.

# FILIPINOS WANT INDEPENDENCE

Maximo M. Kalaw Declares U. S. Cannot Consistently Refuse "Self-Determination."

"When they show sufficient capacity. "When they are able to govern themselves." "When they are educated enough." Thus run the answers to the question as to when the Filipinos should be granted their independence. Now "ability," "capacity" and "sufficient education"—What do they mean in black and white?

Senator Shogun may think no people is capable of self-government that does not establish the judicial recall, or that has no Billy Sunday. John Smith of Somerville may think no people is capable of self-government that does not vote his democratic ticket, or go to church on Sundays.

"Capacity for self-government" is as broad and elastic as the world, and if that should be the criterion for the granting of Philippine independence, America might as well say to the Filipinos, "I will give you independence when it pleases me to do so."

Fortunately, the American promise to the Philippines is not based on such obscure and abstract conditions. It is based on a definite, tangible thing. When America, through her Congress, officially told the Filipino people that they would be granted their independence as soon as they could establish a stable government, no abstract or obscure condition was meant. Stable government, according to American usage, means a certain, definite thing.

The United States promised the Cubans the same thing, that "when they have established a stable government, then American troops will be withdrawn." As soon as the Cuban people elected a government suited to themselves, capable of maintaining order and fulfilling all international obligations, there was a stable government in Cuba, and American troops were withdrawn.

When Congress passed the Jones law, it simply borrowed the phrase "stable government" from the Cuban history and applied it to the Philippines. The history of Philippine legislation shows that in black and white. With full knowledge of what it meant, the Filipino people accepted the Jones law and immediately began setting up the stable government required by Congress as a pre-requisite to independence. The stable government is now a fact. It is indeed more than that; it is an undisputed fact.

The official representative of the United States in the Philippine Islands, the Governor General, reported to the American Congress and the administration that "the Filipino people have established the stable government demanded by Congress as a pre-requisite for the granting of independence—namely, a government elected by the suffrage of the people, which is supported by the people, which is capable of maintaining order and of fulfilling its international obligations."

The Philippine question is therefore no longer a question of politics, argument or supposition. To the Philippine mind, at least, it is now a question of whether the United States is ready to discharge its own obligations fully and completely. America went before the world in the recent war as the avowed champion of "self-determination" and Filipinos cannot see how America can consistently refuse to act.

The Filipino people, however, have no grudge or grievance against the American people. Theirs is a message of friendship and gratitude. They seek independence as the natural and logical outcome of America's policy in the islands and of America's solemn promise to them. They come willing to give privileges and concessions not incompatible with their national welfare.

The Filipino people are willing to accept independence under any of the following conditions: Under a League of Nations, guaranteeing its territorial integrity; under the protectorate of the United States for the first few years; under a treaty of neutrality between the United States, England, Japan, France and other powers, or even without any condition whatever—absolute and complete independence. They have no fear of Japan. Philippine independence, in our opinion, is not inimical to Japanese interests. The Japanese are now free to come to the Philippines, but at the present time there are less than 10,000 Japanese in the islands. There are six times as many Japanese in California as there are in the entire Philippine Archipelago.

The Filipinos are willing to take their chance as a nation. Smaller nations beset by graver perils and dangers have taken a more hazardous chance at freedom, and have succeeded.

# 'Dead' Husband Writes To Wife

TOKIO.—A letter has been received from a man reported killed in the Russo-Japanese war in North Manchuria by his supposed widow, who has been married to a second husband for nearly ten years.

A sergeant named Jinkichi Onishi has been missing since the battle of Liaoyang. The authorities as well as the family of the soldier concluded that he had been killed in the field, and funeral ceremonies were observed. His "widow" subsequently married again, two children being born by the second husband. Now, nearly 17 years since the "death" of her first husband was reported, he writes reporting himself safe in a hospital in Petrograd.

According to his letter, at the time of the Russo-Japanese war, he was taken prisoner and has ever since been imprisoned in a dungeon, which he was never allowed to leave until, after 17 years confinement, he fell ill and was removed to a hospital in Petrograd.
