Rain Fails to Delay Apple Picking

Although the labor situation in the apple orchards is not critical, yet many growers are in need of pickers to assist in harvesting the large crop. The rain greatly slows up the pickers and makes the work disagreeable, but as yet no great loss or damage has been caused. The value of the field packing plants established by the Oregon Growers' association is being fully demonstrated during the present weather, as the short hauls are proving a great factor in getting the crop harvested. Instead of having the fruit piled up ahead of them while their trucks ply between the orchards and the city, the growers are able to get their apples into the packing houses almost as rapidly as the fruit can be removed from the trees and this is greatly increasing efficiency and lessening the amount of labor. All apples from Garden Valley are being handled through the packing plant there and are then brought to Roseburg for loading and shipment.

Here are a few words from Washington's farewell address:

"The great rule of conduct for us in regard to foreign nations is, in extending our commercial relations, to have with them as little political connection as possible. Europe has a set of primary interests which to us have none or a very remote relation. Hence, they must be engaged in frequent controversies, the causes of which are essentially foreign to our concerns. Hence, therefore, it must be unwise in us to implicate ourselves by artificial ties in the ordinary vicissitudes of her politics or the ordinary combinations and collisions of her friendships or enmities.

Our detached and distant situation invites and enables us to pursue a different course. Why forego the advantages of so peculiar a situation? Why quit our own to stand upon foreign ground? Why, by interweaving our destiny with that of any part of Europe, entangle our peace and prosperity in the toils of interest-humor or caprice?"

It is our own true policy to steer clear of permanent alliances with any portion of the foreign world.

And then there was once a great American statesman, whom a portion of the democratic party delighted to honor. Listen to the words of Grover Cleveland, in his first inaugural address:

"The genius of our institutions, the needs of our people in their home life, and the attention which is demanded for the settlement and development of the resources of our vast territory, dictate the scrupulous avoidance of any departure from that foreign policy commended by the history, the traditions and the prosperity of our Republic. It is the policy of independence, favored by our position and defended by our own love of justice and by our own power. It is the policy of neutrality, rejecting any share in foreign broils and ambitions upon other continents and repelling their intrusion here. It is the policy of Monroe, and of Washington, and of Jefferson—"Peace, commerce, and honest friendship with all nations; entangling alliance with none."

And there was another man whom democrats profess to honor. He first used the term "entangling alliance" in an inaugural address. He counseled "Peace, commerce and honest friendship with all nations, entangling alliances with none." These words are the words of Thomas Jefferson. Are Wilson and Cox to be permitted to blot out his wise counsel? Oh, there have been some giants in the democratic party, but their day is long past, and they are succeeded by a race of pygmies!

But listen also to some real statesmen of our day. 31 prominent statesmen, lawyers, college presidents, ministers and business men have issued a statement in regard to the league of nations, which ought to satisfy any citizen who is in doubt as to the course which our country should pursue. The intelligence and patriotism of these men cannot be doubted. They say in part:

"The question between the candidates is not whether our country shall join in such an association. It is whether we shall join under an agreement containing the exact provision negotiated by President Wilson at Paris, or under an agreement which omits or modifies some of those provisions which are very objectionable to a great number of the American people.

The paper signed by 38 republican senators in March, 1919, before the league covenant was adopted at Paris, advised the president that the signers could not approve a treaty in the form then proposed, although it was their sincere desire that the nations of the world should unite to promote peace and general disarmament.

A majority of the senate voted to ratify the league agreement with modifications, which there is good evidence to show would have been accepted by the other nations.

But Mr. Wilson refused to accept these modifications, and insisted upon the agreement absolutely unchanged and democratic senators, sufficient in number to defeat the treaty as modified, followed Mr. Wilson by voting against ratification.

In view of the candid statement of such men' what cheap claptrap it is for the democratic national headquarters to offer a cash prize of \$25,000 for proof that the League of Nations would abridge the sovereignty of the United States. Any one who reads article 10 of the Wilson League of Nations must see at once that it binds the members of the league to protect the territory of every member. In case such territory were invaded, how could there be protection in the last analysis without force? Men and munitions of war would necessarily be required sooner or later. The council of the league would demand these from the members of the league, and we would be required to do our part, or stand before the world as dishonest and unfaithful to our pledges. There is no provision for referring any such matter to the individual nations or the legislative bodies thereof. Our congress would have nothing to say. Therefore, the constitution of the United States would be violated, because under the constitution, congress alone has the power to declare war. Under the provisions of Article 10 of the league of nations, we would sooner or later be compelled to go to war whether congress were willing or not, or else break our obligations to the league. President Wilson quibbles over the matter by saying that the obligation created is only a "moral" one and that we would not be legally bound. In the first place this is not true, because the language used is legally binding, and if it were true, should not a nation as well as an individual observe the moral obligation? The strange working of the presidential mind could not be better illustrated.
