Wilson Writes a Letter to Gov. Cox

WASHINGTON, Oct. 29.—President Wilson wrote Governor Cox expressing confidence in the nominee and said he had followed the governor's course throughout the campaign with "admiration," and expressed the belief that the governor would receive the voters' "enthusiastic endorsement." "You have spoken truly and fearlessly about the great issues at stake," he said. In concluding he asked to be permitted to sign himself, "Your gratified and loyal supporter." He expressed the hope that under the leadership of Cox "we will carry the policy of our national government forward along the path of liberal legislation and humane reform until the whole world again sees the wholesome strength of democracy."

Scenic Decorations Majestic Theatre
Ray Smith, scenic artist in the employ of the Globe Theatres Co., is in this city and has been given full charge of the redecoration of the Majestic theatre. The work is already well under way and the improvement is noticeable. Typical Oregon scenes, in beautiful colorings, are being painted on the interior walls, with a simulated marble frieze at the top, supported by large simulated marble columns. The lower woodwork is to be finished in maroon and old ivory and the effect is very beautiful. With the retinting of the exterior, a decided improvement will have been made. 600 CARS FRESH FRUIT BEEN SHIPPED
Not a Single Complaint Yet Received Concerning Quality Says Officials.

APPLES FOR SWEDEN
First Car Left Several Days Ago—Other Shipments for England and Scotland have Also Commenced This Week.

Quietly and without much ostentation an enormous business has been going on in the offices of the Oregon Growers Co-operative Association. Over 600 cars of fresh fruit have already been shipped this season, and so well has the work of grading and inspecting been done, that not a single complaint on the quality has been noted so far this season.

The Association's and the Packing Corporation's combined balance was \$203,459.87. This money has been coming in from fresh fruit sales mostly pear money, and is being checked out at present to the pear growers in a second advance, which makes the total payments to the pear growers to date of \$70 per ton on No. 1's and \$30 per ton on No. 2's. The remainder of the money on pear sales is coming in rapidly and within the next two or three weeks, the final settlement on pears will be made to the growers. Through the successful sales arrangements made by the association which has one of the best selling organizations in the northwest, the average eastern car for selling pears has been lowered to between \$25 and \$30 per car, which is extremely low compared with the costs in former years. Checks to the growers are going out at the rate of about twenty-five to thirty thousand dollars per day from various banks. The association and its affiliated packing company are doing business with nineteen banks.

The first car of apples for export to Sweden left a few days ago. The export shipments of apples and late pears have also commenced for England, Scotland and Canada. A feature of this season's sales is the attitude of the buyers who have made purchases this year. A heavy repeat business is assured next season as the association's distribution this year was more extensive than Oregon pears have ever seen. One canny buyer, who had never bought Oregon Bartlett's before was so well pleased, that he has instructed the association to enter his order, subject to approval of price, for 1,500 tons of pears for next year.

Owing to a new arrangement made on export business, the association is saving the growers from 2 1/2 to 5 cents a box on sales cost, which has been customary in the past, and which will result in a big saving to the growers.

The Oregon Growers Co-operative association will have its pools open until Monday night, November 1st. At this time the pools will be closed permanently for this year.

Petition Will be Considered Monday

The petition holding up the violation bonds until 1922 will be heard before the council at its next meeting on Nov. 1. The petition has been filed with the city recorder and will be taken up at that time for consideration. Whether or not it can positively prevent further recidivism until the next election, or whether the council can proceed by some other means is a matter which will be left to the city attorney. A decision already made by a local attorney is that postponement of the measure can only force through the issue by an initiative petition, calling for a special election.

Election Returns To be Furnished

Election returns are to be handled in several places throughout the city on the night following the vote. As usual the News-Review will bulletin returns all night and will receive frequent messages announcing the results in the various states and the incomplete returns from Oregon. The vote in Oregon will be handled by the News-Review until the entire count is completed. Arrangements have also been made by J. W. Perkins to throw the returns on a screen at his building on Cass street. A projecting machine will be mounted in the Grand hotel and the slides prepared by a new method there. These slides will be furnished by Mr. Perkins to the management of the Majestic theater and will be shown in that playhouse to those who do not care to remain in the streets. These returns will be received from all parts of the United States through a special telegraph service arranged by Mr. Perkins. Returns will also be megaphoned at frequent intervals at the election day dance to be given at the armory. County returns will be furnished all of these places by the News-Review as rapidly as they are received at this office.

APPLE HARVEST IS ALMOST COMPLETE

Last of Fruit Coming In to be Shipped to the Eastern Market.

TRUCKS ARE KEPT BUSY

Field Packing Station is Great Benefit in Relieving Congestion and Aids in Getting Fruit Ready for Shipment.

The apple picking season is nearing a close with weather conditions ideal and practically no serious troubles of any kind. The Spitznbergs have nearly all been shipped and the Newton season is now well advanced.

The early part of the apple season was not particularly favorable as the continued and prolonged rains prevented pickers from removing the apples as rapidly as should have been done. The workers in the orchards found their task very disagreeable, the mud and rain causing many of them to quit work in the orchards and return to the city. This complicated the labor situation somewhat, but with the return of good weather labor was procured easily and the rapidity of the work was increased.

The wet spell, however, enabled the packers to keep up with the harvest, and consequently there was no congestion at the orchards or at plants. The roads were kept in good condition, and trucks continually plied between the orchards and the city, bringing in the fruit ready for shipment.

The Oregon Growers Association has maintained a field packing station at Garden Valley, and has had the fresh fruit taken there from the orchards, graded and packed in, and thus greatly relieving the local plant, which has been kept busy at all times packing the fruit brought from other districts. Cars have been loaded at Sutherlin and Roseburg, as well as Riddle, and it appears that the early estimate will be far surpassed as to the quantity of the yield this year, which is quite large.

Several individual shippers are also sending out apples in carload lots and the fruit is being dispatched to the east without any delays. The dispatch with which the crop is being handled is in contrast with last season, when a bumper crop, coming simultaneously with an acute car shortage, caused the growers to look frantically for places in which to store fruit until such time as it could be packed and loaded. The experience of last season has resulted in much better facilities for handling the fruit this year, and the work has been practically unhindered in spite of the unfavorable conditions.

The growers are now preparing to spray as soon as they can complete their "arrest." On account of the prevalence of anthracnose spray is absolutely necessary and warnings have been sent out by the local inspector and from the college. Those who have completed the work of picking the apples have already applied the spray, while others are doing so, or are preparing to take such action.

REWARD OFFERED FIGHTING YANKEES

Moscow Would Give Money To Americans to Command Polish Air Forces.

"DEVILS OF THE AIR"

In Battle Near Lemberg, Airplanes Flew in Squadrons Bombing and Covering the Soldiers With Hail of Machine Gun Fire.

WARSAW, Oct. 29.—Polish army intelligence officers report that the city of Moscow offered a reward of 1,000,000 rubles for the capture, dead or alive, of Major Cedrick E. Fauntleroy, of Chicago and McGhee, Ark., commander of the Polish air forces on the southern front. General Budenny's failure to take Lemberg, when the Bolsheviks made the August drive against Warsaw, is attributed by Lenine and Trotsky, chiefly to the fight against the Cossacks from the air.

Major Fauntleroy was recently appointed chief of aviation of the 6th Polish army. He has four squadrons under his command, one of which is the Kosciuszko air organization, composed chiefly of Americans. The aviators in that squadron are under the command of Captain George M. Crawford, of Wilmington, Del., and are known by the Bolshevik soldiers on the southern front as "the devils of the air," according to the recently captured red soldiers.

During two days in August when General Budenny was striving with every force at his command, to break the Polish southern front and dash into Lemberg, the Bolsheviks on the north having reached the outskirts of Warsaw, the four squadrons of the Sixth army made 129 flights, dropped 15,000 pounds of bombs, and used 16,700 machine gun bullets in attacks.

General Rozwadowski, chief of the staff of the Polish army, in a communication to the chief of aviation, says: "Activities of the squadrons of the Sixth army in the battle with the Cavalry army of Budenny were directed with the greatest efficiency, this being acknowledged by statements of Bolshevik prisoners and by Soviet wireless messages." One wireless message, signed by Budenny, and intercepted by the Poles, said: "In a battle near Lemberg, our cavalry troops suffered a great loss from Polish airplanes, which flew in squadrons of 12 planes and covered the soldiers with machine gun fire."

Reviewing the work of aviators of the southern front, General Rozwadowski wrote: "The extraordinary manoeuvres of the air squadrons of the Sixth army, are due to the organizing ability and unlimited energy of the army's chief of aviation, Major Fauntleroy, to whom I convey the highest praise for the enthusiasm with which he has fought for Poland's cause."

Major Fauntleroy was decorated recently by Chief of State, Pilsudski, with the virtual military, the highest award of the Polish government. The Major, who has been a member of the Polish army more than a year, receives in pay, owing to the low value of the Polish mark, about \$16 per month.

Rioting Over Dead Body of Lord Mayor

QUEENSTOWN, Ireland, Oct. 29.—The body of Lord Mayor MacSwiney was landed from the steamer Rathmore and was received by the urban council and thousands of city inhabitants.

HOLYHEAD, Wales, Oct. 29.—Relatives of MacSwiney refused to board the Rathmore and took the boat for Dublin. Violent scenes in which blows were struck and members of the lord mayor's family were dragged from the railway coach when they refused to consent to the government's plan to take the body to Cork instead of Dublin, were enacted. Mrs. MacSwiney claimed the police knocked them down during the melee.
