STORM SIGNALS FROM FARMERS

Something sane and constructive must be done for agriculture. William Allen White, writing in the Emporia, Kan., Gazette, expresses the belief that unless economic relief comes to the farmers of this country before 1932 there will then be such a political storm as would make former upheavals of the sort look insignificant.

At present, he writes, the farmers are puzzled. "They are out of patience, if they are not angry; they don't know where to turn."

Whatever their attitude toward the whole public may have been in the past in selfishness and too great conservatism, they now have genuine troubles at which the rest of the nation is unwise to scoff. There has been a decline in the price of everything the farmer has to sell, but not in the cost of things he must buy. Unemployment exists in many of the big cities, but it has not yet begun to reduce the cost of farm labor, still high and scarce.

The farmers will probably demand four things, prophesies Mr. White. (1) Some special farm credit arrangement with the federal reserve bank. (2) Some security of price in the spring when he plants his crop for the harvest in the fall. (3) Some right of co-operative marketing, encouraged and possibly controlled and stimulated by the government, which will give him a fair show in the world markets. (4) A square deal from packers and big grain men in big distributing centers.

The farmer's troubles are real and acute. Many of them he can straighten out for himself if he will. But some of them depend upon a more understanding public opinion and fairer treatment on the part of other industries. Mr. White's conclusion is a warning which needs to be read seriously and thoughtfully by congress and public alike. "It is fair weather now; so was it while Noah built the Ark."

"The national park crime wave is sweeping over the west today; it must be opposed." This is the declaration of T. Gilbert Pearson, president of the National Association of Audubon Societies. He refers not to a wave of personal crime, but to a crime planned against the whole public by a few private commercial interests. The public has very nearly been caught asleep. A bill which has already passed the senate and is soon to come before the house, would turn over 8000 acres of Yellowstone park land to speculators. This bill can be defeated in the house if the public is told the truth, for knowledge of its full import will raise a storm of protest. The irrigators have claimed that the 8000 acres comprise swamp land not suited for tourists. Last summer the whole region was explored and found to possess a scenic splendor unrivaled by any other section of the park. It has been common knowledge for years in the past, and is therefore inaccessible to any but a few park rangers. As described in an issue of the Saturday Evening Post a few weeks ago, it contains more falls and cascades than are to be found in all the rest of the park combined. It could accommodate 10,000 automobile parties. The water could be used just as effectively if a dam were constructed outside the park limits. This would necessitate the purchase of some privately owned land for use as a reservoir. The irrigators naturally would prefer a concession giving them "free water." When the Smith bill is defeated it would be well for congress, urged on by the public, to turn its attention to repealing any provisions of the water power bill passed during the last session which endanger the parks by opening the way for an orgy of destruction on the part of selfish private interests.

With the increased activity of the blind in industry comes a new duty, to each community—the protection of these afflicted people as they make their way through the public streets to and from their work, especially in crossing the streets. In Minneapolis, where over 70 blind men make their way to work every day, a uniform signal has been adopted to indicate that the person

about to cross the street cannot see. The blind man holds his arm out rigidly in front of him, either with or without his cane in his hand. The public is learning to watch for the signal and to see that each one crosses in safety. Even with this precaution the slightest find going thru the streets the hardest part of the day's work, and two have had nervous breakdowns from the strain of avoiding accidents. Here is additional reason for uniform traffic regulations and the timing of all vehicles to the speed of the foot passenger at crowded street crossings.

LEGION AND LABOR HAVE SAME VIEWS

National Commander Gailbraith and Gompers Exchange Friendly Letters.

WILL WORK TOGETHER

Two Officials Representing Two of America's Greatest Organizations Are to Hold Conference in Near Future.

INDIANAPOLIS, Ind., Jan. 1.—Correspondence between F. W. Gailbraith, Jr., National Commander of the American Legion, and Samuel Gompers, president of the American Federation of Labor, has been made public at the national headquarters of the Legion. The letters, which continue an exchange begun before Mr. Gailbraith took office, reveal the two executives in true accord on the principle that an organization, as such, can scarcely be held responsible for acts of individuals or members, which may not agree with either the letter or the spirit of the body's official pronouncements. Each of the correspondents expressed the hope that they might meet and talk over the problems confronting them.

The first letter was written on November 2, in response to one Mr. Gompers had written and sent to Mr. Franklin D. Oiler, former commander of the Legion last August. The labor leader had called attention to reports that "members of the American Legion were improperly participating in certain political activities in the state of Kansas" and Mr. Gailbraith wrote that a reply had been delayed because he needed time to familiarize himself with the situation. He said:

"As a result of an investigation, the officials of the American Legion in Kansas report that the American Legion did not participate in the incidents reported to you. If any members of the Legion did take up these reported incidents, it was entirely upon their own responsibility and without sanction from any official of our expressed policy."

"As you know the American Legion is an association of former soldiers, sailors and marines, associated together for the following purposes:

"To maintain and uphold the Constitution of the United States of America to maintain law and order; to foster and perpetuate one hundred percent Americanism; to preserve the memories and incidents of our association in the Great War; to inculcate a sense of individual obligation to the community, state and nation; to combat the autocracy of both the classes and the masses; to make right the master of might; to promote peace and good will on earth; to safeguard and transmit to posterity the principles of justice, freedom and democracy; to consecrate and sanctify our comradeship by our devotion to mutual helpfulness."

"The position of the American Legion in political controversies is neutral and non-partisan. We are not interested in political differences as they arise in different sections of the country."

"In a great national organization it is necessary that the individuals as members retain to themselves the greatest freedom in matters of political affiliation, religion, etc., and that they decide upon their own conduct along these lines strictly in accordance with their own conscience."

"Two successive conventions of the American Legion have unequivocally upheld and reiterated this policy. The people of the United States have the right to decide for themselves any political question that may come up before them. The American Legion does not believe in the abridgement of this right in any respect. The American Legion believes in law and order. It is steadfastly opposed to the use of force or violence in furthering any of the doctrines, and will oppose such methods through the lawfully constituted authorities wherever they may appear."

"No one knows more truly than you do the aims and attitudes of a great national association, by which it may be often misjudged by the irresponsible conduct or statements of individual members of the association or by small groups of members, and that it sometimes unfortunately occurs that the newspaper reports of such incidents or statements are not strictly accurate reports of the facts and circumstances as they occurred. Incidents of this nature cannot condemn a national organization to policies or positions in conflict with the policies and positions taken by such an association at its convention or as set forth in its constitution."

Replying a week later, Mr. Gompers wrote:

"It is indeed gratifying to know that you have taken the same stand as your predecessor, Mr. Franklin D. Oiler, and are just as much in earnest as he was in conserving the good name of the American Legion."

I would ask if there is anything in the following declaration to which the American Legion would object. The declaration was made by the A. F. of L. at its convention in 1910.

"Organized labor contends for the improvement of the standard of life to uproot ignorance and foster education, to instill character and manhood and an independent spirit among our people, to bring about a recognition of the interdependence of the modern life of man and fellow man. It claims to establish a normal workday, take the children from the factory and the workshop and place them in the school, playgrounds and the home. In a word the unions of labor, recognizing the duty of toil, strive to educate their members, to make their homes more cheerful in every way, to contribute an earnest effort toward making life the better worth living, to avail their members of their rights as citizens and to bear the duties and responsibilities they owe to our country and our fellow men. Labor contends that in every effort to achieve its praiseworthy ends, all honorable and lawful means are not only commendable but should receive the sympathetic support of every right-thinking progressive man."

"You undoubtedly will find that members of the American Legion, outside of a few, are like members of other organizations; they don't know the real purpose for which the organization is formed. New organizations, especially, find it difficult to restrain their members from doing those things which are a menace, not only to them but to all the people."

"I have been helpful in a way of acquainting members of the trade unions with the real aims and objects of the American Legion. On several occasions resolutions have been presented in meetings of labor organizations that have been laid on the table or defeated because the information they have received thru me in relation to the work of the American Federation of Labor and the American Legion movement, and have been misled as to the work of the American Federation of Labor and it is my belief that if they knew the real object of the American Federation of Labor as outlined in the 1910 convention, it would be an immense cause individuals to cease interfering in any way with the trade unions."

"Permit me to congratulate you on your election as National Commander of the American Legion. I hope that some day I shall have the pleasure of meeting you personally and discussing the problems faced by labor organizations."

The reply of Mr. Gailbraith, dated November 27, said "that it was with a real sense of pride in the fundamental soundness of our American institutions and as renewed proof thereof that I read the American Federation of Labor's declaration of 1910."

Is there anything in that declaration to which the American Legion can object? you ask. Certainly not. The Legion subscribes to every word of it. Compare it with the preamble of the constitution of our organization. But, as you and I must be aware, it is one thing for a great organization like the American Legion or the American Federation of Labor to aspire to lofty aims and in conventions assembled give birth to excellent pronouncements; and is another thing for such organizations to go out in the daily acts and deliberations of its individual members and small groups to always adhere to such declarations.

"In this respect the problems of the respective organizations we represent appear to be the same. We have before us constantly the duty of living up to our professed declarations in letter and spirit. I venture the same may be said of organized labor."

"I shall look forward with pleasure to the time when we may meet and personally discuss some of the phases of our common problem."
