"How do you know that it was Judge Turner, Bart?"

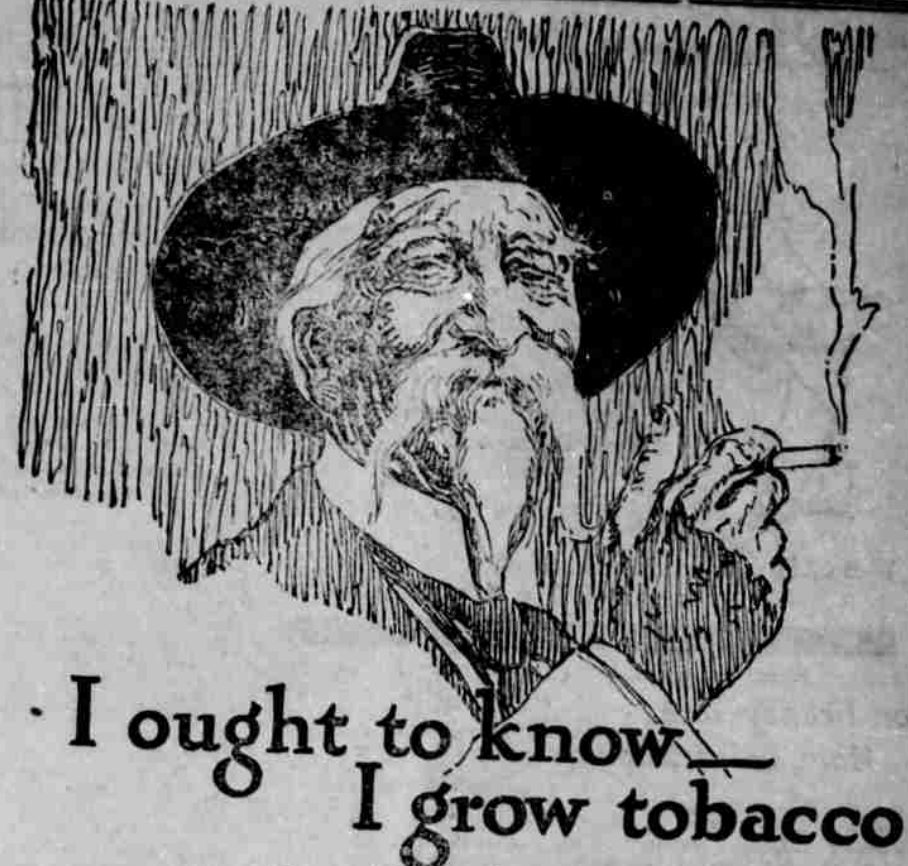
"Well, I saw Early talking to a man who seemed to be remonstrating with him, and I edged over where they were and heard Early call him Jeff."

Desire to Explore Hawaii Volcano

(By Associated Press.)

HONOLULU, T. H., July 3.—Although the recent session of the legislature defeated a bill to provide \$25,000 for experimental borings in Kilauea, the perpetually active volcano on the island of Hawaii, those interested in the project have not abandoned hope that something will be done to utilize the heat of the "House of Fire" for industrial purposes after the manner followed in Italy, according to Lorrin A. Thurston, president of the Volcano Research association.

From Dr. H. S. Washington, of the Carnegie Institution, of Washington, D. C., came the first suggestion to attempt to harness the latent energy of Pele, Kilauea's goddess, to the wheel of practical industry, said Mr. Thurston. The project also had the support of Dr. A. I. Day of the Carnegie Institution, an internationally recognized authority on such matters.

The original plan was to have the territory of Hawaii provide the necessary initial funds for experimental boring, but, said Mr. Thurston, since this proposal has been upset by the pressing need for territorial funds in other directions, it is probable that the next move will have to come from such an agency as the Carnegie Institution or from some individual or group of persons interested in the commercial possibilities of the project.

Mr. Thurston pointed out that generation of industrial power from volcanic gases had passed beyond the experimental stage, particularly in Italy, where electric lines for traction and industrial power were fed with energy generated from volcanic sources.

Mazamas Will Scale Peaks

(By Associated Press.)

PORTLAND, Or., July 3.—Peaks of the Cascade mountains are to be scaled this summer by members of the Mazamas, an Oregon mountaineering club, on their annual outing, Crater Lake, in Southern Oregon, is also on the club's itinerary.

The Mazamas will leave Portland August 1, going by rail to Bend, Ore., from whence the actual excursion will start. Automobiles will carry the party to Crescent lake, 76 miles away, where the first camp will be made.

From Crescent Lake, Diamond Peak, a Cascade mountain, will be scaled, and Waldo, Rosary and Odell lakes will be visited. The Mazamas will then hike to Diamond lake, two days away, and Old Bailey and Thielson peak will be climbed. From Diamond lake, the mountaineers will hike to Crater Lake, where the final camp of several days will be made, and whence Mount Scott and Garfield peak will be conquered. The

return to Portland will be made by way of eford.

About 75 Mazamas are planning to make the trip. Camp equipment will be carried by pack horses and automobiles.
