GRAPES TO DEMAND NEW HIGH PRICE

PAW PAW, Mich., Aug. 22.—(By United Press.)—Despite the fact that Americans are turning their back on their national drink—grape juice—Michigan farmers will receive the highest prices in history for their grape this fall.

Leo E. Prater treasurer of the National Grape Growers' Association, predicted today that Michigan grapes would bring an average price of \$150 a ton, compared with \$90 average last year and a maximum of \$114. Ten years ago they brought \$20 a ton.

The reason for the increased price was a late spring frost which reduced the crop to about 25 per cent of normal. Southwestern Michigan will ship not more than 1,500 cartloads of grapes this year, averaging

perhaps 20 tons to the car.

Grape juice factories, which ordinarily take about a third of the output, will not buy a pound of grapes this year. They have an enormous surplus on hand as a result of the public's refusal to pay the high price for grape juice at soda fountains, in comparison with other soft drinks, because of the extra ad valorem tax.

Baldwin To Get Land Office Job

(News-Review Washington Bureau.) WASHINGTON, Aug. 20.—Edward D. (Ned) Baldwin, of the Dallas, for several years secretary to Congressman Sinnott and for three years clerk to the public lands committee of the house, will be appointed to the vacancy in the Portland land office next February, when the term of the incumbent expires.

He has been endorsed by both Oregon senators, and the appointment would have been announced with the other patronage information but for the fact that the vacancy does not occur until spring.

Baldwin is regarded by the land office and interior department officials here as an expert and has on two occasions been unusually honored by resolutions commending his work and special ability in land matters.

Served as Secretary. He was for six years secretary of the Oregon republican state committee and for some time acting chairman.

His appointment has the endorsement not only of Senator McNary and Senator Stanford, but also of the Oregon congressmen. His taking over the work of the Portland office will place it in the hands of an expert in land law and procedure who has had the benefit of years of intimate contact with the department handling all these matters and with the formation and passage of all the principal legislation referring to the public lands of the country.

Stanfield Enroute. Senator Stanford is now on his way to Oregon and Senator McNary will leave here some time between August 25 and September 1.

It is understood that Jack Day of Portland may be considered for a position some time in the near future. His future status will be determined in conferences in Oregon after the senators arrive there.

No Chance Games At State Fair

SALEM, Aug. 22.—All forms of gambling, including doll and knife racks, candy boards and other games of chance are to be barred from the Oregon state fair grounds during the fair this year. Chief of Police Moffitt announced this morning.

For the first time in history the policing of the fair grounds will be done by the Salem police force, because of the extension of the city limits last year to include the fair grounds, and the city police officials are perfecting their plans accordingly.

Twenty extra officers are to be added to the local force during fair week for the task of patrolling the grounds alone and at least two special officers will be added to the regular city force, Chief Moffitt announced.

Separate headquarters will be maintained at the fair grounds with Sergeant Davis in charge, and arrangements have been made with the fair board for two offices in the administration building. These headquarters will be equipped with telephone connection with all of the buildings on the grounds and with the regular city police headquarters by direct wire.

HUNTER IN THE WET IS KILLED FOR DEER

EUGENE, Or., Aug. 21.—Otis Pitney of Junction City was shot and instantly killed today by H. M. McKee of Alvadore while hunting deer in the Coast range mountains nine miles from Noti and about 20 miles west of Eugene. McKee said he mistook Pitney for a deer.

Pitney and McKee were in 202

rate hunting parties that had started out this morning. McKee said he saw what he thought was a deer moving in the brush a hundred yards away and fired. He said he was horrified to find Pitney, with whom he was acquainted, lying dead with a bullet hole in his neck.

The jugular vein had been pierced by McKee's bullet. McKee told other members of his party what he had done and walked to Noti, telephoned to Coroner Branstetter, who left this afternoon to hold an inquest.

Word from Noti tonight was to the effect that the body would be taken to that place, where an inquest would be held tonight. Pitney was about 20 years old and a son of William Pitney, a pioneer of Junction City. He was a rural mail carrier of Junction City and lives a family. McKee is a blacksmith at Alvadore.

NATIONAL GRAIN DEALERS ASSOCIATION INVESTIGATED

WASHINGTON, Aug. 22.—Investigation of the activities of the National Grain Dealers Association and other organizations alleged to be "engaged in combatting legislation for the relief of agriculture" was ordered in a resolution adopted today by the senate. Senator Kenyon said inquiry was sought because of a report that at the convention at Cincinnati in June, under the auspices of the National Grain Dealers Association, it was determined to institute an active campaign against the United States Grain Growers Inc., a cooperative marketing concern.

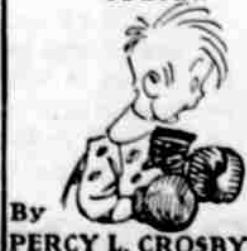
