REPORTING THE MURDER TRIAL.

No other paper in the state is giving its readers so comprehensive and complete report of the Brumfield murder trial as the News-Review. Every angle of the case is being covered. The minutest detail of occurrences leading up to the atrocious crime, as given by the state's witnesses, is taken down verbatim by a short-hand representative of the paper, then transcribed into readable form by the city editor. A like report of the case will be given when the defense calls its witnesses to the stand to testify in behalf of their client. The whole truth of this very important case is going to be given to our readers.

There will be no "culling" of testimony introduced affecting either the defense or prosecution. The readers of the News-Review are going to get a clean sweep of the case.

They are entitled to know just what happens—not only from the standpoint of evidence—but any sidelights on the case occurring during the continuance of the trial. They are also entitled to know something of the actions of the principals in this case, as they occur from time to time during the trial. The angle of the case from this point is being closely watched and our readers may be assured there will be no deviation from the usual policy of this paper—giving the news, first, last, and all the time.

The local courtroom is sufficiently large enough to probably accommodate five or six hundred people. The News-Review today is serving over twenty thousand people, and we opine that these twenty thousand readers are just as anxious to get the real facts, from every angle, concerning the Brumfield case, as those who are able to attend the trial in person.

Therefore there will not be a single incident omitted, from the smallest to the most important piece of testimony adduced at the hearing. It is most important that every good citizen should be apprised of the facts in this case and this paper is sparing no expense to serve its readers in the best possible manner.

Doubtless this policy will not be appreciated by a few narrow heads who would seek to coerce and tamper with legitimate news matter. This paper is serving the people—no single individual has a right, nor will we admit of such a policy, to in any way attempt to "color" the reports contained in the columns of this paper.

Our readers will get the details of the case in question from every angle, regardless of how the matter looks in cold type, and this is a policy that we believe will meet with the approval of our great army of readers.

SINCERITY TOWARD THE PUBLIC.

There are many business people whose only theory of salesmanship is to put over an effective line of talk which is so fluent and valuable as to sweep a person off his feet and persuade him to buy whether his better judgment agrees or not. A man went into a shoe store in a big city one day, and the salesman tried to sell him a certain shoe. The customer thought it was too big. The salesman kept declaring that it was a perfect fit. Then the customer insisted, and the salesman brought out another pair, and that was tried on. "It fits a great deal better than the other," he said, not seeming to realize that he was either confessing that he made a mistake on the first pair, or that he was talking in an insincere way. That kind of salesmanship does not sell goods. There are some men who would not hesitate to tell a little white lie, if they thought the customer would never know the difference. But the buying public is keener than they realize. Sooner or later they find out the truth, and they have little use for a store where the salespeople are not taught to be frank and sincere and offer an exact statement as to what goods are made of. It is one of the satisfactions of doing business in the stores of Roseburg, that the salespeople are trained in this habit of frank and sincere dealing. A sale is not considered a real sale by our merchants, unless the customer knows just what he is getting. If a second grade article is sold, the buyer is informed frankly just what he may expect, and what experience other people have had in dealing with that class of merchandise. In that way our business community has built up relations of confidence and satisfaction that prove very permanent.

The expense of the American army on the Rhine during the three years since the armistice is given at \$278,000,000, somewhat less than the French army but more than the British and a good deal more than the Belgian and Italian armies. It may be all right for the allies, remarks a critic, "but what about this country compelling bankrupt Germans to pay that much money for the support of our soldiers on German soil after the war ended? Leave out the question of decency, which is disregarded in war. What about the common sense of wasting \$278,000,000 German gold dollars to keep our men forming idle habits over there, doing no good?" As regards "idle habits" and "doing no good," those American troops on the Rhine would be at least as idle and doing as little good if they were at home instead of in Germany. Also, if they were here, we should have to pay for their keep. And how about Germany? Well, Germany without provocation forced this country to spend about \$30,000,000,000 on the war—and it may be \$50,000,000,000 before we get through. Germany is getting off easily enough for the few millions required to keep some of our soldiers on the Rhine to help see that the fruits of our victory are made sure.

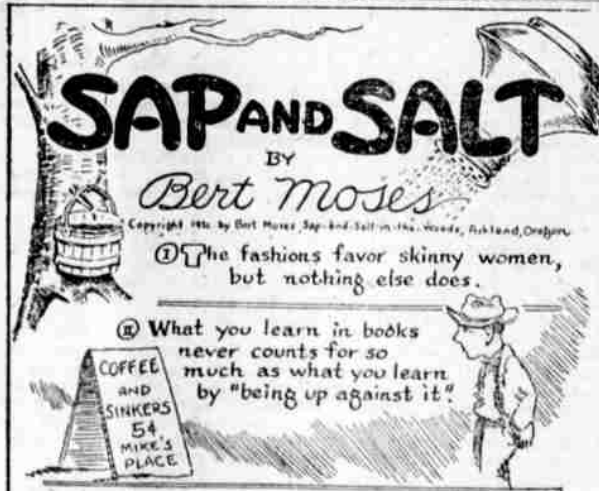

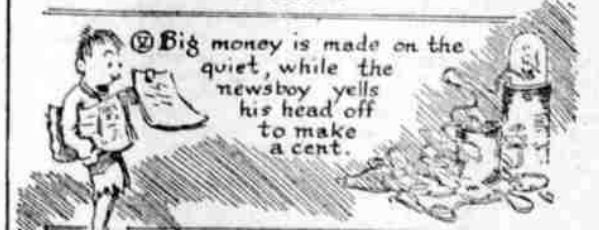

PUBLIC MARKET IS RECOMMENDED

Chamber of Commerce Committee Advises Starting Market In Spring.

GRANGE GIVES SUPPORT

Granges Tell Committee that If Proper Cooperation Can Be Secured That Farmers Will Be Willing to Start Market.

The establishment of a public market, providing sufficient cooperation between the public and farmers, is approved by the Chamber of Commerce committee appointed to investigate the advisability of creating such a market. The committee, however, advises that nothing be done until next spring as it is believed that the winter months would not be conducive to a successful operation and would undoubtedly have a bad effect upon the entire project.

This matter was taken up recently by the Chamber of Commerce at the request of a number of business men, who believe that a public market will be of benefit to the farmers and the public in general. Such markets are now in use all over the country and in most places are operated very successfully. A good market was conducted in Roseburg, prior to the war, but owing to several unfortunate circumstances it became necessary to discontinue the market.

The Chamber of Commerce decided to make a thorough investigation and appointed a committee composed of L. H. Moore, O. C. Baker and L. J. Barnes to take up the proposition with farmers and grange heads. The committee has made the following report:

"Your committee to whom was referred the proposition of establishing a public market in Roseburg, beg leave to report as follows: "We have had this up with the farmers and with the grange and have been advised that it is not advisable to undertake this project at this season of the year. The grange people stated that they would take this matter in hand next February and if the Roseburg people were sufficiently interested to provide quarters for such a project, or at least cooperate in doing so, they thought the farmers would enter into this and put the public market on a sufficient working basis to serve our people."

"We therefore recommend that the matter be left in abeyance until next spring, and that it again be taken up with the grange at that time, to see what can be done, as we believe if our people and the public will get together and cooperate as they should that a public market can be established and will prove a very material help to our people. Such a market has been under operation in Eugene for some time and is very popular, so we are reliably informed, and there can be no doubt that it can be successfully carried on here, providing first and all the time that it gets the proper cooperation from all parties.
